- 8     ▶ requires a manufacturer of menstrual products sold in the state to list certain chemicals and intentionally added ingredients on the packaging of the menstrual product;
- 10     ▶ authorizes the Division of Consumer Protection to:
- 11         • make rules; and
- 12         • enforce labeling requirements;
- 13     ▶ defines terms; and
- 14     ▶ makes technical and conforming changes.
