7 This bill:

- 8 ▸ requires a manufacturer of menstrual products sold in the state to list certain chemicals and intentionally added ingredients on the packaging of the menstrual product;
- 10 ▸ authorizes the Division of Consumer Protection to:
- 11 • make rules; and
- 12 • enforce labeling requirements;
- 13 ▸ defines terms; and
- 14 ▸ makes technical and conforming changes.
