5 This bill addresses behavioral and mental health.

- 8 ▶ changes the entity that administers and reports on the Governor's Suicide Prevention Fund from the governor to the Office of Substance Use and Mental Health (office);
- 10 ▶ requires the Office of Licensing within the Department of Health and Human Services (department) to make rules related to a behavioral health receiving center's communication with prosecutors and law enforcement regarding a justice involved individual's participation in the behavioral health receiving center's treatment program;
- 14 ▶ requires the department to provide a list of mental health and substance use disorder screening tools used in jails;
- 16 ▶ requires the department to create a standard form for justice involved individuals to consent to disclosure of a mental health disorder or substance use disorder to certain persons, including health care
