4 **General Description:**

5 This bill amends vehicle registration notification requirements and provides an option for a  
6 lifetime registration period for certain vehicles.

7 **Highlighted Provisions:**

8 This bill:

- 9 ▶ provides an option for a registration period for a trailer for the lifetime of the person's ownership of the vehicle;
- 11 ▶ provides for the calculation and deposit of registration and various other fees and taxes due at the time of registration to account for a lifetime vehicle registration period;
- 13 ▶ imposes a penalty for fraudulently declaring a trailer as a commercial trailer; and
- 14 ▶ makes technical changes.

15 **Money Appropriated in this Bill:**

- 16 ▶ **This bill appropriates \$65,900 in transfers to unrestricted funds for fiscal year 2027, all of**  
17 **which is from the various sources as detailed in this bill.**
