4 **General Description:**

5        This bill modifies provisions related to {federal guidance letters} federalism.

8            ▶ defines terms;

9            ▶ provides for the registration and protection of a trademark used by a state-led federalism organization;

9            ▶ extends requirements for publishing and reporting federal guidance letters to certain education entities;

13           ▶ changes the statewide website on which state agencies are required to publish federal guidance letters;

11           ▶ requires a state agency that receives a federal guidance letter to submit an electronic report to the Federalism Commission containing information and recommendations regarding the impacts and scope of the federal guidance letter;
