23          Section 1. Section **35A-16-102** is amended to read:

24      **35A-16-102. Definitions.**

As used in this chapter:

- 31      (1) "Board" means the Utah Homeless Services Board created in Section 35A-16-204.
- 32      (2) "Chief executive officer" means the same as that term is defined in Section 11-51-102.
- 33      (3) "Client" means an individual who is experiencing homelessness or an individual at risk of becoming homeless.
- 35      (4) "Collaborative applicant" means the entity designated by a continuum of care to collect and submit data and apply for funds on behalf of the continuum of care, as required by the United States Department of Housing and Urban Development.
- 38      (5) "Continuum of care" means a regional or local planning body designated by the United States Department of Housing and Urban Development to coordinate services for individuals experiencing homelessness within an area of the state.
- 41      (6) "Coordinator" means the state homelessness coordinator appointed under Section 63J-4-202.
- 43      (7) "County of the first class" means the same as that term is defined in Section 17-60-104.
- 44      (8) "County of the second class" means the same as that term is defined in Section 17-60-104.
- 46      (9) "Eligible services" means any activities or services that mitigate the impacts of the location of an eligible shelter, including direct services, public safety services, and emergency services, as further defined by rule made by the office in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act.
