2 **LONG TITLE**

3 **General Description:**

4 This bill extends repeal dates for programs and committees under the Department of Health
5 and Human Services, and related provisions.

18 **Money Appropriated in this Bill:**

19 This bill appropriates \$19,000 in operating and capital budgets for fiscal year 2027, all
20 of which is from the General Fund.
