

Tyler Clancy proposes the following substitute bill:

Offender Supervision Amendments

2026 GENERAL SESSION

LONG TITLE

General Description:

This bill addresses provisions related to supervision of offenders.

Highlighted Provisions:

This bill:

▸ allows a court to order the Division of Adult Probation and Parole to supervise an individual convicted of class B misdemeanors if the Division of Adult Probation and Parole consents to supervise the individual;

▸ requires the board, if considering whether to parole an offender who has previously been paroled and had the offender's parole revoked due to a new criminal offense, to consider the facts and circumstances of the new criminal offense in determining whether the offender should be paroled again;

▸ allows the board, with certain exceptions, to only consider a pardon for an offender who has committed an offense that requires the offender to register on the Sex, Kidnap, and Child Abuse Offender Registry (the registry) if:

- for a sex offender required to register on the registry for 10 years, 10 years have passed from when the sex offender entered the community after the sex offender's conviction; or

- for a sex offender required to register on the registry for the sex offender's lifetime, 20 years have passed from when the sex offender entered the community after the sex offender's conviction; and

▸ adds to the requirements for the board to meet before the board may parole an offender before the offender's minimum term of imprisonment has been met.

42 Section 1. Section **64-14-204** is amended to read:

43 **64-14-204 . Supervision of sentenced offenders placed in community --**

44 **Rulemaking -- POST certified parole or probation officers and peace officers -- Duties --**

45 **Supervision fee -- Coordination with local mental health authority.**

46 (1)(a) The division, except as otherwise provided by law, shall supervise a sentenced

47 offender placed in the community if the offender:

48 (i)(A) is placed on probation by a court;

49 (B) is released on parole by the Board of Pardons and Parole; or

50 (C) is accepted for supervision under the terms of the Interstate Compact for the

51 Supervision of Parolees and Probationers; and

52 (ii) has been convicted of:

53 (A) a felony;

54 (B) a class A misdemeanor when an element of the offense is the use or attempted

55 use of physical force against an individual or property;~~or~~

56 (C) notwithstanding Subsection (1)(a)(ii)(B), a class A misdemeanor if the

57 division is ordered by a court to supervise the offender under Section 77-18-105~~[-]~~ ;

62 (b) If a sentenced offender participates in substance use treatment or a residential

- 63 vocational or life skills program, as defined in Section 13-53-102, while under
64 supervision on probation or parole, the division shall monitor the offender's
65 compliance with and completion of the treatment or program.
- 66 (c) The department shall establish standards for:
- 67 (i) the supervision of offenders in accordance with the adult sentencing and
68 supervision length guidelines, as defined in Section 63M-7-401.1, giving priority,
69 based on available resources, to felony offenders and offenders sentenced under
70 Subsection 58-37-8 (2)(b)(ii); and
- 71 (ii) the monitoring described in Subsection (1)(b).
- 72 (2) The division shall apply the graduated and evidence-based responses established in the
73 adult sentencing and supervision length guidelines, as defined in Section 63M-7-401.1,
74 to facilitate a prompt and appropriate response to an individual's violation of the terms of
75 probation or parole, including:
- 76 (a) sanctions to be used in response to a violation of the terms of probation or parole; and
77 (b) requesting approval from the court or Board of Pardons and Parole to impose a
78 sanction for an individual's violation of the terms of probation or parole, for a period
79 of incarceration of not more than three consecutive days and not more than a total of
80 six days within a period of 30 days.
- 81 (3) The division shall implement a program of graduated incentives as established in the
82 adult sentencing and supervision length guidelines, as defined in Section 63M-7-401.1
83 to facilitate the department's prompt and appropriate response to an offender's:
- 84 (a) compliance with the terms of probation or parole; or
85 (b) positive conduct that exceeds those terms.
- 86 (4)(a) The department shall, in collaboration with the State Commission on Criminal and
87 Juvenile Justice and the Division of Substance Use and Mental Health, create
88 standards and procedures for the collection of information, including cost savings
89 related to recidivism reduction and the reduction in the number of inmates, related to
90 the use of the graduated and evidence-based responses and graduated incentives, and
91 offenders' outcomes.
- 92 (b) The collected information shall be provided to the State Commission on Criminal
93 and Juvenile Justice not less frequently than annually on or before August 31.
- 94 (5) Employees of the division who are POST certified as law enforcement officers or
95 correctional officers and who are designated as parole and probation officers by the
96 executive director have the following duties:

- 97 (a) monitoring, investigating, and supervising a parolee's or probationer's compliance
98 with the conditions of the parole or probation agreement;
- 99 (b) investigating or apprehending any offender who has escaped from the custody of the
100 department or absconded from supervision by the division;
- 101 (c) supervising any offender during transportation; or
- 102 (d) collecting DNA specimens when the specimens are required under Section 53-10-404.
- 103 (6)(a)(i) A monthly supervision fee of \$30 shall be collected from each offender on
104 probation or parole.
- 105 (ii) The fee described in Subsection (6)(a)(i) may be suspended or waived by the
106 division upon a showing by the offender that imposition would create a substantial
107 hardship or if the offender owes restitution to a victim.
- 108 (b)(i) The department shall make rules in accordance with Title 63G, Chapter 3, Utah
109 Administrative Rulemaking Act, specifying the criteria for suspension or waiver
110 of the supervision fee and the circumstances under which an offender may request
111 a hearing.
- 112 (ii) In determining whether the imposition of the supervision fee would constitute a
113 substantial hardship, the division shall consider the financial resources of the
114 offender and the burden that the fee would impose, with regard to the offender's
115 other obligations.
- 116 (c) The division shall deposit money received from the monthly supervision fee
117 established in this Subsection (6) into the General Fund as a parole and probation
118 dedicated credit to be used to cover costs incurred in the collection of the fee and in
119 the development of offender supervision programs.
- 120 (7)(a) For offenders placed on probation under Section 77-18-105 or parole under
121 Subsection 76-3-202(2)(a) on or after October 1, 2015, but before January 1, 2019,
122 the division shall establish a program allowing an offender to earn a reduction credit
123 of 30 days from the offender's period of probation or parole for each month the
124 offender complies with the terms of the offender's probation or parole agreement,
125 including the case action plan.
- 126 (b)(i) For offenders placed on probation under Section 77-18-105 or parole under
127 Section 76-3-202 on or after July 1, 2026, the division shall establish a program,
128 consistent with the adult sentencing and supervision length guidelines, as defined
129 in Section 63M-7-401.1, to provide incentives for an offender that maintains
130 eligible employment, as defined in Section 64-13g-101.

- 131 (ii) The program under Subsection (7)(b)(i) may include a credit towards the
132 reduction of the length of supervision for an offender at a rate of up to 30 days for
133 each month that the offender maintains eligible employment, as defined in Section
134 64-13g-101.
- 135 (iii) A court, or the Board of Pardons and Parole, is not required to grant a request for
136 termination of supervision under the program described in this Subsection (7)(b) if
137 the court, or the Board of Pardons and Parole, finds that:
- 138 (A) the offender presents a substantial risk to public safety;
- 139 (B) termination would prevent the offender from completing risk reduction
140 programming or treatment; or
- 141 (C) the eligibility criteria for termination of supervision, as established in the adult
142 sentencing and supervision length guidelines, as defined in Section
143 63M-7-401.1, have not been met.
- 144 (iv) This Subsection (7)(b) does not prohibit the division, or another supervision
145 services provider, from requesting termination of supervision based on the
146 eligibility criteria in the adult sentencing and supervision length guidelines, as
147 defined in Section 63M-7-401.1.
- 148 (c) The division shall:
- 149 (i) maintain a record of credits earned by an offender under this Subsection (7); and
- 150 (ii) request from the court or the Board of Pardons and Parole the termination of
151 probation or parole not fewer than 30 days prior to the termination date that
152 reflects the credits earned under this Subsection (7).
- 153 (d) This Subsection (7) does not prohibit the division from requesting a termination date
154 earlier than the termination date established by earned credits under Subsection (7)(c).
- 155 (e) The court or the Board of Pardons and Parole shall terminate an offender's probation
156 or parole upon completion of the period of probation or parole accrued by time
157 served and credits earned under this Subsection (7) unless the court or the Board of
158 Pardons and Parole finds that termination would interrupt the completion of a
159 necessary treatment program, in which case the termination of probation or parole
160 shall occur when the treatment program is completed.
- 161 (f) The department shall report annually to the State Commission on Criminal and
162 Juvenile Justice on or before August 31:
- 163 (i) the number of offenders who have earned probation or parole credits under this
164 Subsection (7) in one or more months of the preceding fiscal year and the

- 165 percentage of the offenders on probation or parole during that time that this
166 number represents;
- 167 (ii) the average number of credits earned by those offenders who earned credits;
168 (iii) the number of offenders who earned credits by county of residence while on
169 probation or parole;
- 170 (iv) the cost savings associated with sentencing reform programs and practices; and
171 (v) a description of how the savings will be invested in treatment and
172 early-intervention programs and practices at the county and state levels.
- 173 (8)(a) The department shall coordinate with a local mental health authority to complete
174 the requirements of this Subsection (8) for an offender who:
- 175 (i) is a habitual offender as that term is defined in Section 77-18-102;
176 (ii) has a mental illness as that term is defined in Section 26B-5-301; and
177 (iii) based on a risk and needs assessment:
178 (A) is at a high risk of reoffending; and
179 (B) has risk factors that may be addressed by available community-based services.
- 180 (b) For an offender described in Subsection (8)(a), at any time clinically appropriate or
181 at least three months before termination of an offender's parole or expiration of an
182 offender's sentence, the department shall coordinate with the Department of Health
183 and Human Services and the relevant local mental health authority to provide
184 applicable clinical assessments and transitional treatment planning and services for
185 the offender so that the offender may receive appropriate treatment and support
186 services after the termination of parole or expiration of sentence.
- 187 (c) The local mental health authority may determine whether the offender:
188 (i) meets the criteria for civil commitment;
189 (ii) meets the criteria for assisted outpatient treatment; or
190 (iii) would benefit from assignment to an assertive community treatment team or
191 available community-based services.
- 192 (d) Based on the local mental health authority's determination under Subsection (8)(c),
193 the local mental health authority shall, as appropriate:
194 (i) initiate an involuntary commitment court proceeding;
195 (ii) file a written application for assisted outpatient treatment; or
196 (iii) seek to have the offender assigned to an assertive community treatment team or
197 available community-based services.
- 198 (e) On or before November 1, 2025, the department shall provide a report to the Law

199 Enforcement and Criminal Justice Interim Committee regarding any proposed
200 changes to the requirements in this Subsection (8), including whether the
201 requirements of this Subsection (8) should also apply to any other category of
202 offenders.

203 Section 2. Section **77-18-105** is amended to read:

204 **77-18-105 . Pleas held in abeyance -- Suspension of a sentence -- Probation --**
205 **Supervision -- Terms and conditions of probation -- Time periods for probation -- Bench**
206 **supervision for payments on criminal accounts receivable.**

207 (1) If a defendant enters a plea of guilty or no contest in conjunction with a plea in
208 abeyance agreement, the court may hold the plea in abeyance:

209 (a) in accordance with Chapter 2a, Pleas in Abeyance; and

210 (b) under the terms of the plea in abeyance agreement.

211 (2) If a defendant is convicted, the court:

212 (a) shall impose a sentence in accordance with Section 76-3-201; and

213 (b) subject to Subsection (5), may suspend the execution of the sentence and place the
214 defendant:

215 (i) on probation under the supervision of the division;

216 (ii) on probation under the supervision of an agency of a local government or a
217 private organization; or

218 (iii) on court probation under the jurisdiction of the sentencing court.

219 (3)(a) The legal custody of all probationers under the supervision of the division is with
220 the department.

221 (b) The legal custody of all probationers under the jurisdiction of the sentencing court is
222 vested as ordered by the court.

223 (c) The court has continuing jurisdiction over all probationers.

224 (4)(a) Court probation may include an administrative level of services, including
225 notification to the sentencing court of scheduled periodic reviews of the probationer's
226 compliance with conditions.

227 (b) Supervised probation services provided by the division, an agency of a local
228 government, or a private organization shall specifically address the defendant's risk
229 of reoffending as identified by a screening or an assessment.

230 (c) If a court orders supervised probation and determines that a public probation
231 provider is unavailable or inappropriate to supervise the defendant, the court shall
232 make available to the defendant the list of private probation providers prepared by a

- 233 criminal justice coordinating council under Section 17E-2-201.
- 234 (5)(a) Before ordering supervised probation, the court shall consider the supervision
235 costs to the defendant for each entity that can supervise the defendant.
- 236 (b)(i) A court may order an agency of a local government to supervise the probation
237 for an individual convicted of any crime if:
- 238 (A) the agency has the capacity to supervise the individual; and
239 (B) the individual's supervision needs will be met by the agency.
- 240 (ii) A court may only order:
- 241 (A) except as provided in Subsection (5)(b)(iii), the division to supervise the
242 probation for an individual convicted of a class A misdemeanor or any felony;
243 or
- 244 (B) a private organization to supervise the probation for an individual convicted of
245 a class A, B, or C misdemeanor or an infraction.
- 246 (iii) A court may order the division to supervise the probation for an individual
247 convicted of a class B misdemeanor if the division consents to supervise the
248 offender.
- 249 (c) A court may not order a specific private organization to supervise an individual
250 unless there is only one private organization that can provide the specific supervision
251 services required to meet the individual's supervision needs.
- 252 (6)(a) If a defendant is placed on probation, the court may order the defendant as a
253 condition of the defendant's probation:
- 254 (i) to provide for the support of persons for whose support the defendant is legally
255 liable;
- 256 (ii) to participate in available treatment programs, including any treatment program in
257 which the defendant is currently participating if the program is acceptable to the
258 court;
- 259 (iii) be voluntarily admitted to the custody of the Division of Substance Use and
260 Mental Health for treatment at the Utah State Hospital in accordance with Section
261 77-18-106;
- 262 (iv) if the defendant is on probation for a felony offense, to serve a period of time as
263 an initial condition of probation that does not exceed one year in a county jail
264 designated by the department, after considering any recommendation by the court
265 as to which jail the court finds most appropriate;
- 266 (v) to serve a term of home confinement in accordance with Section 77-18-107;

- 267 (vi) to participate in compensatory service programs, including the compensatory
268 service program described in Section 76-3-410;
- 269 (vii) to pay for the costs of investigation, probation, or treatment services;
- 270 (viii) to pay restitution to a victim with interest in accordance with Chapter 38b,
271 Crime Victims Restitution Act; or
- 272 (ix) to comply with other terms and conditions the court considers appropriate to
273 ensure public safety or increase a defendant's likelihood of success on probation.
- 274 (b) If a defendant is placed on probation and a condition of the defendant's probation is
275 routine or random drug testing, the defendant shall sign a waiver consistent with the
276 Health Insurance Portability and Accountability Act, 42 U.S.C. Sec. 1320d et seq.,
277 allowing the treatment provider conducting the drug testing to notify the defendant's
278 supervising probation officer regarding the results of the defendant's drug testing.
- 279 (c)(i) Notwithstanding Subsection (6)(a)(iv), the court may modify the probation of a
280 defendant to include a period of time that is served in a county jail immediately
281 before the termination of probation as long as that period of time does not exceed
282 one year.
- 283 (ii) If a defendant is ordered to serve time in a county jail as a sanction for a
284 probation violation, the one-year limitation described in Subsection (6)(a)(iv) or
285 (6)(c)(i) does not apply to the period of time that the court orders the defendant to
286 serve in a county jail under this Subsection (6)(c)(ii).
- 287 (7)(a) Except as provided in Subsection (7)(b), probation of an individual placed on
288 probation after December 31, 2018:
- 289 (i) may not exceed the individual's maximum sentence;
- 290 (ii) shall be for a period of time that is in accordance with the adult sentencing and
291 supervision length guidelines, as defined in Section 63M-7-401.1, to the extent the
292 guidelines are consistent with the requirements of the law; and
- 293 (iii) shall be terminated in accordance with the adult sentencing and supervision
294 length guidelines, as defined in Section 63M-7-401.1, to the extent the guidelines
295 are consistent with the requirements of the law.
- 296 (b) Probation of an individual placed on probation after December 31, 2018, whose
297 maximum sentence is one year or less, may not exceed 36 months.
- 298 (c) Probation of an individual placed on probation on or after October 1, 2015, but
299 before January 1, 2019, may be terminated at any time at the discretion of the court
300 or upon completion without violation of 36 months probation in felony or class A

301 misdemeanor cases, 12 months in cases of class B or C misdemeanors or infractions,
302 or as allowed in accordance with Section 64-13-21 regarding earned credits.

303 (d) This Subsection (7) does not apply to the probation of an individual convicted of an
304 offense for criminal nonsupport under Section 76-7-201.

305 (8)(a) Notwithstanding Subsection (7), if there is an unpaid balance of the criminal
306 accounts receivable for the defendant upon termination of the probation period for
307 the defendant under Subsection (7), the court may require the defendant to continue
308 to make payments towards the criminal accounts receivable in accordance with the
309 payment schedule established by the court under Section 77-32b-103.

310 (b) A court may not require the defendant to make payments as described in Subsection
311 (8)(a) beyond the expiration of the defendant's sentence.

312 (c) If the court requires a defendant to continue to pay in accordance with the payment
313 schedule for the criminal accounts receivable under this Subsection (8) and the
314 defendant defaults on the criminal accounts receivable, the court shall proceed with
315 an order for a civil judgment of restitution and a civil accounts receivable for the
316 defendant as described in Section 77-18-114.

317 (d)(i) Upon a motion from the prosecuting attorney, the victim, or upon the court's
318 own motion, the court may require a defendant to show cause as to why the
319 defendant's failure to pay in accordance with the payment schedule should not be
320 treated as contempt of court.

321 (ii) A court may hold a defendant in contempt for failure to make payments for a
322 criminal accounts receivable in accordance with Title 78B, Chapter 6, Part 3,
323 Contempt.

324 (e) This Subsection (8) does not apply to the probation of an individual convicted of an
325 offense for criminal nonsupport under Section 76-7-201.

326 (9) When making any decision regarding probation:

327 (a) the court shall consider information provided by the Department of Corrections
328 regarding a defendant's individual case action plan, including any progress the
329 defendant has made in satisfying the case action plan's completion requirements; and

330 (b) the court may not rely solely on an algorithm or a risk assessment tool score.

331 Section 3. Section **77-27-5** is amended to read:

332 **77-27-5 . Board of Pardons and Parole authority.**

333 (1)(a) Subject to this chapter and other laws of the state, and except for a conviction for
334 treason or impeachment, the board shall determine by majority decision when and

- 335 under what conditions an offender's conviction may be pardoned or commuted.
- 336 (b) The board shall determine by majority decision when and under what conditions an
337 offender committed to serve a sentence at a penal or correctional facility, which is
338 under the jurisdiction of the department, may:
- 339 (i) be released upon parole;
- 340 (ii) have a fine or forfeiture remitted;
- 341 (iii) have the offender's criminal accounts receivable remitted in accordance with
342 Section 77-32b-105 or 77-32b-106;
- 343 (iv) have the offender's payment schedule modified in accordance with Section
344 77-32b-103; or
- 345 (v) have the offender's sentence terminated.
- 346 (c) The board shall prioritize public safety when making a determination under
347 Subsection (1)(a) or (1)(b).
- 348 (d)(i) The board may sit together or in panels to conduct hearings.
- 349 (ii) The chair shall appoint members to the panels in any combination and in
350 accordance with rules made by the board in accordance with Title 63G, Chapter 3,

430 parole in accordance with the adult sentencing and supervision length guidelines, as

 458 (v) for a minor, the day on which the division's custody of the offender was
 459 terminated; or
