2                   **LONG TITLE**

3                   **General Description:**

4                   This bill amends provisions relating to voting.

5                   **Highlighted Provisions:**

6                   This bill:

7                   ▶ defines terms;

8                   ▶ provides a process for an election officer to independently determine whether a registered  
9                   voter is not a citizen of the United States;

10                  ▶ provides a process to challenge a determination described in the preceding paragraph;

11                  ▶ prohibits an individual from voting if an election officer independently determines that  
12                  the voter is not a citizen of the United States and the individual does not successfully  
13                  dispute the determination;

14                  ▶ creates a bifurcated ballot system where, for an election held on or after November 1,  
15                  2026:

16                  • a voter chooses whether to provide documentary proof of United States citizenship  
17                  when registering to vote or before voting; and

18                  • a voter who does not provide documentary proof of United States citizenship may only  
19                  vote in races for federal office;

20                  ▶ modifies voter registration forms and requirements consistent with the bifurcated ballot  
21                  system;

22                  ▶ establishes procedures for administration of the bifurcated ballot system;

23                  ▶ modifies voter registration list requirements in relation to the bifurcated ballot system; and  
24                  ▶ makes technical and conforming changes.

48        *Be it enacted by the Legislature of the state of Utah:*

49            Section 1. Section **20A-1-102** is amended to read:

50        **20A-1-102 . Definitions.**

51        As used in this title:

52        (1) "Active voter" means a registered voter who has not been classified as an inactive voter  
53            by the county clerk.

54        (2) "Automatic tabulating equipment" means apparatus that automatically examines and  
55            counts votes recorded on ballots and tabulates the results.

56        (3)(a) "Ballot" means the storage medium, including a paper, mechanical, or electronic  
57            storage medium, that records an individual voter's vote.

58        (b) "Ballot" does not include a record to tally multiple votes.

59        (4) "Ballot proposition" means a question, issue, or proposal that is submitted to voters on  
60            the ballot for their approval or rejection including:

61            (a) an opinion question specifically authorized by the Legislature;

62            (b) a constitutional amendment;

- 63 (c) an initiative;
- 64 (d) a referendum;
- 65 (e) a bond proposition;
- 66 (f) a judicial retention question;
- 67 (g) an incorporation of a city or town; or
- 68 (h) any other ballot question specifically authorized by the Legislature.

69 (5) "Bind," "binding," or "bound" means securing more than one piece of paper together  
70 using staples or another means in at least three places across the top of the paper in the  
71 blank space reserved for securing the paper.

72 (6) "Board of canvassers" means the entities established by Sections 20A-4-301 and  
73 20A-4-306 to canvass election returns.

74 (7) "Bond election" means an election held for the purpose of approving or rejecting the  
75 proposed issuance of bonds by a government entity.

76 (8) "Business day" means a Monday, Tuesday, Wednesday, Thursday, or Friday that is not  
77 a holiday.

78 (9) "Business reply mail envelope" means an envelope that may be mailed free of charge by  
79 the sender.

80 (10) "Calendar day" means any day, regardless of whether the day is a weekend, a holiday,  
81 a business day, or any other type of day.

82 (11) "Canvass" means the review of election returns and the official declaration of election  
83 results by the board of canvassers.

84 (12) "Canvassing judge" means a poll worker designated to assist in counting ballots at the  
85 canvass.

86 (13) "Contracting election officer" means an election officer who enters into a contract or  
87 interlocal agreement with a provider election officer.

88 (14) "Convention" means the political party convention at which party officers and  
89 delegates are selected.

90 (15) "Counting center" means one or more locations selected by the election officer in  
91 charge of the election for the automatic counting of ballots.

92 (16) "Counting judge" means a poll worker designated to count the ballots during election  
93 day.

94 (17) "Counting room" means a suitable and convenient private place or room for use by the  
95 poll workers and counting judges to count ballots.

96 (18) "County officers" means those county officers that are required by law to be elected.

97 (19) "Date of the election" or "election day" or "day of the election":

98 (a) means the day that is specified in the calendar year as the day on which the election  
99 occurs; and

100 (b) does not include:

101 (i) deadlines established for voting by mail, military-overseas voting, or emergency  
102 voting; or

103 (ii) any early voting or early voting period as provided under Chapter 3a, Part 6,  
104 Early Voting.

105 (20) "Documentary proof of United States citizenship" means:

106 (a) a Utah driver license number that verifies United States citizenship;

107 (b) a Utah state identification card number that verifies United States citizenship;

108 (c) a legible copy of an individual's birth certificate that verifies United States  
109 citizenship;

110 (d) a legible copy of the pages of an individual's United States passport that identifies  
111 the individual and the individual's passport number;

112 (e) an alien registration number that verifies United States citizenship;

113 (f) a legible copy of the voter's United States naturalization documents;

114 (g) a Bureau of Indian Affairs card number, tribal treaty card number, or tribal  
115 enrollment number;

116 (h) a legible copy of a certificate of degree of Indian blood or a Bureau of Indian Affairs  
117 affidavit of birth;

118 (i) verification of citizenship from the Systematic Alien Verification for Entitlements  
119 program, operated by the United States Department of Homeland Security; or

120 (j) other documents or methods of proving United States citizenship that are established  
121 in accordance with the Immigration Reform and Control Act of 1986.

122 [(20)] (21) "Elected official" means:

123 (a) a person elected to an office under Section 20A-1-303 or Chapter 4, Part 6,  
124 Municipal Alternate Voting Methods Pilot Project;

125 (b) a person who is considered to be elected to a municipal office in accordance with  
126 Subsection 20A-1-206(1)(c)(ii); or

127 (c) a person who is considered to be elected to a special district office in accordance  
128 with Subsection 20A-1-206(3)(b)(ii).

129 [(21)] (22) "Election" means a regular general election, a municipal general election, a  
130 statewide special election, a local special election, a regular primary election, a

131 municipal primary election, and a special district election.

132 [~~22~~] (23) "Election Assistance Commission" means the commission established by the  
133 Help America Vote Act of 2002, Pub. L. No. 107-252.

134 [~~23~~] (24) "Election cycle" means the period beginning on the first day on which  
135 individuals are eligible to file declarations of candidacy and ending when the canvass is  
136 completed.

137 [~~24~~] (25) "Election judge" means a poll worker that is assigned to:

- 138 (a) preside over other poll workers at a polling place;
- 139 (b) act as the presiding election judge; or
- 140 (c) serve as a canvassing judge, counting judge, or receiving judge.

141 [~~25~~] (26) "Election material" includes:

- 142 (a) the verification documentation described in Subsection 20A-3a-401(9)(b)(iv);
- 143 (b) the list of voters contacted to cure a ballot described in Subsection 20A-3a-401(10)(b);
- 144 (c) the record of rejected and resolved ballots described in Subsection 20A-3a-401(11)(a);
- 145 (d) any chain of custody documentation described in Section 20A-3a-401.1, including:
  - 146 (i) the count of ballots described in Subsection 20A-3a-401.1(3); and
  - 147 (ii) the batch log described in Subsection 20A-3a-401.1(5);
- 148 (e) the record of signature verification audits described in Subsection 20A-3a-402.5(4);
- 149 (f) the affidavit of compliance described in Subsection 20A-3a-404(2);
- 150 (g) the physical and electronic log of replicated ballots described in Subsection  
151 20A-4-104(3);
- 152 (h) the physical or electronic log of adjudicated ballots described in Section 20A-5-802.5;
- 153 (i) the record of voter database access described in Subsection 20A-5-905(2);
- 154 (j) the reports on military and overseas voters described in Section 20A-16-202;
- 155 (k) scanned copies of return envelopes;
- 156 (l) a copy of the final election results database described in Section 20A-5-802.5; and
- 157 (m) the materials used in the programming of the automatic tabulating equipment.

158 [~~26~~] (27) "Election officer" means:

- 159 (a) the lieutenant governor, for all statewide ballots and elections;
- 160 (b) the county clerk for:
  - 161 (i) a county ballot and election; and
  - 162 (ii) a ballot and election as a provider election officer as provided in Section  
163 20A-5-400.1 or 20A-5-400.5;
- 164 (c) the municipal clerk for:

165 (i) a municipal ballot and election; and  
166 (ii) a ballot and election as a provider election officer as provided in Section  
167 20A-5-400.1 or 20A-5-400.5;  
168 (d) the special district clerk or chief executive officer for:  
169 (i) a special district ballot and election; and  
170 (ii) a ballot and election as a provider election officer as provided in Section  
171 20A-5-400.1 or 20A-5-400.5; or  
172 (e) the business administrator or superintendent of a school district for:  
173 (i) a school district ballot and election; and  
174 (ii) a ballot and election as a provider election officer as provided in Section

176 [~~(27)~~] (28) "Election official" means any election officer, election judge, or poll worker.  
177 [~~(28)~~] (29) "Election results" means:  
178 (a) for an election other than a bond election, the count of votes cast in the election and  
179 the election returns requested by the board of canvassers; or  
180 (b) for bond elections, the count of those votes cast for and against the bond proposition  
181 plus any or all of the election returns that the board of canvassers may request.  
182 [~~(29)~~] (30) "Election results database" means the following information generated by voting  
183 equipment:  
184 (a) one or more electronic files that contains a digital interpretation of each ballot that is  
185 counted in an election;  
186 (b) a ballot image; and  
187 (c) other information related to a ballot that is adjudicated under Section 20A-4-105.  
188 [~~(30)~~] (31) "Election returns" means:  
189 (a) the pollbook;  
190 (b) the military and overseas absentee voter registration and voting certificates;  
191 (c) one of the tally sheets;  
192 (d) any unprocessed ballots;  
193 (e) all counted ballots;  
194 (f) all excess ballots;  
195 (g) all unused ballots;  
196 (h) all spoiled ballots;  
197 (i) all ballot disposition forms, including any provisional ballot disposition forms;  
198 (j) the final election results database described in Section 20A-5-802.5;

199 (k) all return envelopes;

200 (l) any provisional ballot envelopes; and

201 (m) the total votes cast form.

202 [31] (32) "Electronic signature" means an electronic sound, symbol, or process attached to  
203 or logically associated with a record and executed or adopted by a person with the intent  
204 to sign the record.

205 (33) "Federal ballot" means a ballot that includes only the federal races that are to be  
206 presented for a vote in a particular election.

207 [32] (34) "Holiday" means a legal holiday described in Subsections 63G-1-301(1) and (2).

208 [33] (35) "Inactive voter" means a registered voter who is listed as inactive by a county  
209 clerk under Subsection 20A-2-505(4)(c)(i) or (ii).

210 [34] (36) "Judicial office" means the office filled by any judicial officer.

211 [35] (37) "Judicial officer" means any justice or judge of a court of record or any county  
212 court judge.

213 [36] (38) "Local election" means a regular county election, a regular municipal election, a  
214 municipal primary election, a local special election, a special district election, and a  
215 bond election.

216 [37] (39) "Local political subdivision" means a county, a municipality, a special district, or  
217 a local school district.

218 [38] (40) "Local special election" means a special election called by the governing body of  
219 a local political subdivision in which all registered voters of the local political  
220 subdivision may vote.

221 [39] (41) "Manual ballot" means a paper document produced by an election officer on  
222 which an individual records an individual's vote by directly placing a mark on the paper  
223 document using a pen or other marking instrument.

224 [40] (42) "Mechanical ballot" means a record, including a paper record, electronic record,  
225 or mechanical record, that:

226 (a) is created via electronic or mechanical means; and

227 (b) records an individual voter's vote cast via a method other than an individual directly  
228 placing a mark, using a pen or other marking instrument, to record an individual  
229 voter's vote.

230 [41] (43) "Municipal executive" means:

231 (a) the mayor in the council-mayor form of government defined in Section 10-3b-102; or  
232 (b) the mayor in the council-manager form of government defined in Subsection

233 10-3b-103(6).

234 [42] (44) "Municipal general election" means the election held in municipalities and, as  
235 applicable, special districts on the first Tuesday after the first Monday in November of  
236 each odd-numbered year for the purposes established in Section 20A-1-202.

237 [43] (45) "Municipal legislative body" means the council of the city or town in any form  
238 of municipal government.

239 [44] (46) "Municipal office" means an elective office in a municipality.

240 [45] (47) "Municipal officers" means those municipal officers that are required by law to  
241 be elected.

242 [46] (48) "Municipal primary election" means an election held to nominate candidates for  
243 municipal office.

244 [47] (49) "Municipality" means a city or town.

245 [48] (50) "Official ballot" means the ballots distributed by the election officer for voters to  
246 record their votes.

247 [49] (51) "Official endorsement" means the information on the ballot that identifies:

248 (a) the ballot as an official ballot;

249 (b) the date of the election; and

250 (c)(i) for a ballot prepared by an election officer other than a county clerk, the  
251 facsimile signature required by Subsection 20A-6-401(1)(a)(iii); or

252 (ii) for a ballot prepared by a county clerk, the words required by Subsection  
253 20A-6-301(1)(b)(iii).

254 [50] (52) "Official register" means the official record furnished to election officials by the  
255 election officer that contains the information required by Section 20A-5-401.

256 [51] (53) "Political party" means an organization of registered voters that has qualified to  
257 participate in an election by meeting the requirements of Chapter 8, Political Party  
258 Formation and Procedures.

259 [52] (54)(a) "Poll worker" means a person assigned by an election official to assist with  
260 an election, voting, or counting votes.

261 (b) "Poll worker" includes election judges.

262 (c) "Poll worker" does not include a watcher.

263 [53] (55) "Pollbook" means a record of the names of voters in the order that the voters  
264 appear to cast votes.

265 [54] (56) "Polling place" means a building where voting is conducted.

266 [55] (57) "Position" means a square, circle, rectangle, or other geometric shape on a ballot

267 in which the voter marks the voter's choice.

268 [~~56~~] 58 "Presidential Primary Election" means the election established in Chapter 9, Part  
269 8, Presidential Primary Election.

270 [~~57~~] 59 "Primary convention" means the political party conventions held during the year  
271 of the regular general election.

272 [~~58~~] 60 "Protective counter" means a separate counter, which cannot be reset, that:

273 (a) is built into a voting machine; and

274 (b) records the total number of movements of the operating lever.

275 [~~59~~] 61 "Provider election officer" means an election officer who enters into a contract or  
276 interlocal agreement with a contracting election officer to conduct an election for the  
277 contracting election officer's local political subdivision in accordance with Section  
278 20A-5-400.1.

279 [~~60~~] 62 "Provisional ballot" means a ballot voted provisionally by a person:

280 (a) whose name is not listed on the official register at the polling place;

281 (b) whose legal right to vote is challenged as provided in this title; or

282 (c) whose identity was not sufficiently established by a poll worker.

283 [~~61~~] 63 "Provisional ballot envelope" means an envelope printed in the form required by  
284 Section 20A-6-105 that is used to identify provisional ballots and to provide information  
285 to verify a person's legal right to vote.

286 [~~62~~] 64(a) "Public figure" means an individual who, due to the individual being  
287 considered for, holding, or having held a position of prominence in a public or  
288 private capacity, or due to the individual's celebrity status, has an increased risk to the  
289 individual's safety.

290 (b) "Public figure" does not include an individual:

291 (i) elected to public office; or

292 (ii) appointed to fill a vacancy in an elected public office.

293 [~~63~~] 65 "Qualify" or "qualified" means to take the oath of office and begin performing  
294 the duties of the position for which the individual was elected.

295 [~~64~~] 66 "Receiving judge" means the poll worker that checks the voter's name in the  
296 official register at a polling place and provides the voter with a ballot.

297 [~~65~~] 67 "Registration form" means a form by which an individual may register to vote  
298 under this title.

299 [~~66~~] 68 "Regular ballot" means a ballot that is not a provisional ballot.

300 [~~67~~] 69 "Regular general election" means the election held throughout the state on the

301 first Tuesday after the first Monday in November of each even-numbered year for the  
302 purposes established in Section 20A-1-201.

303 [(68)] (70) "Regular primary election" means the election, held on the date specified in  
304 Section 20A-1-201.5, to nominate candidates of political parties and candidates for  
305 nonpartisan local school board positions to advance to the regular general election.

306 [(69)] (71) "Resident" means a person who resides within a specific voting precinct in Utah.

307 [(70)] (72) "Return envelope" means the envelope, described in Subsection 20A-3a-202(4),  
308 provided to a voter with a manual ballot:

309 (a) into which the voter places the manual ballot after the voter has voted the manual  
310 ballot in order to preserve the secrecy of the voter's vote; and

311 (b) that includes the voter affidavit and a place for the voter's signature.

312 [(71)] (73) "Sample ballot" means a mock ballot similar in form to the official ballot,  
313 published as provided in Section 20A-5-405.

314 [(72)] (74) "Special district" means a local government entity under Title 17B, Limited  
315 Purpose Local Government Entities - Special Districts, and includes a special service  
316 district under Title 17D, Chapter 1, Special Service District Act.

317 [(73)] (75) "Special district officers" means those special district board members who are  
318 required by law to be elected.

319 [(74)] (76) "Special election" means an election held as authorized by Section 20A-1-203.

320 [(75)] (77) "Spoiled ballot" means each ballot that:

321 (a) is spoiled by the voter;

322 (b) is unable to be voted because it was spoiled by the printer or a poll worker; or

323 (c) lacks the official endorsement.

324 (78) "Standard ballot" means a ballot that includes all races and ballot propositions that are  
325 to be presented for a vote in a particular election.

326 [(76)] (79) "Statewide special election" means a special election called by the governor or  
327 the Legislature in which all registered voters in Utah may vote.

328 [(77)] (80) "Tabulation system" means a device or system designed for the sole purpose of  
329 tabulating votes cast by voters at an election.

330 [(78)] (81) "Ticket" means a list of:

331 (a) political parties;

332 (b) candidates for an office; or

333 (c) ballot propositions.

334 [(79)] (82) "Transfer case" means the sealed box used to transport voted ballots to the

335       counting center.

336       [~~(80)~~] (83) "Vacancy" means:

337       (a) except as provided in Subsection [~~(80)(b)~~] (83)(b), the absence of an individual to  
338       serve in a position created by state constitution or state statute, whether that absence  
339       occurs because of death, disability, disqualification, resignation, or other cause; or  
340       (b) in relation to a candidate for a position created by state constitution or state statute,  
341       the removal of a candidate due to the candidate's death, resignation, or  
342       disqualification.

343       [~~(81)~~] (84) "Valid voter identification" means:

344       (a) a form of identification that bears the name and photograph of the voter which may  
345       include:  
346           (i) a currently valid Utah driver license;  
347           (ii) a currently valid identification card issued under Title 53, Chapter 3, Part 8,  
348              Identification Card Act;  
349           (iii) a currently valid identification card that is issued by:  
350               (A) the state; or  
351               (B) a branch, department, or agency of the United States;  
352           (iv) a currently valid Utah permit to carry a concealed weapon;  
353           (v) a currently valid United States passport; or  
354           (vi) a currently valid United States military identification card;  
355       (b) one of the following identification cards, regardless of whether the card includes a  
356       photograph of the voter:

368           (iv) a valid social security card;

369 (v) an original or copy of a check issued by the state or the federal government, dated  
370 no more than 90 calendar days before the date of the election;  
371 (vi) an original or copy of a paycheck from the voter's employer, dated no more than  
372 90 calendar days before the date of the election;  
373 (vii) a currently valid Utah hunting or fishing license;  
374 (viii) certified naturalization documentation;  
375 (ix) a currently valid license issued by an authorized agency of the United States;  
376 (x) a certified copy of court records showing the voter's adoption or name change;  
377 (xi) a valid Medicaid card, Medicare card, or Electronic Benefits Transfer [ECard] card;  
378 (xii) a currently valid identification card issued by:  
379 (A) a local government within the state;  
380 (B) an employer for an employee; or  
381 (C) a college, university, technical school, or professional school located within  
382 the state; or  
383 (xiii) a current Utah vehicle registration.

384 [~~(82)~~] (85) "Valid write-in candidate" means a candidate who has qualified as a write-in  
385 candidate by following the procedures and requirements of this title.

386 [~~(83)~~] (86) "Vote by mail" means to vote, using a manual ballot that is mailed to the voter,  
387 by:

388 (a) mailing the ballot to the location designated in the mailing; or  
389 (b) depositing the ballot in a ballot drop box designated by the election officer.

390 [~~(84)~~] (87) "Voter" means an individual who:

391 (a) meets the requirements for voting in an election;  
392 (b) meets the requirements of election registration;  
393 (c) is registered to vote; and  
394 (d) is listed in the official register.

395 [~~(85)~~] (88) "Voter registration deadline" means the registration deadline provided in Section  
396 20A-2-102.5.

397 [~~(86)~~] (89) "Voting area" means the area within six feet of the voting booths, voting  
398 machines, and ballot box.

400 (a) the space or compartment within a polling place that is provided for the preparation  
401 of ballots, including the voting enclosure or curtain; or  
402 (b) a voting device that is free standing.

404 vote a mechanical ballot.

405 [({89})] (92) "Voting precinct" means the smallest geographical voting unit, established under  
406 Chapter 5, Part 3, Duties of the County and Municipal Legislative Bodies.

407 [({90})] (93) "Watcher" means an individual who complies with the requirements described in  
408 Section 20A-3a-801 to become a watcher for an election.

409 [({91})] (94) "Write-in ballot" means a ballot containing any write-in votes.

410 [({92})] (95) "Write-in vote" means a vote cast for an individual, whose name is not printed on  
411 the ballot, in accordance with the procedures established in this title.

412 Section 2. Section **20A-2-101.1** is amended to read:

413 **20A-2-101.1 . Preregistering to vote.**

414 (1) [An] Subject to Section 20A-3a-201.5, an individual may preregister to vote if the  
415 individual:  
416 (a) is 16 or 17 years [of age] old;  
417 (b) is not eligible to register to vote because the individual does not comply with the age  
418 requirements described in Subsection 20A-2-101(1)(c);  
419 (c) is a citizen of the United States;  
420 (d) has been a resident of Utah for at least 30 calendar days; and  
421 (e) currently resides within the voting district or precinct in which the individual  
422 preregisters to vote.

423 (2) An individual described in Subsection (1) may not vote in an election and is not  
424 registered to vote until:  
425 (a) the individual is otherwise eligible to register to vote because the individual complies

1300 proof of United States citizenship, the voter may provide documentary proof of the name  
1301 change, together with the voter's documentary proof of United States citizenship, to  
1302 establish that the voter is a United States citizen.

1303 Section 10. Section **20A-3a-202** is amended to read:

1304 **20A-3a-202 . Conducting election in person and by mail -- Mailing ballots to**  
1305 **voters -- Exceptions by mail.**

1306 (1)(a) Except as otherwise provided for an election conducted entirely by mail under  
1307 Section 20A-7-609.5, an election officer shall administer an election primarily by  
1308 mail, in accordance with this section.

1309 (b) An individual who did not provide valid voter identification at the time the voter  
1310 registered to vote shall provide valid voter identification before voting.

1311 (2) An election officer who administers an election:

1312 (a) shall in accordance with Subsection (3), no sooner than 21 calendar days before  
1313 election day and no later than seven calendar days before election day, mail to the  
1314 applicable voters, in accordance with Subsection 20A-3a-202.5(3), and subject to  
1315 Subsection 20A-3a-202.5(4):

1316 (i) a manual ballot;

1317 (ii) a return envelope;

1318 (iii) instructions for returning the ballot that include an express notice about any  
1319 relevant deadlines that the voter must meet in order for the voter's vote to be  
1320 counted;

1321 (iv) information regarding the location and hours of operation of any election day  
1322 voting center at which the voter may vote or a website address where the voter  
1323 may view this information; and  
1324 (v) instructions on how a voter may sign up to receive electronic ballot status  
1325 notifications via the ballot tracking system described in Section 20A-3a-401.5;  
1326 (b) may not mail a ballot under this section to:  
1327 (i) an inactive voter, unless the inactive voter requests a manual ballot;[-or]  
1328 (ii) a voter whom the election officer is prohibited from sending a ballot under  
1329 Subsection 20A-3a-202.5(4); or  
1330 (iii) for an election held on or after November 1, 2026, a voter who is only eligible to  
1331 vote a federal ballot, if the election does not include a race for federal office;  
1332 (c) shall, on the outside of the envelope in which the election officer mails the ballot,  
1333 include instructions for returning the ballot if the individual to whom the election  
1334 officer mails the ballot does not live at the address to which the ballot is sent;  
1335 (d) shall provide a method of accessible voting to a voter with a disability who is not  
1336 able to vote by mail; and  
1337 (e) shall include, on the election officer's website and with each ballot mailed,  
1338 instructions regarding how a voter described in Subsection (2)(d) may vote.  
1339 (3)(a) An election officer who mails a manual ballot under Subsection (2) shall mail the  
1340 manual ballot to the address:  
1341 (i) provided at the time of registration or updated by the voter after the time of  
1342 registration; or  
1343 (ii) if, at or after the time of registration, the voter files an alternate address request  
1344 form described in Subsection (3)(b), the alternate address indicated on the form.  
1345 (b) The lieutenant governor shall make available to voters an alternate address request

1348 (c) A voter shall provide the completed alternate address request form to the election  
1349 officer no later than 11 calendar days before the day of the election.  
1350 (d) Beginning on November 5, 2025, through December 31, 2028, an election officer shall  
1351 include, with each ballot mailed to a voter, a separate paper document containing the following  
1352 statements:  
1353 "WARNING  
1354 If you have a valid Utah driver license or a valid Utah state identification card, failure to

1355 provide the last four digits of the license or card number may result in your ballot not being

1366 (e) Beginning on January 1, 2029, an election officer shall include, with each ballot mailed to a

1370 provide the last four digits of your license or card number will result in your ballot not being

(5) If the election officer determines that the voter has not yet provided valid voter identification with the voter's voter registration, the election officer may:

(a) mail a ballot to the voter;

(b) instruct the voter to enclose a copy of the voter's valid voter identification in the return envelope; and

(c) provide instructions to the voter on how the voter may sign up to receive electronic ballot status notifications via the ballot tracking system described in Section 20A-3a-401.5.

(6) An election officer who administers an election shall:

(a)(i) before the election, obtain the signatures of each voter qualified to vote in the election; or

(ii) obtain the signature of each voter within the voting precinct from the county clerk; and

(b) maintain the signatures on file in the election officer's office.

(7) Upon receipt of a returned ballot, the election officer shall review and process the ballot

1424 (8) A county that administers an election:

1425 (a) shall provide at least one election day voting center in accordance with Part 7,

1455 (1) This section governs ballots returned by mail, via a ballot drop box, or by other legal

1457 (2) Poll workers shall process return envelopes containing manual ballots that are in the  
1458 custody of the poll workers in accordance with this section.

1459 (3) Poll workers shall examine a return envelope to make the determinations described in  
1460 Subsection (4).

1461 (4) The poll workers shall take the action described in Subsection (5)(a) if the poll workers  
1462 determine:

1463 (a) for an election held before January 1, 2029:

1464 (i) that the return envelope contains the last four digits of the voter's Utah driver

1476 license number, Utah state identification card number, or social security number;  
1477 (ii) if the return envelope does not contain the digits described in Subsection (4)(b)(i),  
1478 that the voter included in the return envelope a copy of the identification described  
1479 in Subsection 20A-3a-204(2)(c)(ii); or  
1480 (iii) for a voter described in Subsection 20A-3a-301(7), that the voter complied with  
1481 Subsection 20A-3a-301(7);

1482 (c) that the affidavit is sufficient;

1483 (d) that the voter is registered to vote in the correct precinct;

1484 (e) that the voter's right to vote the ballot has not been challenged;

1485 (f) that the voter has not already voted in the election; and

1486 (g) for a voter who has not yet provided valid voter identification with the voter's voter  
1487 registration, whether the voter has provided valid voter identification with the return  
1488 envelope.

1489 (5)(a) [If] Subject to Sections 20A-2-508 and 20A-3a-201.5, if the poll workers make all  
1490 of the findings described in Subsection (4), the poll workers shall:

1491 (i) remove the manual ballot from the return envelope in a manner that does not  
1492 destroy the affidavit on the return envelope;  
1493 (ii) ensure that the ballot is not examined in connection with the return envelope; and  
1494 (iii) place the ballot with the other ballots to be counted.

1495 (b) If the poll workers do not make all of the findings described in Subsection (4), the

1505 that the return envelope does not comply with Subsection (4), the election officer

1517 (13), that the signature on the return envelope is not reasonably consistent with the  
1518 individual's signature in the voter registration records, the election officer shall:  
1519 (i) contact the individual in accordance with Subsection (8); and  
1520 (ii) inform the individual:  
1521 (A) that the individual's signature is in question;  
1522 (B) how the individual may resolve the issue; and  
1523 (C) that, in order for the ballot to be counted, the individual is required to deliver  
1524 to the election officer a correctly completed affidavit, provided by the county

(c) The election officer shall ensure that the notice described in Subsection (7)(a) or (b) includes:

- (i) when communicating the notice by mail, a printed copy of the affidavit described in Subsection (7)(d) and a courtesy reply envelope;
- (ii) when communicating the notice electronically, a link to a copy of the affidavit described in Subsection (7)(d) or information on how to obtain a copy of the affidavit; or
- (iii) when communicating the notice by phone, either during a direct conversation with the voter or in a voicemail, arrangements for the voter to receive a copy of the affidavit described in Subsection (7)(d), either in person from the clerk's office, by mail, or electronically.

(d) An affidavit described in Subsection (7)(a)(ii)(C) or (7)(b)(ii)(C) shall include:

- (i) an attestation that the individual voted the ballot;
- (ii) a space for the individual to enter the individual's name, date of birth, and driver license number or the last four digits of the individual's social security number;
- (iii) a space for the individual to sign the affidavit;
- (iv) a statement that, by signing the affidavit, the individual authorizes the lieutenant governor's and county clerk's use of the information in the affidavit and the individual's signature on the affidavit for voter identification purposes; and
- (v) a check box accompanied by language in substantially the following form: "I am a voter with a qualifying disability under the Americans with Disabilities Act that impacts my ability to sign my name consistently. (e) In order for an individual described in Subsection (7)(a) or (b) to have the individual's ballot counted, the individual shall deliver the affidavit described in Subsection (7)(d) to the election officer.

(f) An election officer who receives a signed affidavit under Subsection (7)(e) shall immediately:

- (i) scan the signature on the affidavit electronically and keep the signature on file in the statewide voter registration database developed under Section 20A-2-502;
- (ii) if the election officer receives the affidavit no later than noon on the last business day before the day on which the canvass begins, count the individual's ballot; and

1559 (iii) if the check box described in Subsection (7)(d)(v) is checked, comply with the  
1560 rules described in Subsection (13)(c).

1561 (8)(a) The election officer shall, within two business days after the day on which an  
1562 individual's ballot is rejected, notify the individual of the rejection and the reason for

1578 before the day on which the canvass begins, the election officer:  
1579 (a) receives a signed affidavit from the individual under Subsection (7); or  
1580 (b)(i) contacts the individual;

1599 (10)(a) The election officer shall retain and preserve:

1600 (i) the return envelopes in accordance with Subsection 20A-4-202(2); and  
1601 (ii) the documents described in Subsection (9)(b)(iv) in accordance with Subsection  
1602 20A-4-202(3).

1603 (b) If the election officer complies with Subsection (10)(a)(ii) by including the  
1604 documentation in the voter's voter registration record, the election officer shall make,  
1605 retain, and preserve a record of the name and voter identification number of each  
1606 voter contacted under Subsection (9)(b).

1607 (11)(a) The election officer shall record the following in the database used in the  
1608 verification process:

1609 (i) any initial rejection of a ballot under Subsection (5)(b), within one business day  
1610 after the day on which the election officer rejects the ballot; and  
1611 (ii) any resolution of a rejection of a ballot under Subsection (9), within one business  
1612 day after the day on which the ballot rejection is resolved.

1613 (b) An election officer shall include, in the canvass report, a final report of the  
1614 disposition of all rejected and resolved ballots, including, for ballots rejected, the

1616 (i) the number of ballots rejected because the voter did not sign the voter's ballot; and  
1617 (ii) the number of ballots rejected because the voter's signatures on the ballot, and in

1619 (12) Willful failure to comply with this section constitutes willful neglect of duty under  
1620 Section 20A-5-701.

1621 (13) The director of elections within the Office of the Lieutenant Governor shall make  
1622 rules, in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act, to  
1623 establish:

1624 (a) criteria and processes for use by poll workers in determining if a signature  
1625 corresponds with the signature on file for the voter under Subsection (4)(a)(ii)(A);  
1626 (b) training and certification requirements for election officers and employees of election

1628 (c) in compliance with Title II of the Americans with Disabilities Act of 1990, 42 U.S.C.

1631 (14)(a) Upon request, and subject to Subsections (14)(b) and (c), an election officer may  
1632 disclose the name and address of a voter whose ballot has been rejected and not yet  
1633 resolved with:

1634 (i) a candidate in the election;  
1635 (ii) an individual who represents the candidate's campaign;  
1636 (iii) the sponsors of an initiative or referendum appearing on the ballot; or  
1637 (iv) for a ballot proposition appearing on the ballot, an individual who represents a  
1638 political issues committee, as defined in Section 20A-11-101, if the political  
1639 issues committee supports or opposes the ballot proposition.

1640 (b) If an election officer discloses the information described in Subsection (14)(a), the  
1641 election officer shall:

1642 (i) make the disclosure within two business days after the day on which the request is  
1643 made;  
1644 (ii) respond to each request in the order the requests were made; and  
1645 (iii) make each disclosure in a manner, and within a period of time, that does not  
1646 reflect favoritism to one requestor over another.

1647 (c) A disclosure described in this Subsection (14) may not include the name or address  
1648 of a protected individual, as defined in Subsection 20A-2-104(1).

1651 (1) Each election officer shall ensure that provisional ballot envelopes are printed in  
1652 substantially the following form:

1655 Are you a citizen of the United States of America? Yes No

1656 Will you be 18 years old on or before election day? Yes No

1657 If you checked "no" in response to either of the two above questions, do not complete  
1658 this form.

1659 You must be a United States citizen to vote. If you fail to provide proof of United States  
1660 citizenship, you will only be permitted to vote for federal offices. Information on how to

1661 provide proof of citizenship is included on or with this form.
