LONG TITLE

General Description:

4 This bill amends provisions regarding electric assisted bicycles and other devices.

5 **Highlighted Provisions:**

6 This bill:

- 8 ▶ defines terms;
- 9 ▶ clarifies the definition of motorcycle;
- 10 ▶ makes it unlawful to consume alcohol while operating an electric assisted bicycle;
- 11 ▶ addresses tampering with or modifying equipment on an electric assisted bicycle or
- 12 motorcycle;
- 13 ▶ subjects electric bicycles to impound for violations;
- 14 ▶ requires that individuals under 21 years old shall wear helmets while operating electric
- 15 assisted bicycles on a highway;
- 16 ▶ creates a safety course for the operation of certain electric devices on a highway and
- 17 describes the circumstances under which the course is required; and
- 18 ▶ makes technical changes.

48 Section 1. Section **13-20-2** is amended to read:

49 **13-20-2 (Effective 05/06/26). Definitions.**

50 As used in this chapter:

51 (1) "Consumer" means an individual who enters into an agreement or contract for the
52 transfer, lease, purchase of a new motor vehicle other than for purposes of resale, or
53 sublease during the duration of the period defined under Section 13-20-5.
54 (2) "Manufacturer" means manufacturer, importer, distributor, or anyone who is named as
55 the warrantor on an express written warranty on a motor vehicle.
56 (3) "Motor home" means a self-propelled vehicular unit, primarily designed as a temporary
57 dwelling for travel, recreational, and vacation use.

58 (4)(a) "Motor vehicle" includes:

59 (i) a motor home, as defined in this section, but only the self-propelled vehicle and
60 chassis sold in this state;
61 (ii) a motor vehicle, as defined in Section 41-1a-102, sold in this state; and
62 (iii) a motorcycle, as defined in Section 41-1a-102, sold in this state if the motorcycle
63 is designed primarily for use and operation on paved highways.

64 (b) "Motor vehicle" does not include:

- (i) those portions of a motor home designated, used, or maintained primarily as a mobile dwelling, office, or commercial space;
- (ii) a road tractor or truck tractor as defined in Section 41-1a-102;
- (iii) a mobile home as defined in Section 41-1a-102;
- (iv) any motor vehicle with a gross laden weight of over 14,000 pounds, except:
 - (A) a motor home as defined under Subsection (3); and
 - (B) a farm tractor as defined in Section 41-1a-102;
- (v) a motorcycle, as defined in Section 41-1a-102, if the motorcycle is designed primarily for use or operation over unimproved terrain;
- (vi) an electric assisted bicycle as defined in Section 41-6a-102;
- (vii) a moped as defined in Section 41-6a-102; or
- (viii) a motor assisted scooter as defined in Section 41-6a-102[~~; or~~].
- ~~(ix) a motor-driven cycle as defined in Section 41-6a-102.~~

(5) "Recreational vehicle trailer" means a travel trailer, camping trailer, or fifth wheel trailer.

Section 2. Section **13-35-102** is amended to read:

13-35-102 (Effective 05/06/26). Definitions.

As used in this chapter:

- (1) "Dealership" means a site or location in this state:
 - (a) at which a franchisee conducts the business of a new powersport vehicle dealer; and
 - (b) that is identified as a new powersport vehicle dealer's principal place of business for registration purposes under Section 13-35-105.
- (2) "Department" means the Department of Commerce.
- (3) "Executive director" means the executive director of the Department of Commerce.
- (4) "Franchise" or "franchise agreement" means a written agreement, for a definite or indefinite period, in which:
 - (a) a person grants to another person a license to use a trade name, trademark, service mark, or related characteristic; and
 - (b) a community of interest exists in the marketing of new powersport vehicles, new powersport vehicle parts, and services related to the sale or lease of new powersport vehicles at wholesale or retail.
- (5) "Franchisee" means a person with whom a franchisor has agreed or permitted, in writing or in practice, to purchase, sell, or offer for sale new powersport vehicles manufactured, produced, represented, or distributed by the franchisor.

99 (6)(a) "Franchisor" means a person who has, in writing or in practice, agreed with or
100 permits a franchisee to purchase, sell, or offer for sale new powersport vehicles
101 manufactured, produced, represented, or distributed by the franchisor, and includes:
102 (i) the manufacturer or distributor of the new powersport vehicles;
103 (ii) an intermediate distributor;
104 (iii) an agent, officer, or field or area representative of the franchisor; and
105 (iv) a person who is affiliated with a manufacturer or a representative or who directly
106 or indirectly through an intermediary is controlled by, or is under common control
107 with the manufacturer.

108 (b) For purposes of Subsection (6)(a)(iv), a person is controlled by a manufacturer if the
109 manufacturer has the authority directly or indirectly by law or by an agreement of the
110 parties, to direct or influence the management and policies of the person.

111 (7) "Lead" means the referral by a franchisor to a franchisee of an actual or potential
112 customer for the purchase or lease of a new powersport vehicle, or for service work
113 related to the franchisor's vehicles.

114 (8) "Line-make" means the powersport vehicles that are offered for sale, lease, or
115 distribution under a common name, trademark, service mark, or brand name of the
116 franchisor, or manufacturer of the powersport vehicle.

117 (9) "New powersport vehicle dealer" means a person who is engaged in the business of
118 buying, selling, offering for sale, or exchanging new powersport vehicles either outright
119 or on conditional sale, bailment, lease, chattel mortgage, or otherwise who has
120 established a place of business for the sale, lease, trade, or display of powersport
121 vehicles.

122 (10) "Notice" or "notify" includes both traditional written communications and all reliable
123 forms of electronic communication unless expressly prohibited by statute or rule.

124 (11)(a) "Powersport vehicle" means:
125 (i) an all-terrain type I, type II, or type III vehicle "ATV" defined in Section 41-22-2;
126 (ii) a snowmobile as defined in Section 41-22-2;
127 (iii) a motorcycle as defined in Section 41-1a-102;
128 (iv) a personal watercraft as defined in Section 73-18-2; or
129 [~~(v) except as provided in Subsection (11)(b), a motor-driven cycle as defined in~~
130 ~~Section 41-6a-102; or~~]
131 [~~(vi)~~] (v) a moped as defined in Section 41-6a-102.

132 (b) "Powersport vehicle" does not include:

133 (i) an electric assisted bicycle defined in Section 41-6a-102;
134 (ii) a motor assisted scooter as defined in Section 41-6a-102; or
135 (iii) an electric personal assistive mobility device as defined in Section 41-6a-102.

136 (12) "Relevant market area" means:

137 (a) for a powersport dealership in a county that has a population of less than 225,000:
138 (i) the county in which the powersport dealership exists or is to be established or
139 relocated; and
140 (ii) in addition to the county described in Subsection (12)(a)(i), the area within a
141 15-mile radius from the site of the existing, new, or relocated dealership; or
142 (b) for a powersport dealership in a county that has a population of 225,000 or more, the
143 area within a 10-mile radius from the site of the existing, new, or relocated dealership.

144 (13) "Sale, transfer, or assignment" means any disposition of a franchise or an interest in a
145 franchise, with or without consideration, including a bequest, inheritance, gift, exchange,
146 lease, or license.

147 (14) "Serve" or "served," unless expressly indicated otherwise by statute or rule, includes
148 any reliable form of communication.

149 (15) "Written," "write," "in writing," or other variations of those terms shall include all
150 reliable forms of electronic communication.

151 Section 3. Section **41-6a-102** is amended to read:

152 **41-6a-102 (Effective 05/06/26) (Partially Repealed 07/01/27). Definitions.**

153 As used in this chapter:

154 (1) "Alley" means a street or highway intended to provide access to the rear or side of lots
155 or buildings in urban districts and not intended for through vehicular traffic.

156 (2) "All-terrain type I vehicle" means the same as that term is defined in Section 41-22-2.

157 (3) "All-terrain type II vehicle" means the same as that term is defined in Section 41-22-2.

158 (4) "All-terrain type III vehicle" means the same as that term is defined in Section 41-22-2.

159 (5) "Authorized emergency vehicle" includes:

160 (a) a fire department vehicle;

161 (b) a police vehicle;

162 (c) an ambulance; and

163 (d) other publicly or privately owned vehicles as designated by the commissioner of the
164 Department of Public Safety.

165 (6) "Autocycle" means the same as that term is defined in Section 53-3-102.

166 (7)(a) "Bicycle" means a wheeled vehicle:

- (i) propelled by human power by feet or hands acting upon pedals or cranks;
- (ii) with a seat or saddle designed for the use of the operator;
- (iii) designed to be operated on the ground; and
- (iv) whose wheels are not less than 14 inches in diameter.

(b) "Bicycle" includes an electric assisted bicycle.

(c) "Bicycle" does not include scooters and similar devices.

(a) "Bicycle lane" means a portion of a highway that has been designated by a highway authority through striping, signage, pavement markings, or barriers for the preferential or exclusive use of bicycle, electric assisted bicycle, and motor assisted scooter traffic.

(b) "Bicycle lane" does not include shared lanes intended for both motor vehicle and bicycle travel.

(a) "Bus" means a motor vehicle:

- (i) designed for carrying more than 15 passengers and used for the transportation of persons; or
- (ii) designed and used for the transportation of persons for compensation.

(b) "Bus" does not include a taxicab.

(a) "Circular intersection" means an intersection that has an island, generally circular in design, located in the center of the intersection where traffic passes to the right of the island.

(b) "Circular intersection" includes:

- (i) roundabouts;
- (ii) rotaries; and
- (iii) traffic circles.

(a) "Class 1 electric assisted bicycle" means an electric assisted bicycle equipped with a motor or electronics that:

- [(a)] (i) provides assistance only when the rider is pedaling; and
- [(b)] (ii) ceases to provide assistance when the bicycle reaches the speed of 20 miles per hour.

(b) "Class 1 electric assisted bicycle" does not include a programmable electric assisted bicycle capable of operating as a class 2 electric assisted bicycle or a class 3 electric assisted bicycle.

(a) "Class 2 electric assisted bicycle" means an electric assisted bicycle equipped with a motor or electronics that:

201 [(\u2022)] (i) may be used exclusively to propel the bicycle; and
202 [(\u2022)] (ii) is not capable of providing assistance when the bicycle reaches the speed of
203 20 miles per hour.

204 (b) "Class 2 electric assisted bicycle" does not include a programmable electric assisted
205 bicycle capable of operating as a class 3 electric assisted bicycle.

206 (13)(a) "Class 3 electric assisted bicycle" means an electric assisted bicycle equipped
207 with a motor or electronics that:

208 [(\u2022)] (i) provides assistance only when the rider is pedaling;

209 [(\u2022)] (ii) ceases to provide assistance when the bicycle reaches the speed of 28 miles
210 per hour; and

211 [(\u2022)] (iii) is equipped with a speedometer.

212 (b) "Class 3 electric assisted bicycle" includes a programmable electric assisted bicycle
213 that is capable of operating as a class 3 electric assisted bicycle.

214 (14) "Commissioner" means the commissioner of the Department of Public Safety.

215 (15) "Controlled-access highway" means a highway, street, or roadway:

216 (a) designed primarily for through traffic; and

217 (b) to or from which owners or occupants of abutting lands and other persons have no
218 legal right of access, except at points as determined by the highway authority having
219 jurisdiction over the highway, street, or roadway.

220 (16) "Crosswalk" means:

221 (a) that part of a roadway at an intersection included within the connections of the lateral
222 lines of the sidewalks on opposite sides of the highway measured from:

223 (i)(A) the curbs; or

224 (B) in the absence of curbs, from the edges of the traversable roadway; and

225 (ii) in the absence of a sidewalk on one side of the roadway, that part of a roadway
226 included within the extension of the lateral lines of the existing sidewalk at right
227 angles to the centerline; or

228 (b) any portion of a roadway at an intersection or elsewhere distinctly indicated for
229 pedestrian crossing by lines or other markings on the surface.

230 (17) "Department" means the Department of Public Safety.

231 (18) "Direct supervision" means oversight at a distance within which:

232 (a) visual contact is maintained; and

233 (b) advice and assistance can be given and received.

234 (19) "Divided highway" means a highway divided into two or more roadways by:

235 (a) an unpaved intervening space;

236 (b) a physical barrier; or

237 (c) a clearly indicated dividing section constructed to impede vehicular traffic.

238 (20) "Echelon formation" means the operation of two or more snowplows arranged
239 side-by-side or diagonally across multiple lanes of traffic of a multi-lane highway to
240 clear snow from two or more lanes at once.

241 (21)(a) "Electric assisted bicycle" means a bicycle with an electric motor that:

242 (i) has a power output of not more than 750 watts;

243 (ii) has fully operable pedals;

244 (iii) has permanently affixed cranks that were installed at the time of the original
245 manufacture;

246 (iv) is fully operable as a bicycle without the use of the electric motor; and

247 (v) is one of the following:

248 (A) a class 1 electric assisted bicycle;

249 (B) a class 2 electric assisted bicycle;

250 (C) a class 3 electric assisted bicycle; or

251 (D) a programmable electric assisted bicycle.

252 (b) "Electric assisted bicycle" does not include:

253 (i) a moped;

254 (ii) a motor assisted scooter;

255 (iii) an electric motorcycle;

256 [(iii) (iv) a motorcycle; or

257 [(iv) a motor-driven cycle; or]

258 (v) any other vehicle with less than four wheels that is designed, manufactured,
259 intended, or advertised by the seller to have any of the following capabilities or
260 features, or that is modifiable or is modified to have any of the following
261 capabilities or features:

262 (A) has the ability to attain the speed of 20 miles per hour or greater on motor
263 power alone;

264 (B) is equipped with a continuous rated motor power of more than 750 watts[or
265 greater];

266 (C) is equipped with foot pegs for the operator at the time of manufacture, or
267 requires installation of a pedal kit to have operable pedals; or

268 (D) if equipped with multiple operating modes and a throttle, has one or more

269 modes that exceed 20 miles per hour on motor power alone.

270 (22)(a) "Electric personal assistive mobility device" means a self-balancing device with:

271 (i) two nontandem wheels in contact with the ground;

272 (ii) a system capable of steering and stopping the unit under typical operating
273 conditions;

274 (iii) an electric propulsion system with average power of one horsepower or 750
275 watts;

276 (iv) a maximum speed capacity on a paved, level surface of 12.5 miles per hour; and

277 (v) a deck design for a person to stand while operating the device.

278 (b) "Electric personal assistive mobility device" does not include a wheelchair.

279 (23) "Electric motorcycle" means a motorcycle:

280 (a) powered by an electric motor of more than 750 watts; and

281 (b) capable of exceeding a speed of 20 miles per hour using the power of the electric
282 motor alone.

283 [(23)] (24) "Electric unicycle" means a self-balancing personal transportation device that:

284 (a) has a single wheel;

285 (b) is powered by an electric motor that utilizes gyroscopes and accelerometers to
286 stabilize the rider; and

287 (c) is designed for the operator to face in the direction of travel while operating the
288 device.

289 [(24)] (25) "Explosives" means a chemical compound or mechanical mixture commonly
290 used or intended for the purpose of producing an explosion and that contains any
291 oxidizing and combustive units or other ingredients in proportions, quantities, or
292 packing so that an ignition by fire, friction, concussion, percussion, or detonator of any
293 part of the compound or mixture may cause a sudden generation of highly heated gases,
294 and the resultant gaseous pressures are capable of producing destructive effects on
295 contiguous objects or of causing death or serious bodily injury.

296 [(25)] (26) "Farm tractor" means a motor vehicle designed and used primarily as a farm
297 implement, for drawing plows, mowing machines, and other implements of husbandry.

298 [(26)] (27) "Flammable liquid" means a liquid that has a flashpoint of 100 degrees F. or less,
299 as determined by a Tagliabue or equivalent closed-cup test device.

300 [(27)] (28) "Freeway" means a controlled-access highway that is part of the interstate system
301 as defined in Section 72-1-102.

302 [(28)] (29)(a) "Golf cart" means a device that:

303 (i) is designed for transportation by players on a golf course;
304 (ii) has not less than three wheels in contact with the ground;
305 (iii) has an unladen weight of less than 1,800 pounds;
306 (iv) is designed to operate at low speeds; and
307 (v) is designed to carry not more than six persons including the driver.

308 (b) "Golf cart" does not include:

309 (i) a low-speed vehicle or an off-highway vehicle;
310 (ii) a motorized wheelchair;
311 (iii) an electric personal assistive mobility device;
312 (iv) an electric assisted bicycle;
313 (v) a motor assisted scooter;
314 (vi) a personal delivery device, as defined in Section 41-6a-1119; or
315 (vii) a mobile carrier, as defined in Section 41-6a-1120.

316 [~~(29)~~] (30) "Gore area" means the area delineated by two solid white lines that is between a
317 continuing lane of a through roadway and a lane used to enter or exit the continuing lane
318 including similar areas between merging or splitting highways.

319 [~~(30)~~] (31) "Gross weight" means the weight of a vehicle without a load plus the weight of
320 any load on the vehicle.

321 (32)(a) "High power electric device" means a self-propelled vehicle powered by an
322 electric motor that is capable of traveling more than 20 miles per hour on the power
323 of the electric motor alone.

324 (b) "High power electric device" includes an electric motorcycle.

325 [~~(31)~~] (33) "Hi-rail vehicle" means a roadway maintenance vehicle that is:

326 (a) manufactured to meet Federal Motor Vehicle Safety Standards; and
327 (b) equipped with retractable flanged wheels that allow the vehicle to travel on a
328 highway or railroad tracks.

329 [~~(32)~~] (34) "Highway" means the entire width between property lines of every way or place
330 of any nature when any part of it is open to the use of the public as a matter of right for
331 vehicular travel.

332 [~~(33)~~] (35) "Highway authority" means the same as that term is defined in Section 72-1-102.

333 [~~(34)~~] (36) "Interdicted person" means the same as that term is defined in Section 32B-1-102.

334 [~~(35)~~] (37)(a) "Intersection" means the area embraced within the prolongation or
335 connection of the lateral curb lines, or, if none, then the lateral boundary lines of the
336 roadways of two or more highways that join one another.

337 (b) Where a highway includes two roadways 30 feet or more apart:
338 (i) every crossing of each roadway of the divided highway by an intersecting
339 highway is a separate intersection; and
340 (ii) if the intersecting highway also includes two roadways 30 feet or more apart, then
341 every crossing of two roadways of the highways is a separate intersection.
342 (c) "Intersection" does not include the junction of an alley with a street or highway.

343 [~~(36)~~] (38) "Island" means an area between traffic lanes or at an intersection for control of
344 vehicle movements or for pedestrian refuge designated by:

345 (a) pavement markings, which may include an area designated by two solid yellow lines
346 surrounding the perimeter of the area;
347 (b) channelizing devices;
348 (c) curbs;
349 (d) pavement edges; or
350 (e) other devices.

351 [~~(37)~~] (39)(a) "Lane filtering" means, when operating a motorcycle other than an
352 autocycle, the act of overtaking and passing another vehicle that is stopped in the
353 same direction of travel in the same lane.

354 (b) "Lane filtering" does not include lane splitting.

355 [~~(38)~~] (40)(a) "Lane splitting" means, when operating a motorcycle other than an
356 autocycle, the act of riding a motorcycle between clearly marked lanes for traffic
357 traveling in the same direction of travel while traffic is in motion.

358 (b) "Lane splitting" does not include lane filtering.

359 [~~(39)~~] (41) "Law enforcement agency" means the same as that term is as defined in Section
360 53-1-102.

361 [~~(40)~~] (42) "Limited access highway" means a highway:

362 (a) that is designated specifically for through traffic; and
363 (b) over, from, or to which neither owners nor occupants of abutting lands nor other
364 persons have any right or easement, or have only a limited right or easement of
365 access, light, air, or view.

366 [~~(41)~~] (43) "Local highway authority" means the legislative, executive, or governing body of
367 a county, municipal, or other local board or body having authority to enact laws relating
368 to traffic under the constitution and laws of the state.

369 [~~(42)~~] (44)(a) "Low-speed vehicle" means a four wheeled motor vehicle that:

370 (i) is designed to be operated at speeds of not more than 25 miles per hour; and

371 (ii) has a capacity of not more than six passengers, including a conventional driver or
372 fallback-ready user if on board the vehicle, as those terms are defined in Section
373 41-26-102.1.

374 (b) "Low-speed vehicle" does not include a golfcart or an off-highway vehicle.

375 [~~(43)~~] (45) "Metal tire" means a tire, the surface of which in contact with the highway is
376 wholly or partly of metal or other hard nonresilient material.

377 [~~(44)~~] (46)(a) "Mini-motorcycle" means a motorcycle [~~or motor-driven cycle~~] that has a
378 seat or saddle that is less than 24 inches from the ground as measured on a level
379 surface with properly inflated tires.

380 (b) "Mini-motorcycle" does not include a moped or a motor assisted scooter.

381 (c) "Mini-motorcycle" does not include a motorcycle that is:

382 (i) designed for off-highway use; and

383 (ii) registered as an off-highway vehicle under Section 41-22-3.

384 [~~(45)~~] (47) "Mobile home" means:

385 (a) a trailer or semitrailer that is:

386 (i) designed, constructed, and equipped as a dwelling place, living abode, or sleeping
387 place either permanently or temporarily; and

388 (ii) equipped for use as a conveyance on streets and highways; or

389 (b) a trailer or a semitrailer whose chassis and exterior shell is designed and constructed
390 for use as a mobile home, as defined in Subsection [~~(45)(a)~~] (47)(a), but that is
391 instead used permanently or temporarily for:

392 (i) the advertising, sale, display, or promotion of merchandise or services; or

393 (ii) any other commercial purpose except the transportation of property for hire or the
394 transportation of property for distribution by a private carrier.

395 [~~(46)~~] (48) "Mobility disability" means the inability of a person to use one or more of the
396 person's extremities or difficulty with motor skills, that may include limitations with
397 walking, grasping, or lifting an object, caused by a neuro-muscular, orthopedic, or other
398 condition.

399 [~~(47)~~] (49)(a) "Moped" means a [~~motor-driven cycle~~] motorcycle having:

400 (i) pedals to permit propulsion by human power; and

401 (ii) a motor that:

402 (A) produces not more than two brake horsepower; and

403 (B) is not capable of propelling the cycle at a speed in excess of 30 miles per hour
404 on level ground.

405 (b) If an internal combustion engine is used, the displacement may not exceed 50 cubic
