**LONG TITLE**

**General Description:**

This bill addresses the Colorado River Authority of Utah.

**Highlighted Provisions:**

This bill:

- moves the Colorado River Authority of Utah (authority) from the governor's office to the Department of Natural Resources, including providing a transition;
- modifies the definition provision;
- amends the membership provision of the authority including modifying the appointment process;
- addresses the operation of the authority;
- expands the powers and duties of the authority;
- modifies the appointment of the river commissioner;
- repeals provision prohibiting the river commissioner from receiving compensation;
- amends provision on hiring of the authority's executive director;
- repeals the Colorado River Authority Restricted Account; and
- makes technical and conforming amendments.

**Money Appropriated in this Bill:**

This bill appropriates \$1,638,500 in operating and capital budgets for fiscal year 2027, all of which is from the General Fund.

This bill appropriates (\$1,638,500) in restricted fund and account transfers for fiscal year 2027, all of which is from the General Fund.

**Other Special Clauses:**

This bill provides a special effective date.

92 Section 1. Section **63G-2-305** is amended to read:

93 **63G-2-305 (Effective 07/01/26). Protected records.**

94 The following records are protected if properly classified by a governmental entity:

- 95 (1) trade secrets as defined in Section 13-24-2 if the person submitting the trade secret has  
96 provided the governmental entity with the information specified in Section 63G-2-309;

- 97 (2) commercial information or nonindividual financial information obtained from a person  
98 if:
- 99 (a) disclosure of the information could reasonably be expected to result in unfair  
100 competitive injury to the person submitting the information or would impair the  
101 ability of the governmental entity to obtain necessary information in the future;
- 102 (b) the person submitting the information has a greater interest in prohibiting access than  
103 the public in obtaining access; and
- 104 (c) the person submitting the information has provided the governmental entity with the  
105 information specified in Section 63G-2-309;
- 106 (3) commercial or financial information acquired or prepared by a governmental entity to  
107 the extent that disclosure would lead to financial speculations in currencies, securities, or  
108 commodities that will interfere with a planned transaction by the governmental entity or  
109 cause substantial financial injury to the governmental entity or state economy;
- 110 (4) records, the disclosure of which could cause commercial injury to, or confer a  
111 competitive advantage upon a potential or actual competitor of, a commercial project

118 Subsection (6) does not restrict the right of a person to have access to, after the contract  
119 or grant has been awarded and signed by all parties:
- 120 (a) a bid, proposal, application, or other information submitted to or by a governmental  
121 entity in response to:
- 122 (i) an invitation for bids;
- 123 (ii) a request for proposals;
- 124 (iii) a request for quotes;
- 125 (iv) a grant; or
- 126 (v) other similar document; or
- 127 (b) an unsolicited proposal, as defined in Section 63G-6a-712;
- 128 (7) information submitted to or by a governmental entity in response to a request for  
129 information, except, subject to Subsections (1) and (2), that this Subsection (7) does not  
130 restrict the right of a person to have access to the information, after:

- 131 (a) a contract directly relating to the subject of the request for information has been  
132 awarded and signed by all parties; or
- 133 (b)(i) a final determination is made not to enter into a contract that relates to the  
134 subject of the request for information; and
- 135 (ii) at least two years have passed after the day on which the request for information  
136 is issued;
- 137 (8) records that would identify real property or the appraisal or estimated value of real or  
138 personal property, including intellectual property, under consideration for public  
139 acquisition before any rights to the property are acquired unless:
- 140 (a) public interest in obtaining access to the information is greater than or equal to the  
141 governmental entity's need to acquire the property on the best terms possible;
- 142 (b) the information has already been disclosed to persons not employed by or under a  
143 duty of confidentiality to the entity;
- 144 (c) in the case of records that would identify property, potential sellers of the described  
145 property have already learned of the governmental entity's plans to acquire the  
146 property;
- 147 (d) in the case of records that would identify the appraisal or estimated value of  
148 property, the potential sellers have already learned of the governmental entity's  
149 estimated value of the property; or
- 150 (e) the property under consideration for public acquisition is a single family residence  
151 and the governmental entity seeking to acquire the property has initiated negotiations  
152 to acquire the property as required under Section 78B-6-505;
- 153 (9) records prepared in contemplation of sale, exchange, lease, rental, or other compensated  
154 transaction of real or personal property including intellectual property, which, if  
155 disclosed [~~prior to~~] before completion of the transaction, would reveal the appraisal or  
156 estimated value of the subject property, unless:
- 157 (a) the public interest in access is greater than or equal to the interests in restricting  
158 access, including the governmental entity's interest in maximizing the financial  
159 benefit of the transaction; or
- 160 (b) when prepared by or on behalf of a governmental entity, appraisals or estimates of  
161 the value of the subject property have already been disclosed to persons not  
162 employed by or under a duty of confidentiality to the entity;
- 163 (10) records created or maintained for civil, criminal, or administrative enforcement  
164 purposes or audit purposes, or for discipline, licensing, certification, or registration

- 165 purposes, if release of the records:
- 166 (a) reasonably could be expected to interfere with investigations undertaken for  
167 enforcement, discipline, licensing, certification, or registration purposes;
- 168 (b) reasonably could be expected to interfere with audits, disciplinary, or enforcement  
169 proceedings;
- 170 (c) would create a danger of depriving a person of a right to a fair trial or impartial  
171 hearing;
- 172 (d) reasonably could be expected to disclose the identity of a source who is not generally  
173 known outside of government and, in the case of a record compiled in the course of  
174 an investigation, disclose information furnished by a source not generally known  
175 outside of government if disclosure would compromise the source; or
- 176 (e) reasonably could be expected to disclose investigative or audit techniques,  
177 procedures, policies, or orders not generally known outside of government if  
178 disclosure would interfere with enforcement or audit efforts;
- 179 (11) records the disclosure of which would jeopardize the life or safety of an individual;
- 180 (12) records the disclosure of which would jeopardize the security of governmental  
181 property, governmental programs, or governmental recordkeeping systems from  
182 damage, theft, or other appropriation or use contrary to law or public policy;
- 183 (13) records that, if disclosed, would jeopardize the security or safety of a correctional  
184 facility, or records relating to incarceration, treatment, probation, or parole, that would  
185 interfere with the control and supervision of an offender's incarceration, treatment,  
186 probation, or parole;
- 187 (14) records that, if disclosed, would reveal recommendations made to the Board of  
188 Pardons and Parole by an employee of or contractor for the Department of Corrections,  
189 the Board of Pardons and Parole, or the Department of Health and Human Services that  
190 are based on the employee's or contractor's supervision, diagnosis, or treatment of any  
191 person within the board's jurisdiction;
- 192 (15) records and audit workpapers that identify audit, collection, and operational procedures  
193 and methods used by the State Tax Commission, if disclosure would interfere with  
194 audits or collections;
- 195 (16) records of a governmental audit agency relating to an ongoing or planned audit until  
196 the final audit is released;
- 197 (17) records that are subject to the attorney client privilege;
- 198 (18) records prepared for or by an attorney, consultant, surety, indemnitor, insurer,

- 199 employee, or agent of a governmental entity for, or in anticipation of, litigation or a  
200 judicial, quasi-judicial, or administrative proceeding;
- 201 (19)(a)(i) personal files of a state legislator, including personal correspondence to or  
202 from a member of the Legislature; and
- 203 (ii) notwithstanding Subsection (19)(a)(i), correspondence that gives notice of  
204 legislative action or policy may not be classified as protected under this section;

- 206 (b)(i) an internal communication that is part of the deliberative process in connection  
207 with the preparation of legislation between:

- 229 (24) records of investigations of loss occurrences and analyses of loss occurrences that may  
230 be covered by the Risk Management Fund, the Employers' Reinsurance Fund, the  
231 Uninsured Employers' Fund, or similar divisions in other governmental entities;
- 232 (25) records, other than personnel evaluations, that contain a personal recommendation

- 233 concerning an individual if disclosure would constitute a clearly unwarranted invasion  
234 of personal privacy, or disclosure is not in the public interest;
- 235 (26) records that reveal the location of historic, prehistoric, paleontological, or biological  
236 resources that if known would jeopardize the security of those resources or of valuable  
237 historic, scientific, educational, or cultural information;
- 238 (27) records of independent state agencies if the disclosure of the records would conflict  
239 with the fiduciary obligations of the agency;
- 240 (28) records of an institution of higher education defined in Section 53H-1-101 regarding  
241 tenure evaluations, appointments, applications for admissions, retention decisions, and  
242 promotions, which could be properly discussed in a meeting closed in accordance with  
243 Title 52, Chapter 4, Open and Public Meetings Act, provided that records of the final  
244 decisions about tenure, appointments, retention, promotions, or those students admitted,  
245 may not be classified as protected under this section;
- 246 (29) records of the governor's office, including budget recommendations, legislative  
247 proposals, and policy statements, that if disclosed would reveal the governor's  
248 contemplated policies or contemplated courses of action before the governor has  
249 implemented or rejected those policies or courses of action or made them public;
- 250 (30) records of the Office of the Legislative Fiscal Analyst relating to budget analysis,  
251 revenue estimates, and fiscal notes of proposed legislation before issuance of the final  
252 recommendations in these areas;
- 253 (31) records provided by the United States or by a government entity outside the state that  
254 are given to the governmental entity with a requirement that they be managed as  
255 protected records if the providing entity certifies that the record would not be subject to  
256 public disclosure if retained by it;
- 257 (32) transcripts, minutes, recordings, or reports of the closed portion of a meeting of a  
258 public body except as provided in Section 52-4-206;
- 259 (33) records that would reveal the contents of settlement negotiations but not including final

- 270 (36) materials to which access must be limited for purposes of securing or maintaining the  
271 governmental entity's proprietary protection of intellectual property rights including  
272 patents, copyrights, and trade secrets;
- 273 (37) the name of a donor or a prospective donor to a governmental entity, including an  
274 institution of higher education defined in Section 53H-1-101, and other information  
275 concerning the donation that could reasonably be expected to reveal the identity of the  
276 donor, provided that:
- 277 (a) the donor requests anonymity in writing;
- 278 (b) any terms, conditions, restrictions, or privileges relating to the donation may not be  
279 classified protected by the governmental entity under this Subsection (37); and
- 280 (c) except for an institution of higher education defined in Section 53H-1-101, the  
281 governmental unit to which the donation is made is primarily engaged in educational,  
282 charitable, or artistic endeavors, and has no regulatory or legislative authority over  
283 the donor, a member of the donor's immediate family, or any entity owned or  
284 controlled by the donor or the donor's immediate family;
- 285 (38) accident reports, except as provided in Sections 41-6a-404, 41-12a-202, and 73-18-13;
- 286 (39) a notification of workers' compensation insurance coverage described in Section  
287 34A-2-205;
- 288 (40) subject to Subsections (40)(g) and (h), the following records of an institution of higher  
289 education defined in Section 53H-1-101, which have been developed, discovered,  
290 disclosed to, or received by or on behalf of faculty, staff, employees, or students of the  
291 institution:
- 292 (a) unpublished lecture notes;
- 293 (b) unpublished notes, data, and information:
- 294 (i) relating to research; and
- 295 (ii) of:
- 296 (A) the institution of higher education defined in Section 53H-1-101; or
- 297 (B) a sponsor of sponsored research;
- 298 (c) unpublished manuscripts;
- 299 (d) creative works in process;
- 300 (e) scholarly correspondence; [and]

- 301 (f) confidential information contained in research proposals;
- 302 (g) this Subsection (40) may not be construed to prohibit disclosure of public  
303 information required [~~pursuant to~~] in accordance with Subsection 53H-14-202(2)(a)  
304 or (b); and
- 305 (h) this Subsection (40) may not be construed to affect the ownership of a record;
- 306 (41)(a) records in the custody or control of the Office of the Legislative Auditor General  
307 that would reveal the name of a particular legislator who requests a legislative audit  
308 prior to the date that audit is completed and made public; and
- 309 (b) notwithstanding Subsection (41)(a), a request for a legislative audit submitted to the  
310 Office of the Legislative Auditor General is a public document unless the legislator  
311 asks that the records in the custody or control of the Office of the Legislative Auditor

- 315 (42) records that provide detail as to the location of an explosive, including a map or other  
316 document that indicates the location of:

320 Services created by Section 26B-6-210;
- 321 (44) information contained in the Licensing Information System described in Title 80,  
322 Chapter 2, Child Welfare Services;
- 323 (45) information regarding National Guard operations or activities in support of the  
324 National Guard's federal mission;
- 325 (46) records provided by any pawn or secondhand business to a law enforcement agency or  
326 to the central database in compliance with Title 13, Chapter 32a, Pawnshop, Secondhand  
327 Merchandise, and Catalytic Converter Transaction Information Act;

- 338 (iii) the property of a private person who provides the Division of Emergency

- 340 (49) records of the Department of Agriculture and Food that provides for the identification,
- 341 tracing, or control of livestock diseases, including any program established under Title
- 342 4, Chapter 24, Utah Livestock Brand and Anti-Theft Act, or Title 4, Chapter 31, Control
- 343 of Animal Disease;
- 344 (50) as provided in Section 26B-2-709:
- 345 (a) information or records held by the Department of Health and Human Services related
- 346 to a complaint regarding a provider, program, or facility which the department is
- 347 unable to substantiate; and
- 348 (b) information or records related to a complaint received by the Department of Health
- 349 and Human Services from an anonymous complainant regarding a provider, program,
