LONG TITLE

General Description:

This bill creates a study related to wetland health and protection.

Highlighted Provisions:

This bill:

▸ directs the Department of Natural Resources to:

- complete a study on wetlands in the state;
- make recommendations for legislative and administrative action on improving wetland health and mitigating wetland loss; and
- report the study findings and recommendations to the Natural Resources, Agriculture, and Environment Interim Committee; and

▸ makes technical and conforming changes.

79-2-406, as last amended by Laws of Utah 2024, Chapter 88

Be it enacted by the Legislature of the state of Utah:

Section 1. Section **79-2-406** is amended to read:

79-2-406 . Wetlands study.

(1) As used in this section, "committee" means the Natural Resources, Agriculture, and Environment Interim Committee.

(2) Before October 30, 2027, the department shall complete a study on the status of wetlands in the state.

- 30 (3) The study described in Subsection (2) shall include:
- 31 (a) a determination on how wetland acreage in the state has changed within the previous
- 32 five years;
- 33 (b) any reclassification or potential reclassification of wetlands in the previous five years
- 34 based on changes to federal law;
- 35 (c) the impact of wetland loss on:
- 36 (i) outdoor recreation, including:
- 37 (A) the hunting of duck and other migratory game birds; and
- 38 (B) any loss of recreational opportunities on lakes and rivers in the state;
- 39 (ii) water quality in rivers and lakes adjacent to wetlands; and
- 40 (iii) aquatic species in greatest need of conservation; and
- 41 (d) recommendations for legislative and administration action to:
- 42 (i) improve the health of wetlands in the state; and
- 43 (ii) mitigate wetland loss and degradation.
- 44 (4) The department shall report to the committee:
- 45 (a) before November 30, 2026, a progress report of the study findings and
- 46 recommendations described in Subsection (3); and
- 47 (b) before October 30, 2027, a complete report of the study findings and
- 48 recommendations described in Subsection (3).
- 49 [~~(2) The department shall publish, on the department's website, the land use permits~~
- 50 ~~collected by the Utah Geological Survey pursuant to Subsection 79-3-202(1)(q).]~~
- 51 [~~(3)(a) The department shall study and make recommendations to the committee on the~~
- 52 ~~viability of an in-lieu fee program for wetland mitigation, including:]~~
- 53 [~~(i) the viability of the state establishing and administering an in-lieu fee program; and]~~
- 54 [~~(ii) the viability of the state partnering with a private organization to establish and~~

- 56 [~~(b) As part of the study described in Subsection (3)(a), the department shall consult~~

- 60 [~~(i) the Utah Department of Environmental Quality;]~~
