LONG TITLE

General Description:

This bill exempts sales of Olympic tickets for the 2034 Olympic and Paralympic Winter Games from sales and use tax.

Highlighted Provisions:

This bill:

- exempts sales of Olympic tickets for the 2034 Olympic and Paralympic Winter Games from sales and use tax; and
- makes technical changes.

Be it enacted by the Legislature of the state of Utah:

Section 1. Section **59-12-104** is amended to read:

59-12-104 . Exemptions.

Exemptions from the taxes imposed by this chapter are as follows:

- (1) sales of aviation fuel, motor fuel, and special fuel subject to a Utah state excise tax under Chapter 13, Motor and Special Fuel Tax Act;
- (2) subject to Section 59-12-104.6, sales to the state, its institutions, and its political subdivisions; however, this exemption does not apply to sales of:
 - (a) construction materials except:

- 30 (i) construction materials purchased by or on behalf of institutions of the public
31 education system as defined in Utah Constitution, Article X, Section 2, provided
32 the construction materials are clearly identified and segregated and installed or
33 converted to real property which is owned by institutions of the public education
34 system; and
- 35 (ii) construction materials purchased by the state, its institutions, or its political
36 subdivisions which are installed or converted to real property by employees of the
37 state, its institutions, or its political subdivisions; or
- 38 (b) tangible personal property in connection with the construction, operation,
39 maintenance, repair, or replacement of a project, as defined in Section 11-13-103, or
40 facilities providing additional project capacity, as defined in Section 11-13-103;
- 41 (3)(a) sales of an item described in Subsection (3)(b) from a vending machine if:
- 42 (i) the proceeds of each sale do not exceed \$1; and
- 43 (ii) the seller or operator of the vending machine reports an amount equal to 150% of
44 the cost of the item described in Subsection (3)(b) as goods consumed; and
- 45 (b) Subsection (3)(a) applies to:
- 46 (i) food and food ingredients; or
- 47 (ii) prepared food;
- 48 (4)(a) sales of the following to a commercial airline carrier for in-flight consumption:
- 49 (i) alcoholic beverages;
- 50 (ii) food and food ingredients; or
- 51 (iii) prepared food;
- 52 (b) sales of tangible personal property or a product transferred electronically:
- 53 (i) to a passenger;
- 54 (ii) by a commercial airline carrier; and
- 55 (iii) during a flight for in-flight consumption or in-flight use by the passenger; or
- 56 (c) services related to Subsection (4)(a) or (b);
- 57 (5) sales of parts and equipment for installation in an aircraft operated by a common carrier
58 in interstate or foreign commerce;
- 59 (6) sales of commercials, motion picture films, prerecorded audio program tapes or records,
60 and prerecorded video tapes by a producer, distributor, or studio to a motion picture
61 exhibitor, distributor, or commercial television or radio broadcaster;
- 62 (7)(a) except as provided in Subsection (85) and subject to Subsection (7)(b), sales of
63 cleaning or washing of tangible personal property if the cleaning or washing of the

64 tangible personal property is not assisted cleaning or washing of tangible personal
65 property;

66 (b) if a seller that sells at the same business location assisted cleaning or washing of
67 tangible personal property and cleaning or washing of tangible personal property that
68 is not assisted cleaning or washing of tangible personal property, the exemption
69 described in Subsection (7)(a) applies if the seller separately accounts for the sales of
70 the assisted cleaning or washing of the tangible personal property; and

71 (c) for purposes of Subsection (7)(b) and in accordance with Title 63G, Chapter 3, Utah
72 Administrative Rulemaking Act, the commission may make rules:

73 (i) governing the circumstances under which sales are at the same business location;

75 (ii) establishing the procedures and requirements for a seller to separately account for
76 sales of assisted cleaning or washing of tangible personal property;

77 (8) sales made to or by religious or charitable institutions in the conduct of their regular

96 (B) the item was purchased by a hospital or other medical facility; and

97 (b)(i) Subsection (10)(a) applies to:

- 98 (A) a drug;
99 (B) a syringe; or
100 (C) a stoma supply; and
101 (ii) in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act,
102 the commission may by rule define the terms:
103 (A) "syringe"; or
104 (B) "stoma supply";
105 (11) purchases or leases exempt under Section 19-12-201;
106 (12)(a) sales of an item described in Subsection (12)(c) served by:
107 (i) the following if the item described in Subsection (12)(c) is not available to the
108 general public:
109 (A) a church; or
110 (B) a charitable institution; or
111 (ii) an institution of higher education if:
112 (A) the item described in Subsection (12)(c) is not available to the general public;
113 or
114 (B) the item described in Subsection (12)(c) is prepaid as part of a student meal
115 plan offered by the institution of higher education;
116 (b) sales of an item described in Subsection (12)(c) provided for a patient by:
117 (i) a medical facility; or
118 (ii) a nursing facility; and
119 (c) Subsections (12)(a) and (b) apply to:
120 (i) food and food ingredients;
121 (ii) prepared food; or
122 (iii) alcoholic beverages;
123 (13)(a) except as provided in Subsection (13)(b), the sale of tangible personal property
124 or a product transferred electronically by a person:
125 (i) regardless of the number of transactions involving the sale of that tangible
126 personal property or product transferred electronically by that person; and
127 (ii) not regularly engaged in the business of selling that type of tangible personal
128 property or product transferred electronically;
129 (b) this Subsection (13) does not apply if:
130 (i) the sale is one of a series of sales of a character to indicate that the person is
131 regularly engaged in the business of selling that type of tangible personal property

- 133 (ii) the person holds that person out as regularly engaged in the business of selling

- 160 (ii) uses or consumes the machinery, equipment, normal operating repair or
- 161 replacement parts, or materials:
- 162 (A) in the manufacturing process to manufacture an item sold as tangible personal
- 163 property, as the commission may define that phrase in accordance with Title
- 164 63G, Chapter 3, Utah Administrative Rulemaking Act; or
- 165 (B) for a scrap recycler, to process an item sold as tangible personal property, as

- 166 the commission may define that phrase in accordance with Title 63G, Chapter 3,
167 Utah Administrative Rulemaking Act;
- 168 (b) an establishment, as the commission defines that term in accordance with Title 63G,
169 Chapter 3, Utah Administrative Rulemaking Act, that:
- 170 (i) is described in NAICS Subsector 212, Mining (except Oil and Gas), or NAICS
171 Code 213113, Support Activities for Coal Mining, 213114, Support Activities for
172 Metal Mining, or 213115, Support Activities for Nonmetallic Minerals (except
173 Fuels) Mining, of the 2002 North American Industry Classification System of the
174 federal Executive Office of the President, Office of Management and Budget;
- 175 (ii) is located in the state; and
- 176 (iii) uses or consumes the machinery, equipment, normal operating repair or
177 replacement parts, or materials in:
- 178 (A) the production process to produce an item sold as tangible personal property,
179 as the commission may define that phrase in accordance with Title 63G,
180 Chapter 3, Utah Administrative Rulemaking Act;
- 181 (B) research and development, as the commission may define that phrase in
182 accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act;
- 183 (C) transporting, storing, or managing tailings, overburden, or similar waste
184 materials produced from mining;
- 185 (D) developing or maintaining a road, tunnel, excavation, or similar feature used
186 in mining; or
- 187 (E) preventing, controlling, or reducing dust or other pollutants from mining; or
- 188 (c) an establishment, as the commission defines that term in accordance with Title 63G,
189 Chapter 3, Utah Administrative Rulemaking Act, that:
- 190 (i) is described in NAICS Code 518112, Web Search Portals, of the 2002 North
191 American Industry Classification System of the federal Executive Office of the
192 President, Office of Management and Budget;
- 193 (ii) is located in the state; and
- 194 (iii) uses or consumes the machinery, equipment, normal operating repair or
195 replacement parts, or materials in the operation of the web search portal;
- 196 (15)(a) sales of the following if the requirements of Subsection (15)(b) are met:
- 197 (i) tooling;
- 198 (ii) special tooling;
- 199 (iii) support equipment;

- 200 (iv) special test equipment; or
- 201 (v) parts used in the repairs or renovations of tooling or equipment described in
- 202 Subsections (15)(a)(i) through (iv); and
- 203 (b) sales of tooling, equipment, or parts described in Subsection (15)(a) are exempt if:
- 204 (i) the tooling, equipment, or parts are used or consumed exclusively in the
- 205 performance of any aerospace or electronics industry contract with the United
- 206 States government or any subcontract under that contract; and
- 207 (ii) under the terms of the contract or subcontract described in Subsection (15)(b)(i),
- 208 title to the tooling, equipment, or parts is vested in the United States government
- 209 as evidenced by:
- 210 (A) a government identification tag placed on the tooling, equipment, or parts; or
- 211 (B) listing on a government-approved property record if placing a government
- 212 identification tag on the tooling, equipment, or parts is impractical;
- 213 (16) sales of newspapers or newspaper subscriptions;
- 214 (17)(a) except as provided in Subsection (17)(b), tangible personal property or a product
- 215 transferred electronically traded in as full or part payment of the purchase price,
- 216 except that for purposes of calculating sales or use tax upon vehicles not sold by a
- 217 vehicle dealer, trade-ins are limited to other vehicles only, and the tax is based upon:
- 218 (i) the bill of sale or other written evidence of value of the vehicle being sold and the
- 219 vehicle being traded in; or
- 220 (ii) in the absence of a bill of sale or other written evidence of value, the then existing
- 221 fair market value of the vehicle being sold and the vehicle being traded in, as
- 222 determined by the commission; and
- 223 (b) Subsection (17)(a) does not apply to the following items of tangible personal
- 224 property or products transferred electronically traded in as full or part payment of the
- 225 purchase price:
- 226 (i) money;
- 227 (ii) electricity;
- 228 (iii) water;
- 229 (iv) gas; or
- 230 (v) steam;
- 231 (18)(a)(i) except as provided in Subsection (18)(b), sales of tangible personal
- 232 property or a product transferred electronically used or consumed primarily and
- 233 directly in farming operations, regardless of whether the tangible personal

property or product transferred electronically:

(A) becomes part of real estate; or

(B) is installed by a farmer, contractor, or subcontractor; or

(ii) sales of parts used in the repairs or renovations of tangible personal property or a product transferred electronically if the tangible personal property or product transferred electronically is exempt under Subsection (18)(a)(i); and

(b) amounts paid or charged for the following are subject to the taxes imposed by this chapter:

(i)(A) subject to Subsection (18)(b)(i)(B), machinery, equipment, materials, or supplies if used in a manner that is incidental to farming; and

(B) tangible personal property that is considered to be used in a manner that is incidental to farming includes:

(I) hand tools; or

(II) maintenance and janitorial equipment and supplies;

(ii)(A) subject to Subsection (18)(b)(ii)(B), tangible personal property or a product transferred electronically if the tangible personal property or product transferred electronically is used in an activity other than farming; and

(B) tangible personal property or a product transferred electronically that is considered to be used in an activity other than farming includes:

(I) office equipment and supplies; or

(II) equipment and supplies used in:

(Aa) the sale or distribution of farm products;

(Bb) research; or

(Cc) transportation; or

(iii) a vehicle required to be registered by the laws of this state during the period ending two years after the date of the vehicle's purchase;

(19) sales of hay;

(20) exclusive sale during the harvest season of seasonal crops, seedling plants, or garden, farm, or other agricultural produce if the seasonal crops are, seedling plants are, or garden, farm, or other agricultural produce is sold by:

(a) the producer of the seasonal crops, seedling plants, or garden, farm, or other agricultural produce;

(b) an employee of the producer described in Subsection (20)(a); or

(c) a member of the immediate family of the producer described in Subsection (20)(a);

- (21) purchases made using a coupon as defined in 7 U.S.C. Sec. 2012 that is issued under the Food Stamp Program, 7 U.S.C. Sec. 2011 et seq.;
- (22) sales of nonreturnable containers, nonreturnable labels, nonreturnable bags, nonreturnable shipping cases, and nonreturnable casings to a manufacturer, processor, wholesaler, or retailer for use in packaging tangible personal property to be sold by that manufacturer, processor, wholesaler, or retailer;
- (23) a product stored in the state for resale;
- (24)(a) purchases of a product if:
- (i) the product is:
 - (A) purchased outside of this state;
 - (B) brought into this state:
 - (I) at any time after the purchase described in Subsection (24)(a)(i)(A); and
 - (II) by a nonresident person who is not living or working in this state at the time of the purchase;
 - (C) used for the personal use or enjoyment of the nonresident person described in Subsection (24)(a)(i)(B)(II) while that nonresident person is within the state; and
 - (D) not used in conducting business in this state; and
 - (ii) for:
 - (A) a product other than a boat described in Subsection (24)(a)(ii)(B), the first use of the product for a purpose for which the product is designed occurs outside of this state;
 - (B) a boat, the boat is registered outside of this state; or
 - (C) a vehicle other than a vehicle sold to an authorized carrier, the vehicle is registered outside of this state;
- (b) the exemption provided for in Subsection (24)(a) does not apply to:
- (i) a lease or rental of a product; or
 - (ii) a sale of a vehicle exempt under Subsection (33); and
- (c) in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act, for purposes of Subsection (24)(a), the commission may by rule define what constitutes the following:
- (i) conducting business in this state if that phrase has the same meaning in this Subsection (24) as in Subsection (63);
 - (ii) the first use of a product if that phrase has the same meaning in this Subsection

- (24) as in Subsection (63); or
- (iii) a purpose for which a product is designed if that phrase has the same meaning in this Subsection (24) as in Subsection (63);
- (25) a product purchased for resale in the regular course of business, either in the product's original form or as an ingredient or component part of a manufactured or compounded product;
- (26) a product upon which a sales or use tax was paid to some other state, or one of another state's subdivisions, except that the state shall be paid any difference between the tax paid and the tax imposed by this part and Part 2, Local Sales and Use Tax Act, and no adjustment is allowed if the tax paid was greater than the tax imposed by this part and Part 2, Local Sales and Use Tax Act;
- (27) any sale of a service described in Subsections 59-12-103(1)(b), (c), and (d) to a person for use in compounding a service taxable under the subsections;
- (28) purchases made in accordance with the special supplemental nutrition program for women, infants, and children established in 42 U.S.C. Sec. 1786;
- (29) sales or leases of rolls, rollers, refractory brick, electric motors, or other replacement parts used in the furnaces, mills, or ovens of a steel mill described in SIC Code 3312 of the 1987 Standard Industrial Classification Manual of the federal Executive Office of the President, Office of Management and Budget;
- (30) sales of a boat of a type required to be registered under Title 73, Chapter 18, State Boating Act, a boat trailer, or an outboard motor if the boat, boat trailer, or outboard motor is:
- (a) not registered in this state; and
- (b)(i) not used in this state; or
- (ii) used in this state:
- (A) if the boat, boat trailer, or outboard motor is not used to conduct business, for a time period that does not exceed the longer of:
- (I) 30 days in any calendar year; or
- (II) the time period necessary to transport the boat, boat trailer, or outboard motor to the borders of this state; or
- (B) if the boat, boat trailer, or outboard motor is used to conduct business, for the time period necessary to transport the boat, boat trailer, or outboard motor to the borders of this state;
- (31) sales of aircraft manufactured in Utah;

- (32) amounts paid for the purchase of telecommunications service for purposes of providing telecommunications service;
- (33) sales, leases, or uses of the following:
- (a) a vehicle by an authorized carrier; or
 - (b) tangible personal property that is installed on a vehicle:
 - (i) sold or leased to or used by an authorized carrier; and
 - (ii) before the vehicle is placed in service for the first time;
- (34)(a) 45% of the sales price of any new manufactured home; and
- (b) 100% of the sales price of any used manufactured home;
- (35) sales relating to schools and fundraising sales;
- (36) sales or rentals of durable medical equipment if:
- (a) a person presents a prescription for the durable medical equipment; and
 - (b) the durable medical equipment is used for home use only;
- (37)(a) sales to a ski resort of electricity to operate a passenger ropeway as defined in Section 72-11-102; and
- (b) the commission shall by rule determine the method for calculating sales exempt under Subsection (37)(a) that are not separately metered and accounted for in utility billings;
- (38) sales to a ski resort of:
- (a) snowmaking equipment;
 - (b) ski slope grooming equipment;
 - (c) passenger ropeways as defined in Section 72-11-102; or
 - (d) parts used in the repairs or renovations of equipment or passenger ropeways described in Subsections (38)(a) through (c);
- (39) subject to Subsection 59-12-103(2)(j), sales of natural gas, electricity, heat, coal, fuel oil, or other fuels for industrial use;
- (40)(a) subject to Subsection (40)(b), sales or rentals of the right to use or operate for amusement, entertainment, or recreation an unassisted amusement device as defined in Section 59-12-102;
- (b) if a seller that sells or rents at the same business location the right to use or operate for amusement, entertainment, or recreation one or more unassisted amusement devices and one or more assisted amusement devices, the exemption described in Subsection (40)(a) applies if the seller separately accounts for the sales or rentals of the right to use or operate for amusement, entertainment, or recreation for the assisted

- 371 (c) for purposes of Subsection (40)(b) and in accordance with Title 63G, Chapter 3, Utah
- 372 Administrative Rulemaking Act, the commission may make rules:

- 387 (43)(a) sales made to or by:
- 388 (i) an area agency on aging; or
- 389 (ii) a senior citizen center owned by a county, city, or town; or
- 390 (b) sales made by a senior citizen center that contracts with an area agency on aging;
- 391 (44) sales or leases of semiconductor fabricating, processing, research, or development
- 392 materials regardless of whether the semiconductor fabricating, processing, research, or
- 393 development materials:
- 394 (a) actually come into contact with a semiconductor; or
- 395 (b) ultimately become incorporated into real property;
- 396 (45) an amount paid by or charged to a purchaser for accommodations and services
- 397 described in Subsection 59-12-103(1)(i) to the extent the amount is exempt under

- 399 (46) the lease or use of a vehicle issued a temporary sports event registration certificate in
