3 **General Description:**

4 This resolution promotes strengthening households of married parents with children.

18 *Be it resolved by the Legislature of the state of Utah:*

19 WHEREAS, the bonds between parents and children are fundamental to human

20 development;

21 WHEREAS, humans have a psychological and social need for feelings of belonging, love,

22 and strong familial relationships;

23 WHEREAS, for most individuals, family provides essential support during challenging

24 times;

25 WHEREAS, the global Beijing Declaration and Platform for Action determined that

26 "family is the basic group unit of society," underscoring the family's pivotal role in societal

27 well-being;

29 WHEREAS, according to the National Census, in 1980, 77% of children lived with married
30 parents;

31 WHEREAS, in 2020, nationally, 63% of children lived with married parents;

32 WHEREAS, there is a correlation between the decline in percentage of children living with
33 married parents and the increase in income inequality, the increase in poverty rates, and the
34 decrease in economic mobility;

35 WHEREAS, Archbridge Institute ranks Utah as the best in the nation for social mobility;

36 WHEREAS, investing in career and technical programs provide Utahns greater access to
37 higher-paying jobs, leading to upward mobility and increased family stability;

38 WHEREAS, according to a 2024 United States Department of Health and Human Services
39 report, 80% of Utah households are headed by two parents, compared to 63% nationally;

40 WHEREAS, according to economist Melissa Kearny, the higher percentage of two-parent
41 households is correlated with low poverty rates, high social mobility, and lower income
42 inequality;

43 WHEREAS, findings from the Marriage and Religion Research Institute indicate that
44 children raised by married parents experience better long-term outcomes, such as higher
45 educational attainment, improved emotional well-being, and greater economic stability
46 compared to those raised in single-parent households;

47 WHEREAS, Utah is committed to creating strong families;

48 WHEREAS, Utah promotes the Success Sequence where children are encouraged to
49 complete at least a high school education, obtain full-time work, and marry before having
50 children;

51 WHEREAS, the Success Sequence teaches students the importance of education, financial
52 responsibility, and intact, healthy marriages;

53 WHEREAS, Utah's early-childhood tax credit provides financial relief to families during
54 the early, formative years of a child's life;

55 WHEREAS, Utah is not immune to the national trend of decreasing birthrates and decline
56 of households of married parents with children;

57 WHEREAS, these trends are a cause for concern for the future of Utah children;

58 WHEREAS, Utah code has replaced or removed references to mother, father, person,
59 parent, and family;

60 WHEREAS, many single-parent families find themselves in a less-than-ideal situation
61 when raising children;

62 WHEREAS, single-parent families work diligently and often raise remarkable children

63 despite the hardships they face; and

64 WHEREAS, single-parent families should never be stigmatized:

65 NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah commits
66 to provide children with the greatest opportunities for success in life by prioritizing intact
67 families in legislation language, including maintaining the terms mother, father, person, and
68 parents in Utah code and adding those terms into legislation when possible in order to maintain
69 a state focus on families and to direct attention towards creating strong families for Utah's
70 children.

71 BE IT FURTHER RESOLVED that the Legislature of the state of Utah encourages and
72 promotes two-parent families, strong marriages, and healthy family communication.

73 BE IT FURTHER RESOLVED that the Legislature of the state of Utah promotes career
74 and technical programs, the Success Sequence, and continuing and expanding the
75 early-childhood tax credits to create financial security, upward mobility, and family stability
76 that creates a strong foundation for Utah children.
