Legislative Activities Amendments

LONG TITLE

General Description:

This bill amends provisions related to legislative activities.

Highlighted Provisions:

This bill:

- clarifies that the Legislative Management Committee (LMC) oversees workplace harassment and discrimination policy governance and updates references to that policy;
- modifies LMC's quorum and meeting requirements;
- provides that LMC shall oversee and develop policies governing branch-wide internal administrative matters for the Legislature;
- eliminates certain administrative duties of the presiding officer and the majority and minority leader of each chamber of the Legislature and the chairs of LMC;
- repeals the LMC Subcommittee on Oversight;
- provides that LMC policy governs the general counsel's representation of a legislative client before a court or administrative agency or tribunal;
- reorganizes and amends the legislative general counsel's responsibility to correct technical errors in legislation and the Utah Code;
- eliminates the Legislature's responsibility to print, store, and distribute the Utah Code Annotated;
- repeals a provision governing legislators who attend meetings of the Legislature;
- updates the definition of a legislative procurement unit to include the House of Representatives, the Senate, or a state office of the Legislature;
- repeals certain quinquennial reporting requirements applicable to legislative boards and the Office of Legislative Research and General Counsel;
- provides that the president of the Senate and the speaker of the House of Representatives are vice chairs of the State Capitol Preservation Board (board);

- 29 ▸ directs the board to make rules related to specified activities on capitol hill;
- 30 ▸ provides that the board's authority to make rules to govern, administer, and regulate
- 31 capitol hill does not restrict LMC's authority to adopt policies that govern the legislative
- 32 area;
- 33 ▸ provides that, if there is a conflict between a board rule and an LMC policy governing the
- 34 legislative area, the LMC policy prevails;
- 35 ▸ directs the executive director of the board to notify and consult with the president of the
- 36 Senate and the speaker of the House of Representatives when a person appeals an
- 37 administrative denial of a requested activity in the legislative area;
- 38 ▸ provides that a bill summary by a staff member of the Senate or the House of
- 39 Representatives, or by a staff office for the Legislature, is not evidence of legislative
- 40 intent; and
- 41 ▸ make technical and conforming changes.

67 Section 1. Section **36-11-501** is amended to read:

68 **36-11-501 . Unlawful harassment -- Investigation -- Penalties.**

69 (1) A lobbyist may not engage in conduct that violates:

70 (a) federal workplace discrimination and harassment requirements;

71 (b) [~~Utah Senate or Utah House~~] Legislative Management Committee policies governing
 72 workplace discrimination or harassment;

73 (c) Utah executive branch policies governing workplace discrimination or harassment; or

74 (d) any combination of [~~Subsections~~] Subsection (1)(a), (b), or (c).

75 (2)(a) The lieutenant governor may take an action described in Subsection (3) against a
 76 lobbyist if the lieutenant governor finds, after giving the lobbyist notice and an
 77 opportunity to be heard, that the lobbyist engaged in a serious violation, or multiple
 78 violations, of this section.

79 (b) The lieutenant governor shall post on the lieutenant governor's website a copy of the [
 80 ~~Utah Senate's harassment policy, the Utah House's harassment policy,~~] Legislative
 81 Management Committee's workplace discrimination and harassment policy and the
 82 executive branch's harassment policies.

83 (3) If the lieutenant governor makes a finding described in Subsection (2)(a), the lieutenant
 84 governor may, taking into account the seriousness of the violation or the seriousness or
 85 frequency of multiple violations, do either or both of the following:

86 (a) impose an administrative fine against the lobbyist, not to exceed \$2,000; or

87 (b) suspend the lobbyist's license for a period of up to five years.

88 (4) A record that relates to an investigation under this section is a protected record, to the
 89 extent permitted by Title 63G, Chapter 2, Government Records Access and Management
 90 Act.

91 (5)(a) A lobbyist who is a victim of workplace discrimination or harassment by an
 92 executive worker may file a complaint under the state executive branch's applicable
 93 workplace discrimination and harassment policy.

94 (b) A lobbyist who is a victim of workplace discrimination or harassment by a
 95 legislative worker may file a complaint under the [~~Utah Senate's workplace~~
 96 ~~discrimination and harassment policy or the Utah House's~~] Legislative Management

97 Committee's workplace discrimination and harassment policy.

98 Section 2. Section **36-12-6** is amended to read:

99 **36-12-6 . Permanent committees -- House and Senate management -- Members --**
 100 **Chair -- Legislative Management Committee -- Membership -- Chair and vice-chair --**
 101 **Meetings -- Quorum.**

102 (1) There are hereby established as permanent committees of the Legislature a House
 103 Management Committee and a Senate Management Committee.

104 (a)(i) The House Management Committee shall consist of eight members of the
 105 House of Representatives, four from each major political party. The membership
 106 shall include the elected leadership of the House of Representatives and additional
 107 members chosen at the beginning of each annual general session by the minority
 108 party caucus as needed to complete the full membership.

109 (ii) The chair of the committee shall be the speaker of the House of Representatives
 110 or the speaker's designee.

111 (b)(i) The Senate Management Committee shall consist of eight members of the
 112 Senate, four from each major political party. The membership shall include the
 113 elected leadership of the Senate and additional members chosen at the beginning
 114 of each annual general session by the appropriate party caucus as needed to
 115 complete the full membership.

116 (ii) The chair of the committee shall be the president of the Senate or the president's
 117 designee.

118 (2)(a) There is established a permanent committee of the Legislature known as the
 119 Legislative Management Committee.

120 (b) The committee shall consist of:

121 (i) the members of the House Management Committee; and

122 (ii) the members of the Senate Management Committee.

123 (c)(i) The president of the Senate or the president's designee shall be chair during
 124 1987, and the speaker of the House of Representatives or the speaker's designee
 125 shall be vice-chair of the committee during that year.

126 (ii) The positions of chair and vice-chair of the Legislative Management Committee
 127 shall rotate annually between these two officers in succeeding years.

 135 section, or if a vacancy occurs, a replacement shall be chosen by the leadership of the

144 (4)(a) A quorum of the House Management Committee or the Senate Management
 145 Committee is a majority of the committee's members.

146 (b) A quorum of the Legislative Management Committee is at least 50% of the
 147 committee's members from one chamber and more than 50% of the committee's
 148 members from the other chamber.

149 Section 3. Section **36-12-7** is amended to read:

150 **36-12-7 . Legislative Management Committee -- Duties -- Litigation.**

151 (1) The Senate or House Management Committee shall:

152 (a) receive legislative resolutions directing studies on legislative matters and may assign
 153 these studies to the appropriate interim committee of its chamber;

154 (b) assign to interim committees of the same chamber, matters of legislative study not
 155 specifically contained in a legislative resolution but considered significant to the
 156 welfare of the state;

157 (c) receive requests from interim committees of its chamber for matters to be included
 158 on the study agenda of the requesting committee. Appropriate bases for denying a
 159 study include inadequate funding to properly complete the study or duplication of the
 160 work;

161 (d) establish a budget account for interim committee day as designated by Legislative
 162 Management Committee and for all other legislative committees of its chamber and
 163 allocate to that account sufficient funds to adequately provide for the work of the
 164 committee; and

- 165 (e) designate the time and place for periodic meetings of the interim committees.
- 166 (2) To maximize the use of legislators' available time, the Senate and House Management
167 Committees should attempt to schedule the committee meetings of their respective
168 chambers during the same one or two-day period each month. This does not preclude an
169 interim committee from meeting at any time it determines necessary to complete its
170 business.
- 171 (3)(a) The Legislative Management Committee shall:
- 172 (i) appoint, after recommendation of the appropriate subcommittee of the Legislative
173 Management Committee, without regard to political affiliation, and subject to
174 approval of a majority vote of both chambers, individuals qualified for the
175 positions of director of the Office of Legislative Research and General Counsel,
176 legislative fiscal analyst, legislative general counsel, and legislative auditor
177 general;
- 178 (ii) ~~[develop policies for]~~ oversee branch-wide internal administrative matters for the
179 Legislature, including providing for the establishment of policies governing:
180 (A) personnel management, compensation, and training of all professional
181 legislative staff; and
182 (B) other legislative branch-wide administrative matters;
- 183 (iii) develop a policy within the limits of legislative appropriation for the
184 authorization and payment to legislators of compensation and travel expenses,
185 including out-of-state travel;
- 186 (iv) approve special study budget requests of the legislative directors; and
- 187 (v) assist the speaker-elect of the House of Representatives and the president-elect of
188 the Senate, upon selection by their majority party caucus, to organize their
189 respective chambers of the Legislature and assume the direction of the operation
190 of the Legislature in the forthcoming annual general session.
- 191 (b)(i)(A) An appointment under Subsection (3)(a)(i) is for a six-year term, subject
192 to renewal by a majority vote of the Legislative Management Committee.
- 193 (B) Each renewal is for an additional six-year term and is not subject to approval
194 by the Legislature.
- 195 (ii) The Legislature by a majority vote of both chambers or the Legislative
196 Management Committee by a two-thirds vote may remove an individual appointed
197 under this Subsection (3) before the expiration of the individual's term for such
198 causes as inefficiency, incompetency, failure to maintain skills or adequate

199 performance levels, insubordination, misfeasance, malfeasance, or nonfeasance in
200 office.

201 (c) If a vacancy occurs in a position appointed under this Subsection (3), the Legislative
202 Management Committee shall appoint an individual to fill the vacancy until the
203 Legislature approves or rejects the individual's appointment by a majority vote of
204 both chambers.

205 (4)(a) The Legislature delegates to the Legislative Management Committee the
206 authority, by means of a majority vote of the committee, to direct the legislative
207 general counsel in matters involving the Legislature's participation in litigation.

208 (b) The Legislature has an unconditional right to intervene in a state court action and
209 may provide evidence or argument, written or oral, if a party to that court action
210 challenges:

211 (i) the constitutionality of a state statute;

212 (ii) the validity of legislation; or

213 (iii) any action of the Legislature.

214 (c) In a federal court action that challenges the constitutionality of a state statute, the
215 validity of legislation, or any action of the Legislature, the Legislature may seek to
216 intervene, to file an amicus brief, or to present argument in accordance with federal
217 rules of procedure.

218 (d) Intervention by the Legislature pursuant to Subsection (4)(b) or (c) does not limit the
219 duty of the attorney general to appear and prosecute legal actions or defend state
220 agencies, officers or employees as otherwise provided by law.

221 (e) In any action in which the Legislature intervenes or participates, legislative counsel
222 and the attorney general shall function independently from each other in the
223 representation of their respective clients.

228 **Powers, functions, and duties -- Organization of office -- Selection of director and general**
229 **counsel.**

230 (1) There is established an Office of Legislative Research and General Counsel as a
231 permanent staff office for the Legislature.

232 (2) The powers, functions, and duties of the Office of Legislative Research and General

- 233 Counsel under the supervision of the director shall be:
- 234 (a) to provide research and legal staff assistance to all standing, special, and interim
235 committees as follows:
- 236 (i) to assist each committee chairman in planning the work of the committee;
- 237 (ii) to prepare and present research and legal information in accordance with
238 committee instructions or instructions of the committee chairman;
- 239 (iii) to prepare progress reports of committee work when requested; and
- 240 (iv) to prepare a final committee report in accordance with committee instructions,
241 that includes relevant research information, committee policy recommendations,
242 and recommended legislation;
- 243 (b) to collect and examine the acts and official reports of any state and report their
244 contents to any committee or member of the Legislature;
- 245 (c) to provide research and legal analysis services to any interim committee, legislative
