

Nate Blouin proposes the following substitute bill:

1 **Great Salt Lake Amendments**

2026 GENERAL SESSION

2 **LONG TITLE**

3 **General Description:**

4 This bill addresses funding of programs with the objective of distributing water to the Great  
5 Salt Lake.

7 **Highlighted Provisions:**

8 This bill:

9 ▶ modifies the purposes for which Great Salt Lake Account money may be used for the  
10 acquisition or lease of water or water rights related to the Great Salt Lake; and  
11 ▶ makes technical and conforming amendments.

12 **Money Appropriated in this Bill:**

13 This bill appropriates \$1,500,000 in operating and capital budgets for fiscal year 2027, all  
14 of which is from the General Fund.

15 This bill appropriates \$198,500,000 in restricted fund and account transfers for fiscal year  
16 2027, including:

17 ▶ (\$1,500,000) from General Fund; and  
18 ▶ \$200,000,000 from various sources as detailed in this bill.

19 **Other Special Clauses:**

20 This bill provides a special effective date.

21 **Utah Code Sections Affected:**

22 **AMENDS:**

23 **73-32-304**, as last amended by Laws of Utah 2023, Chapter 208 and renumbered and  
24 amended by Laws of Utah 2023, Chapter 205

26 *Be it enacted by the Legislature of the state of Utah:*

27 Section 1. Section **73-32-304** is amended to read:

28 **73-32-304 . Great Salt Lake Account.**

29 (1) As used in this section[–] :

30 (a) "Mineral" includes a chemical compound that includes an element or mineral.

31 (b) "Mining" means the process of producing, extracting, leaching, evaporating, or  
32 otherwise removing a mineral from a natural deposit of the mineral.

33 (2)(a) There is created within the General Fund a restricted account known as the "Great  
34 Salt Lake Account" consisting of:

35 (i) revenues deposited into the account under Subsection (3);

36 (ii) appropriations from the Legislature; and

37 (iii) interest and other earnings described in Subsection (2)(b).

38 (b) The Office of the Treasurer shall deposit interest and other earnings derived from  
39 investment of money in the account into the account.

40 (3) The Division of Forestry, Fire, and State Lands shall deposit into the account the royalty  
41 income received by the state from mining that occurs on or after July 1, 2022, of a  
42 mineral from the sovereign lands of the Great Salt Lake if during the fiscal year  
43 beginning July 1, 2020, the state did not receive royalty income from the mining of that  
44 same mineral from the sovereign lands of the Great Salt Lake.

45 (4)(a) Upon appropriation by the Legislature, money in the account may be used to:

46 [(a)] (i) manage the water levels of the Great Salt Lake; [and] or

47 [(b)] ~~fund the activities of the commissioner and office under this chapter.]~~

48 (ii) make payments to negotiate agreements, leases, or other means to acquire or lease  
49 water or water rights for the Great Salt Lake.

50 (b) Money deposited into the account under Subsection (2)(a)(ii) or appropriations  
51 transferring money from the Water Infrastructure Restricted Account may only be  
52 used for the purpose outlined in Subsection (4)(a)(ii).

## 53 Section 2. **FY 2027 Appropriations.**

54 The following sums of money are appropriated for the fiscal year beginning July 1,  
55 2026, and ending June 30, 2027. These are additions to amounts previously appropriated for  
56 fiscal year 2027.

### 57 Subsection 2(a). **Operating and Capital Budgets**

58 Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures Act, the  
59 Legislature appropriates the following sums of money from the funds or accounts indicated for  
60 the use and support of the government of the state of Utah.

61 ITEM 1 To Department of Natural Resources - Office of the Great Salt Lake Commissioner  
62 From General Fund

## **Subsection 2(b). Restricted Fund and Account Transfers**

66           The Legislature authorizes the State Division of Finance to transfer the following  
67 amounts between the following funds or accounts as indicated. Expenditures and outlays from  
68 the funds to which the money is transferred must be authorized by an appropriation.

69 ITEM 2 To General Fund Restricted - Great Salt Lake Account

70 From General Fund (1,500,000)

71 From Water Infrastructure Restricted Account, One-time 200,000,000

## 72 Schedule of Programs:

73 Great Salt Lake Account 198,500,000

74 The Legislature intends that the money

75 transferred from the Water Infrastructure Restricted  
76 Account under this Item 2 be used for the acquisition or  
77 lease of water or water rights for the Great Salt Lake as  
78 provided in Subsection 73-32-304(4)(a)(ii).

### Section 3. Effective Date.

80 This bill takes effect on July 1, 2026.
