SECOND EXTRAORDINARY SESSION of the SIXTY-SIXTH LEGISLATURE

The Senate of the Sixty-sixth Legislature of the State of Utah met in the Senate Chamber at the State Capitol Complex and virtually in the Second Extraordinary Session at 4:00 p.m. on Wednesday, May 21, 2025.

PROCLAMATION

Cox, Governor of the State of Utah, by virtue of the authority vested in me by the Constitution and Laws of the State of Utah, do by this Proclamation call the Senate only of the 66th Legislature of the State of Utah into the Second Extraordinary Session at the Utah State Capitol in Salt Lake City, Utah, on the 21st day of May 2025, at 4:00 p.m., for the following purpose:

For the Senate to consent to appointments made by the Governor to positions within state government of the State of Utah since the close of the 2025 General Session of the Legislature of the State of Utah.
