# SEVENTH EXTRAORDINARY SESSION of the SIXTY-FIFTH LEGISLATURE

The Senate of the Sixty-fifth Legislature of the State of Utah met in the Senate Chamber at the State Capitol Complex and virtually in the Seventh Extraordinary Session at 4:00 p.m. on Wednesday, April 17, 2024.

The Senate was called to order at 4:16 p.m. with President J. Stuart Adams presiding.

#### **PROCLAMATION**

WHEREAS, since the close of the 2024 General Session of the 65th Legislature of the State of Utah, certain matters have arisen which require immediate legislative attention; and

WHEREAS, Article VII, Section 6 of the Constitution of the State of Utah provides that the governor may, by proclamation, convene the Senate into Extraordinary Session; and

NOW, THEREFORE, I, Spencer J. Cox, Governor of the State of Utah, by virtue of the authority vested in me by the Constitution and Laws of the State of Utah, do by this Proclamation call the Senate only of the 65th Legislature of the State of Utah into the Seventh Extraordinary Session at the Utah State Capitol in Salt Lake City, Utah, on the 17th day of April 2024, at 4:00 p.m., for the following purpose:

For the Senate to consent to appointments made by the Governor to positions within state government of the State of Utah since the close of the 2024 General Session of the Legislature of the State of Utah.

### COMMUNICATIONS FROM THE DEPARTMENT OF HEALTH AND **HUMAN SERVICES**

Dr. Angelo Giardino, a member of the Compassionate Use Board has vacated his position and the Utah Department of Health and Human Services would like the Utah State Senate to consider voting to confirm Dr. Gary Bosshardt as the new board member.

The purpose of this letter is to request the State Senate's immediate consideration of the confirmation of Dr. Gary Bosshardt to the Board.

Utah Code 26B-1-421(1) establishes the qualifications for Compassionate Use Board membership. They include registration as a qualified medical provider with the Department of Health and Human Services' Center for Medical Cannabis, knowledge about the medicinal use of cannabis, professional licensure in Utah as a physician, and board certification.

Dr. Gary Bosshardt meets the requirements for licensure, board certification, and knowledge of medical cannabis as outlined in the Act. Dr. Gary Bosshardt is a general pediatrician who received his medical degree from the University of Utah School of Medicine. He completed his residency at Penn State Children's Hospital. He is board-certified by the American Board of Pediatrics and holds Fellow status with the American Academy of Pediatrics.

Thank you in advance for your consideration of Dr. Gary Bosshardt as a Board appointee.
