1. **Call to Order**

Chair Buttars called the meeting to order at 2:25 p.m.

2. **Committee Business**

**MOTION:** Rep. Bush moved to approve the minutes of the January 8, 2002 meeting. The motion passed unanimously with Sen. Hickman absent for the vote.

**H.J.R.11 Resolution Requiring Public Notice Prior to Special Sessions (S. Urquhart)**

Rep. Urquhart introduced H.J.R. 11 and explained it to the committee.

Sandy Peck, League of Women Voters, spoke to the bill.

MOTION: Rep. Bush moved to send H.J.R.11 out with a favorable recommendation. The motion passed unanimously with Sen. Hickman absent for the vote.

**H.B.85 Utah Lake Authority Legislative Task Force (G. Way)**

MOTION: Sen Peterson moved to adopt in title and body 1<sup>st</sup> Substitute H.B. 85 - Water Development and Conservation Task Force. The motion passed unanimously with Sen. Hickman absent for the vote.

Rep. Way introduced 1<sup>st</sup> Sub. H.B. 85 and introduced it to the committee. The bill was further explained by Sen. Howard Stephenson.

MOTION: Rep. Winn moved to pass 1<sup>st</sup> Sub. H.B. 85 out favorably to the Rules Committee to be placed on the calendar. The motion passed unanimously with Sen. Hickman absent for the vote.

**H.J.R.9 Joint Resolution - Rejecting Recommended Salary Increase for Legislatures (G. Way)**
