EXPECTED LEGISLATIVE ACTION

The Legislature must approve all regulatory fees annually. (Statutory fees are set in the Utah State Code and do not need annual approval.) Without approval of these fees the state would lose more than \$20,900,000. The fees presented below are a request by the agency and a recommendation by the Analyst. The legislature may change, eliminate or add any fee. After approval by the subcommittee and Executive Appropriations, the fees will be included in a bill for final approval by the entire legislature.
