## **Business, Economic Development & Labor Appropriations Subcommittee**

**AGENCY REQUESTED** Intent Language for Labor Commission, Department of Commerce, and Public Service Commission

February 15, 2011

### Labor Commission

*Under Section 63J-1-603 of the Utah Code the Legislature intends that appropriations to the Industrial Accidents Restricted Account provided for the Utah Labor Commission line item in Item 57 of Chapter 2 Laws of Utah 2010 not lapse at the close of Fiscal Year 2011.*

### Department of Commerce

*Under Section 63J-1-603 of the Utah Code the Legislature intends that unused appropriations provided for the Department of Commerce Division of Public Utilities in Item 61 of Chapter 2 Laws of Utah 2010 lapse to the Professional and Technical Services Fund at the close of Fiscal Year 2011.*

*Under Section 63J-1-603 of the Utah Code the Legislature intends that appropriations provided for the Department of Commerce Division of Public Utilities in Item 61 of Chapter 2 Laws of Utah 2010 from the Professional and Technical Services Fund be nonlapsing at the close of Fiscal Year 2011.*

*Under Section 63J-1-603 of the Utah Code the Legislature intends that unused appropriations provided for the Department of Commerce Committee of Consumer Services in Item 62 of Chapter 2 Laws of Utah 2010 lapse to the Committee's Professional and Technical Services Fund at the close of Fiscal Year 2011.*

*Under Section 63J-1-603 of the Utah Code the Legislature intends that appropriations provided for the Department of Commerce Committee of Consumer Services in Item 62 of Chapter 2 Laws of Utah 2010 from the Professional and Technical Services Fund be nonlapsing at the close of Fiscal Year 2011.*

### Public Service Commission

*Under Section 63J-1-603 of the Utah Code the Legislature intends that appropriations of the Public Utilities Regulatory Fee provided for the Public Service Commission line item in Item 68 of Chapter 2 Laws of Utah 2010 up to \$35,000 not lapse at the close of Fiscal Year 2011.*

## Utah Department of Community and Culture

### Other Intent Language

The Division of State History has reviewed fleet use and has determined one less fleet vehicle is needed for efficient division operations. The number of authorized/appropriated fleet vehicles is reduced from four to three.

### Non-Lapsing Intent Language

1. Under Section 63J-1-402 of the Utah Code, the Legislature intends that any remaining amount of the \$537,800 ongoing General Funds provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 75, for the Department of Community and Culture – Administration line item for digitization not lapse at the close of Fiscal Year 2011.

- 1a. \$145,900 Unit 1122, Information Technology
- 1b. \$391,900 Unit 1140 Administrative Services
- 1c. Totals \$537,800

2. Under Section 63J-1-402 of the Utah Code, the Legislature intends that up to \$97,400 of any remaining amount of the \$671,700 ongoing General Funds provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 75, for the Department of Community and Culture – Executive Director's Office line item not lapse at the close of Fiscal Year 2011. This funding would be used specifically for building lease payments.

3. Under Section 63J-1-402 of the Utah Code, the Legislature intends that up to \$116,900 of any remaining amount of the \$1,228,500 ongoing General Funds provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 75, for the Department of Community and Culture - Administration (Information Technology) line item not lapse at the close of Fiscal Year 2011.

4. Under Section 63J-1-402 of the Utah Code, the Legislature intends that any remaining amount of the \$222,900 ongoing General Funds and \$25,000 Dedicated Credits provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 81, for the Department of Community and Culture - Indian Affairs line item not lapse at the close of Fiscal Year 2011.

5. Under Section 63J-1-402 of the Utah Code, the Legislature intends that any remaining amount of the \$227,000 Dedicated Credits provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 76, for the Department of Community and Culture - Historical Society line item not lapse at the close of Fiscal Year 2011.

6. Under Section 63J-1-402 of the Utah Code, the Legislature intends that any remaining amount of the \$60,000 ongoing General Funds for Fine Arts art acquisitions and \$3,800 ongoing General Funds for Folk Arts art acquisitions provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 78, for the Department of Community and Culture - Division of Arts and Museums line item not lapse at the close of Fiscal Year 2011.

7. Under Section 63J-1-402 of the Utah Code, the Legislature intends that, up to \$274,200, of the \$4,601,800 ongoing General Funds provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 80, for the Department of Community and Culture - State Library Division line item not lapse at the close of Fiscal Year 2011. This amount will temporarily restore reduction to CLEF (Community Library Enhancements Funding) and be used for CLEF grants in FY 2012.

8. Under Section 63J-1-402 of the Utah Code, the Legislature intends that up to \$24,500 of any remaining amount of the \$289,800 ongoing General Funds provided by the Laws of Utah 2010 Chapter 2, State Agency and Higher Education Base Budget, Item 82, for the Department of Community and Culture – Housing and Community Development (Emergency Food Network) line item not lapse at the close of Fiscal Year 2011. This funding would be used specifically for food bank capital improvements.

# Governor's Office of Economic Development

## Non-Lapsing Authority Intent Language Request 2/1/11

### **GOED Administration**

Under Section 63J-1-603 of the Utah Code, the Legislature intends that appropriations provided for the Governor's Office of Economic Development Administrative line item in Item 85 of Chapter 2 Laws of Utah 2010 and Item 189 of Chapter 408 Laws of Utah 2010 not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to business marketing efforts and relocation expenses - \$200,000; and health system reform - \$670,000.

### **GOED Office of Tourism**

Under Section 63J-1-603 of the Utah Code, the Legislature intends that appropriations provided for the Office of Tourism line item in Item 86 of Chapter 2 Laws of Utah 2010 not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to contractual obligations and support - \$350,000, and film incentives - \$5,417,800.

Under Section 63J-1-603 of the Utah Code, the Legislature intends that appropriations provided for the Office of Tourism, Advertising and Promotion program in Item 190 of Chapter 408 Laws of Utah 2010 and Item 119 of Chapter 414 Laws of Utah 2010 not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to advertising and promotion - \$6,950,000.

### **GOED Business Development**

Under Section 63J-1-603 of the Utah Code, the Legislature intends that appropriations provided for the Business Development line item in Item 87 of Chapter 2 Laws of Utah 2010 and Item 81 of Chapter 383 Laws of Utah 2007 not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to Business Cluster support - \$50,000, Centers of Excellence contracts - \$3,000,000, Business Marketing Initiative - \$500,000, International Development contracts and support - \$200,000, Procurement and Technical Assistance Center contracts - \$150,000, Rural Development contracts and support - \$200,000, Corporate Recruitment contracts and support - \$75,000, and relocation expenses - \$400,000.

### **Pete Suazo Utah Athletic Commission**

Under Section 63J-1-603 of the Utah Code, the Legislature intends that appropriations provided for the Pete Suazo Utah Athletic Commission formerly appropriated under the Utah Sports Authority in Item 88 of Chapter 2 Laws of Utah 2010 not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to the Pete Suazo Utah Athletic Program - \$141,200.

## Nonlapsing

### Tax Commission

1. Under Section 63J-1-603 of the Utah Code the Legislature intends that \$72,046,600 appropriations provided for the Utah State Tax Commission in Item 71 Chapter 2, Laws of Utah not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to the costs directly related to the modernization of tax and motor vehicle systems and processes.
2. Under Section 63J-1-603 of the Utah Code the Legislature intends that \$4,562,000 appropriations provided for the Utah State Tax Commission in Item 72 Chapter 2, Laws of Utah not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to license plate production.
3. Under Section 63J-1-603 of the Utah Code the Legislature intends that Electronic Payment Fees appropriations provided for the Utah State Tax Commission in Item 71 Chapter 2, Laws of Utah not lapse at the close of Fiscal Year 2011. The use of any nonlapsing funds is limited to covering costs related to electronic payments.
