Salt Lake County is divided east-and-west, with a complete district from its east boundary to approximately 27th West. The western-third of Salt Lake County forms a second district with Tooele County, southern Davis County, and northern Utah County, which all have commercial, employment, educational, and transportation interests in common with Salt Lake County. The northern district joins the urban counties of Weber and northern Davis with the other northern tier counties from east to west. The southern district joins the remainder of Utah County with the southern tier of counties from east to west.
