ISSUE BRIEF

Summary

The following report details the state agency fees within the Executive Offices and Criminal Justice (EOCJ) Appropriations Subcommittee for FY 2014 pursuant to 63J-1-50. There are two sections: (1) Consolidated Fee Report and (2) Consolidated Fee Change Report. The Consolidated Fee Report lists all fees for agencies within the EOCJ Appropriations Subcommittee. The Consolidated Fee Change report contains only fees that have changed since FY 2013 approved fees and amounts. By statute, all fees not set in statute must be approved by the Subcommittee annually. Fees were submitted to agencies to the Governor's Office of Planning and Budget (GOPB) reviewed and modified where necessary and forwarded to the Office of the Legislative Fiscal Analyst for review and submission to the Subcommittee.
