7 **LONG TITLE**

8 **Committee Note:**

9 The Executive Appropriations Committee recommended this bill.

10 **General Description:**

11 This bill appropriates funds for the support and operation of Higher Education for the fiscal
12 year beginning July 1, 2014 and ending June 30, 2015.

13 **Highlighted Provisions:**

14 This bill:

- 15 ▶ provides appropriations for the use and support of higher education agencies and
16 institutions;
17 ▶ provides appropriations for the use and support of the Utah Medical Education Council;
18 and
19 ▶ provides appropriations for other purposes as described.

20 **Money Appropriated in this Bill:**

21 This bill appropriates \$1,465,863,800 in operating and capital budgets for fiscal year 2015,
22 including:

- 23 ▶ \$442,164,600 from the General Fund;
24 ▶ \$339,865,000 from the Education Fund;
25 ▶ \$683,834,200 from various sources as detailed in this bill.

26 **Other Special Clauses:**

27 This bill takes effect on July 1, 2014.

32 Section 1. **FY 2015 Appropriations.** The following sums of money are appropriated for the
 33 fiscal year beginning July 1, 2014 and ending June 30, 2015.

 35 Utah Code Title 63J, the Legislature appropriates the following sums of money from the funds or
