






Projected H.B. 362 Revenues






Pavement Conditions with and without H.B. 362 funds

Level 2 Condition Forecast with \$10 million/yr




Low-Volume Road Condition Forecast with \$50 million/yr




2015 Roadway Fatalities



2015 Roadway Fatalities by Type








I-15 NB Delay by County (All Day, Every Day)

The Buffer Time Index (BTI) represents the **additional time** drivers need to add to their average travel time to ensure that they arrive at their destination on time 95% of the time.














Average Statewide Snow and Ice Performance (% of acceptable/exceptional road conditions during winter storms)





Pavement Conditions - High-Volume








