

Utah's Charitable Solicitation Act:
Regulation of Charities in Utah

- 1) The Charitable Solicitations Act (Utah Code § 13-22-1 *et seq.*) requires charities to register with the Division of Consumer Protection before soliciting for contributions. There are over 5,000 charities currently registered with the Division.
- 2) To register, a charity must disclose information to the Division, including the charity's purpose, financial information, information about the charity's solicitations and any use of professional fund raisers, legal actions involving key individuals at the charity, and a statement of what percentage of contributions will remain available for the charitable purpose.
- 3) The Division has on its website a list of registered charities and a statement of what percentage of contributions remain available for the charitable purpose.
- 4) The Act prohibits untrue statements and material omissions. (Another statute, the Utah Consumer Sales Practices Act, also prohibits misrepresentations regarding charitable solicitations.)
- 5) The Division investigates violations of the Charitable Solicitations Act. The Division also has the ability to deny, suspend, or revoke a registration. In certain circumstances, the Division can issue fines.
- 6) The Act also provides requirements for professional fund raisers.
