480 receives multiple timely qualified proposals from applicants with the highest and same priority.
(5) If the division leases vacant division-owned property to a private party, the division shall, within 30 days after a lease agreement is executed, provide written notice of the lease to:

(a) the municipality in which the vacant division-owned property is located, if the vacant division-owned property is within a municipality; or

(b) the county in whose unincorporated area the vacant division-owned property is located, if the vacant division-owned property is not located within a municipality.
