DCFS “Aged Out” clients and those who had received public mental health (MH) and/or substance use disorder services (SUD)

- All mental health and substance use disorder services provided by Local Authorities in the Utah public system.
- DCFS “Aged Out” clients for FY16 and FY17 = 329 clients
- Of the 329 DCFS aged out clients, 286 matched back to mental health or substance use disorder services prior to or after their “aged out” date.

Mental Health (MH)

1. % of DCFS clients served in MH services prior to "Age Out Date" - $186/329 = 56.5\%$
2. % of DCFS clients served/carry over in MH services after "Age Out Date" - $86/329 = 26.1\%$
3. % of DCFS clients admitted into MH services after "Age Out Date" - $7/329 = 2.1\%$

Substance Use Disorder (SUD)

1. % of DCFS clients served in SUD services prior to "Age Out Date" - $52/329 = 15.8\%$
2. % of DCFS clients served/carry over in SUD services after "Age Out Date" - $14/329 = 4.3\%$
3. % of DCFS clients admitted in SUD services after "Age Out Date" - $11/329 = 3.3\%$

Combined MH & SUD Services

1. % of DCFS clients served prior to "Age Out Date" - $238/329 = 72.3\%$
2. % of DCFS clients served/carry over after "Age Out Date" - $100/329 = 30.4\%$
3. % of DCFS clients admitted after "Age Out Date" - $18/329 = 5.5\%$
