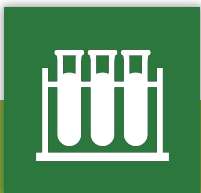


Industrial Hemp, Medical Marijuana, and CBD

Industrial Hemp: Cannabis = **LESS** than 0.3% THC

Medical Marijuana: Cannabis = **MORE** than 0.3% THC

CBD is Cannabidiol: A cannabinoid which comes from the Cannabis plant.
CBD is produced from either Industrial Hemp or Marijuana plant.

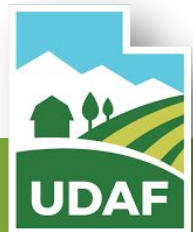

7. Dispensing of Cannabis Products



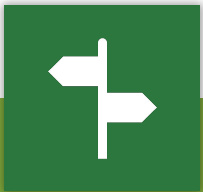
Cannabis Rules Creation

UDAF creating rules for entirely new mandate, following public process with limited capacity.

UDAF Priorities



- First, product registration and industrial hemp
- Next, cultivation, processing, and testing of marijuana

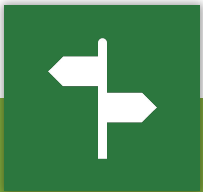

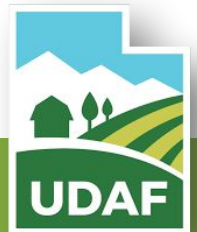
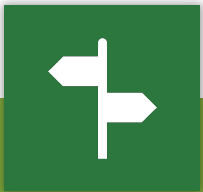


Additional Human Capital

- June 11 - Hired Program Specialist

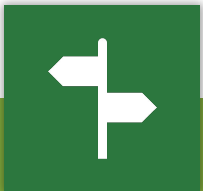

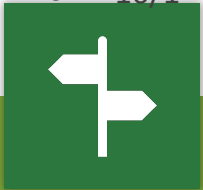


- Pending draft reviews
 - 30 Day Comment period
 - Additional public meetings
 - Likely to have significant public comment requiring revisions and additional public comment
 - Final rules announced



Anticipated Cannabis Rules Timeline

- 4/19 - Public Meetings
- 5/15 - Processor and Product Registration Stakeholder meetings
- May - AG's office begins researching specific legal questions surrounding marijuana
- 5/22 - Cultivation Stakeholder meeting
- 5/29 - Attorney General hires an Attorney specifically for Cannabis
- June - AG's office begins drafting concepts for medical marijuana rules
- 6/11 - UDAF hires Program Specialist
- 9/1 - Internal draft for UDAF and AG's office on Medical Marijuana. Fiscal Analysis begins.
 - Will need assistance from GOMB and DAS on Fiscal Analysis.
- 10/1 - Medical Marijuana rules submitted.
- 10/15 - Rule becomes public and available for comment
 - Public Meetings to be held
- 12/15 - Public Comment closes
- 1/15 - Revised Rule incorporating Public Comment resubmitted
- 2/1 - Revised Rule becomes public and available for comment
 - Public meeting to be held
- 3/1 - Public Comment closes
- 3/15 - Rule published

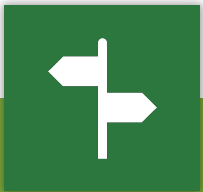

 - Will need assistance from DAS and GOMB

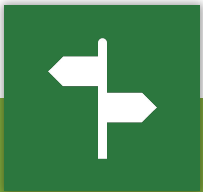
