No new funding currently required:

- Initial Team Set Up of Two Highly Qualified Internal USBE employee
- USBE has the available funding to augment the initial two full time FTEs with additional resources
- Will work closely with LEAs to implement, train, and monitor while simultaneously assuring compliance now and in the future
- A comprehensive and coordinated approach that supports the individual student and their family's interests
- Will provide the USBE periodic updates on progress and will identify and advise on noncompliant LEAs for immediate action
