



# Rebalancing Legislative Workload

Effect of 1<sup>st</sup> Sub. H.B. 387 and H.J.R 22 | February 27, 2019

*This document explains the effect of proposed legislation 1<sup>st</sup> Sub. H.B. 387 “Boards and Commissions Amendments” and H.J.R 22 “Joint Rules Resolution – Boards and Commissions Process Amendments.” It also provides the legislatively appointed members of each affected board or commission.*

## Umbrella Policies

- Requires a piece of legislation that increases legislative workload to receive approval from the Legislative Management Committee (in HJR).
- Requires sunset date to be placed on every newly created board or commission that increases legislative workload (in HJR).
- Requires each executive branch board or commission to submit an annual report to the governor’s office and requires the governor’s office to provide a summary report to the Legislature.
- Requires each legislative branch board or commission to submit an annual report to the OLRGC and requires OLRGC to provide a summary report to the Legislature.
