Vote "NO" on SB187 COUNTY PLANNING AND SERVICES AMENDMENTS

The Association of Community Councils Together (ACCT) is a nonprofit organization made up of 16 Community Councils in Metro Townships, Millcreek and unincorporated Salt Lake County with over 140,000 residents. Those Community Councils include: Big Cottonwood, Canyon Rim, Copperton, East Mill Creek, Emigration Canyon, Granite, Kearns, Magna, Millcreek, Mt. Olympus, Parleys, Sandy Hills, White City, Willow Canyon, and Willow Creek.

We were made aware of SB187 last week.

ACCT opposes SB 187. We have opposed the Mountainous Planning District and Commission since its inception.

ACCT opposes the proposed 3-year extension, of the Mountainous Planning Commission.

As to the language on "fire, paramedic, and police protection services within a municipality", we request an independent review and resolution to be addressed independent of the Mountainous Planning District.

The Emergency Management Funds have been discontinued the same as the Town of Brighton, for several of our communities since their incorporation as Metro Townships.

The mountainous Planning District section of Utah Code should not be leveraged to fund other services.

We support amendment to Salt Lake County funding mechanisms via General Tax Dollars once an area incorporates as independent Municipalities.

On March 6, 2019 the Granite Community Council unanimously passed a resolution opposing the passage of SB 187. The Granite Community Council represents the residents of the unincorporated areas of Salt Lake County residing in Little Cottonwood Canyon and in and around the mouth of the Canyon. The residents of our community who live in Little Cottonwood Canyon are part of the Mountainous Planning District.

SB 187 would extend the sunset date of the Mountainous Planning Commission and it would do so without giving the residents who live in the Mountainous Planning District an opportunity to voice their opinions on the extension of the sunset date

The Granite Community council was not informed of or involved in any of the SB 187 discussions regarding the sunset of the Mountain Planning Commission. It appears that the process used to arrive at SB 187 violates the integrity of our community councils, the very process that guarantees the voice of the people. Our residents know and expect that important issues will be presented to them with adequate time for study and debate. The residents can then support or reject an issue based on the merits.

My request is simple. Withdraw SB 187 from this session. The current sunset date is June of 2020. It the date does need to be extended you can reintroduce the bill in the 2020 session. Please do not allow the role of the community councils to be undermined. Please guarantee that the voice of the local residents and the role of the community councils will be respected and preserved. We work very hard to educate and assure the integrity of the public process and to make sure that local residents are heard. The sunset date of the Mountain Planning Commission does not expire until after next years (2020) legislative session. If you feel there are important reasons to extend the sunset, please send this issue to Interim study so we can participate.
