Incorporation by Reference in Administrative Rulemaking

Discussed with a legislator, the Office of Administrative Rules, and the Governor's Office concerns with:

- incorporation by reference in state administrative rules;
- whether agencies have adopted a uniform approach to incorporation; and
- whether agencies are providing public access to incorporated materials.

Received a [report](#) from staff on the statutory requirements for incorporation by reference and requested that the Office of Administrative Rules provide recommendations for updating the Administrative Rulemaking Act.

R414-22-3 Grounds for Excluding Providers

Discussed with the Department of Health, the Division of Occupational and Professional Licensing, and the Utah Medical Association a rule providing grounds for excluding some healthcare providers from serving Medicaid patients. The Department of Health indicated that it will work on revisions to the rule and present the changes at a future committee meeting.

Blood Alcohol Limit

Reviewed draft legislation that amends provisions of the Workers' Compensation Act by reducing the blood or breath alcohol concentration threshold for certain workers' compensation claims.

Action: *Approved as a committee bill draft legislation, “[Blood Alcohol Limit Amendments](#),” for the 2020 General Session.*

Committee Bill Files

Received an update from committee staff on the status of committee bill files.

Discussed a committee bill opened by the chairs to address the study item Peer-to-Peer Businesses (automotive).

Action: *Voted to open a committee bill file to amend the Workers' Compensation Advisory Council membership to include legislators.*

Mitigation of Evictions for Renters and Landlords

Discussed with the United Way and Clearfield City the consequences of evictions, which includes uprooting children from their schools and financial difficulties for landlords.

Discussed the United Way's 2-1-1 hotline, which provides information and educational resources to help Utah tenants and families in need. An invitation was extended to committee members to join the Promise Partnership Regional Council that will work to identify solutions to mitigate evictions for renters and landlords.

Federalism Commission Overview

Received an [overview](#) from committee staff regarding the responsibilities of the newly created Federalism Commission.

Federalism Index

Utah Valley University [presented](#) the federalism index to the commission.

Review of Work

Discussed the work accomplished by the Federal Funds Commission, the Commission on Federalism, and the Commission for the Stewardship of Public Lands, which were combined in the 2019 General Session to form the Federalism Commission.

Staff discussed the status of contracts previously held by the Commission on Federalism

Action: Adopted two letters related to [local management plans](#) and [lobbying efforts](#) in Washington D.C. drafted by the Commission for the Stewardship of Public Lands.

Action: Voted to assume the contracts previously held by the Commission on Federalism related to work being done by Utah Valley University on the federalism index and by Geomancer on the valuation of federal lands.

Valuation of Federal Lands

Geomancer [presented](#) land valuation work they completed for Washington County.

Action: Voted to authorize the commission chairs to negotiate additional terms of the contract with Geomancer to conduct land valuation work for the entire state of Utah.

Government Operations

Abusive Conduct Reporting

Action: Approved as a committee bill draft legislation, [“Abusive Conduct Reporting Amendments,”](#) which amends provisions related to reporting and investigating abusive conduct between state employees.

By-Mail Voting

Discussed a concept [proposal](#) from county clerks to conduct a comprehensive review of statutes that govern voting methods. The committee discussed redrafting statewide voting statutes to reflect “voter’s choice” practices that are largely used across the state’s counties so that:

- all active voters will be mailed a ballot prior to each election in which they are eligible to vote;
- voters may request that their ballot be sent to an alternate address;
- in-person early voting options will be provided in each county; and
- election day polling places or vote centers will be provided in each jurisdiction and open to any eligible voter.

Congressional Vacancies

Discussed a concept [proposal](#) regarding the process to fill a congressional vacancy. The proposal would create a process that is consistent with current election policies for holding an election to fill a vacancy in the United States House of Representatives. The proposal would also require the governor, when making a temporary appointment to fill a vacancy in the United States Senate, to choose from three candidates nominated by the Legislature.

Action: Voted to open a committee bill file related to the nomination of candidates to fill a vacancy in the United States Senate.

Local Government Disclosure Requirements

Received a [report](#) from the Office of the Lieutenant Governor regarding the number of local candidates that report no campaign contribution or expenditures.

Standardized Petition Policies

Received a [report](#) from county clerks regarding inconsistencies in standards and policies related to the verification process for various types of statutorily required petitions.

Sunset Reviews

Conducted sunset reviews of Title 36, Chapter 31, [Martha Hughes Cannon Statue Oversight Committee](#), and Utah Code Section [11-14-308](#), related to special service district bonds secured by mineral lease.



Action: Voted to open a committee bill file to address extending sunset provisions for special service district bonds that are secured by mineral lease.

Healthcare Costs -- Options for State Policymakers

Received a [report](#) from researchers at the Johns Hopkins University Bloomberg School of Public Health on value-based purchasing as a strategy to reduce the increase in healthcare prices paid by health insurers.

Medicaid Eligibility Expansion -- Implementation Update

Received a [report](#) from the Department of Health on the request for federal waivers to implement the second phase of the Medicaid eligibility expansion that was approved by the Legislature during the 2019 General Session. The department will submit the request following two public hearings in June, with federal approval of the request likely occurring no earlier than September 2019. The first phase of the expansion has increased enrollment by about 30,000.

Opioid Misuse -- Prescribing Guidelines and Practices

Appellate Decisions that Call for Legislative Action

Assessment and Treatment of a Substance Use Disorder

Discussed a concern that some for-profit entities appear to be overtreating low-risk, low-need offenders from the court system and that the treatment might do more harm than good. Proponents of the committee's study of this issue claim that there is a financial conflict of interest for a for-profit entity which both:

- assesses an individual to determine if substance use disorder treatment is necessary; and
- provides the substance use disorder treatment to the individual.

Asset Forfeiture

Discussed draft legislation, "[Asset Forfeiture Changes](#)," which would:

- address grounds for seizing property;



- address custody and control of property;
- require a court to make certain findings before the court can order property to be returned to a person claiming property;
- address jurisdiction for a district court;
- address voiding a forfeiture;
- provide for release of property held for forfeiture on certain grounds;
- change interest requirements;
- modify award provisions under the State Asset Forfeiture Grant program; and
- address forfeiture reporting requirements.

Victim Address Confidentiality

Discussed issues regarding an address confidentiality program for victims of violent crime.

Revenue and Taxation

Income Tax Treatment of Nonresident Wages

Received a [presentation](#) from the State Tax Commission regarding the income tax treatment of nonresident wages. Currently, Utah Code relies upon the formula used to apportion business income to determine what portion of an individual's nonresident income is subject to Utah sales tax. The State Tax Commission recommended that individual nonresident income be allocated proportionately among the states where an individual earns income.

Property Tax Circuit Breaker Tax Relief

Received a [presentation](#) from committee staff regarding the income-based tax relief known as "circuit breaker." Circuit breaker relief is available to individuals who meet certain age, residency, and income requirements and includes a:

- homeowner valuation reduction for property tax;
- homeowner's credit; and
- renter's credit.

Sales Tax Sourcing

Received a [presentation](#) from the State Tax Commission explaining how the point of sale of a transaction is determined for local option sales tax purposes. The presentation noted that current statute is silent regarding the sourcing of online motor vehicle transactions. The State Tax Commission recommended that online motor vehicle purchases be sourced by destination.

Tax Commission Property Tax Authority

The committee discussed draft legislation, "[Tax Commission Authority Amendments](#)," which repeals the State Tax



Commission's authority to adjust or defer taxes levied against property assessed by the State Tax Commission.

Tax Restructuring and Equalization

Received a brief update from a member of the Tax Restructuring and Equalization Task Force regarding the work of the task force since its formation, which includes adopting a vision, process, and set of principles and scheduling a series of town hall meetings across the state over the next six weeks.
