- 8:47 **3. Limited Family Services for Low Income Individuals – Sunset Review**  
*Utah Code Subsection 26-18-417(3), is [scheduled](#) for repeal July 1, 2020, unless reauthorized by the Legislature. The subsection requires reporting to the Legislature if a waiver or state plan amendment is approved to permit coverage of family planning services for individuals who are not otherwise eligible for Medicaid and are below the federal poverty level. The need for a waiver or state plan amendment was reduced with the initial implementation of [2019 S.B. 96, Medicaid Expansion Adjustments](#), which expanded Medicaid eligibility, under certain conditions, to all individuals below the federal poverty level.*

## 7. Prescriber Education

*The committee will review the implementation of policies designed to identify and offer education to prescribers who may not be prescribing opioids or other controlled substances in accordance with best practice guidelines.*

### Background

- In 2018, the Division of Occupational and Professional Licensing was charged with reviewing its controlled substance database to “identify any prescriber who has a pattern of prescribing opioids not in accordance with the recommendations of: (i) the CDC Guideline for Prescribing Opioids for Chronic Pain...; (ii) the Utah Clinical Guidelines on Prescribing Opioids for Treatment of Pain...; or (iii) [certain] other publications describing best practices related to prescribing opioids...” The division was also charged with offering education regarding best practices to prescribers so identified. In 2019, the division was charged with offering educational visits to practitioners who may have prescribed a controlled substance to an overdose or poisoning victim.
