
CHAP: Children's Hearing Aid Program

### Background:

H.B. 157 (2013 General Session) UCA 26-10-11, whose Chief Sponsor was Representative Rebecca P. Edwards, created a two-year pilot program within the Department of Health to provide hearing aids to qualifying children under three years of age who have hearing loss.

H.B. 16 (2015 General Session), CHAP was converted from a pilot program to a permanent program.

### **Eligibility Guidelines:**

- Younger than six years of age
- Have hearing loss diagnosed by an audiologist with pediatric expertise
- Medical clearance by a physician
- Utah resident
- Family income < 300% FPG
- Cannot be Medicaid eligible
- Cannot have private insurance that covers the total cost of hearing aids



### CHAP follows national BEST PRACTICE guidelines:

- Early diagnosis, fitting of amplification, and timely follow-up by an audiologist with pediatric expertise
- Medical clearance by physician
- Enrollment in early intervention if child is under 3 years of age
- Timely follow up with managing audiologist
- Parents agree to maintain routine care of hearing aids and overall hearing healthcare

### Early Intervention (EI) Information

- 100% of CHAP recipients under 3 years of age are enrolled in EI
- 138 participants were under 3 years when they applied





### <u>Specifics</u>

- 11 families had 2 or more children with hearing loss that received assistance from CHAP
- 45.5% have a comorbid condition










# **Program Benefits of Early Amplification**

 The greater the potential for typical speech and language development, social skills, academic achievement, and future vocational skills

The greater the savings associated with special education

costs (approximately \$112,000 for 12 years of services)

 The greater the savings for significant costs associated with the potential need for long term social and vocational services
