- Operation Recovery OTP- 173 intakes in past 12 months- 60 daily doses 25-30 MONTHLY Vivitrol shots and other MAT
- Daily Van Transportation to MAT (Medication Assisted Treatment) We have NO Public Transportation
- We Created Safe and Sober Living for local women and children
- **SUPeRAD-**Program for opioid dependent pregnant women to engage, stabilize and restore both mom and baby to good health. This program includes MAT, behavioral health care, maternal education, social support services, prenatal education classes, sober living and life coaching.
- Open Access-same day or next day assessments help during the "window of opportunity"
- Jail Evaluations/Assessments-to keep folks from falling off cliff when released
- MAT in Jail- YAY Carbon County!
- UROHC- Rural Opioid Health Care Consortium-engaging health care providers to increase resources, reduce stigma.
- SAMHSA MAT Grant-\$500,000 per year for 3 years to help pay for Operation Recovery MAT program

- **Prevention Campaign-** opioid prevention efforts at Four Corners Community Behavioral Health have included :National Drug Take Back Days twice a year, "Use Only As Directed", partnering with the local health department on National Overdose Awareness Day as well as Recovery Day. This campaign targets all community members and promotes how to have conversations with Primary Care Providers to prevent opioid addiction, as well as using medication only as directed. Partnership with our local Family Support Center to provide in-home visits for at-risk families using the Parents as Teachers Evidence-Based Model to reduce risk factors and prevent opioid use.
