

Overview

- Currently, no easy way for most Utah patients and providers to find the price of or expected payment amount for healthcare procedures before receiving care
- OSA started working on a transparency project October 2018







Legislation

• 2019 General Session

OSA commissioned to create a public-facing tool that "...present[s] health care price information for consumers in a way that is clear and accurate." (Utah Code 67-3-11)

• OSA understands 'price' to represent the (total) amount paid for a procedure





Approach



- Studied methodologies and cost tools from other states and organizations

Methodology

- Data comes from the All-Payer Claims Database (APCD)
 - Includes data from June 1, 2016 December 31, 2017
- Dataset excludes Medicaid and Medicare data
- Removed outliers
 - Excluded top/bottom 5% of claims for each provider
 - Excluded providers with a low frequency (≤ 10) of a given procedure
 - Excluded providers with a median price < 25% the average median price



Methodology

- Payment amount includes plan-paid, prepaid, copay, coinsurance, and deductible amounts
- Bundled claims for surgical and imaging procedures to find the total payment amount for the encounter
- Contacted providers for feedback on methodology
- Allow providers opportunity to review their associated analysis

Initial Results Large disparities in procedure payment amounts

Urine Analysis Procedure

- Lowest payment provider: \$2
- Highest payment provider: \$77

Hip Replacement Procedure

- Lowest payment provider: \$23,216
- Highest payment provider: \$42,347





- Full completion (analysis completed and providers contacted):
 - Knee Replacement (27447)
 - Colonoscopy (45380)
 - Urine Analysis (81000-81003)
 - Established patient office visit (99211-99215)
- Analysis completed for over 150 procedures
- Includes:
 - Simple procedures (e.g. office visit)
 - More complex procedures that require bundling claims (e.g. knee replacement)
