Considerations for Committee Draft Legislation | October 16, 2019 | v2

The first phase of the Government Operations Interim Committee's draft legislation "Executive Boards and Commissions Amendments" is aimed at placing sunset provisions on all appropriate executive boards and commissions. In its Augustin meeting, the committee considered 294 of the 394 existing executive boards and commissions with regards to the execution of the first phase and considerations for the next phase of the draft legislation. This document contains considerations for the remaining 100 executive boards and commissions regarding the first and next phases of the draft legislation.
