Title & Responsible Party	Purpose

Student Growth Percentile (SGP) Across Transition & Impact The Center for Assessment	Determine ability to validly calculate student growth with removal of writing and change in assessments
USBE/LEA Achievement Study USBE, Jordan, & Salt Lake City School Districts	Examine differences in achievement outcomes to prior years to determine impacts of all irregularities

## **Review Process Timeline**

Assessment and Accountability Policy Advisory Committee September 10, 2019

Utah State Board of Education Oct 3, 2019 Identification of schools in need of improvement (Turnaround) December 2019?

September 11 & 12, 2019 Technical Advisory Committee December 2019? Publication of School Report Card



## **Summary Recommendations**

- Based on Utah's Assessment and Accountability and Technical Advisory Committees along with the Center for Assessment, USBE assessment/accountability specialists, and local experts
- USBE review of the set of comprehensive analyses
  - Interruption study
  - Growth analyses
  - Scale score analyses
- Based on these analyses, <u>all of the groups</u> noted above <u>recommend moving ahead</u> with accountability calculations for 2018-2019.



### **USBE Motion**

- 1. Publish the 2018-2019 RISE results
- Direct staff to engage with legislators to <u>identify</u> <u>flexibilities from state accountability</u> requirements, including assignment of the letter grade and identifying schools for improvement
- 3. Include a disclaimer on the school accountability/report card (dashboard) indicating that interruptions occurred during testing

# Office of the Legislative Auditor General – Limited Review of RISE Testing Issues

- Surveyed 90 LEA Leaders
- 82 responded to the survey
- 74 of those or 91% reported their LEA was either significantly or moderately <u>negatively impacted</u> by "Questar's testing issues"

The following slide contains the description of the negative impacts



#### Negative Impacts for Students, Teachers, Data, and Time

- "Lost instructional time"
- "Additional work for LEA employees"
- "Inability for LEA employees to complete testing responsibilities"
- "Negative impact on student and staff morale"
- "Strained testing environments"
- "Lack of confidence in the data"



#### **Student Mitigation**

#### 53G-4-303(4)(b) Utah Standards Assessment

A teacher may use a student's score on the standards assessment... to <u>improve</u> the student's academic grade for or demonstrate the student's competency within a relevant course.



# **Possible School Mitigation – State Accountability**

## School Report Card

- Publish Report Cards with no letter grade and a disclaimer about this year's testing irregularities requires Statutory change
- State Turnaround
- Establish a criteria to ensure schools are not erroneously identified for State Turnaround based on testing irregularities such as % of incomplete tests and missing participation codes – does not require Statutory change



# 2019/2020 RISE Status

The test administration window opened on October 1, 2019 for Benchmark & Interim RISE assessments

- 58 LEA's have teachers who have already utilized these productivity tools
- 10,456 Interim RISE assessments have been administered
- 38,278 Benchmark RISE assessment have been administered

No delivery dates have been missed and no significant customer service issues have arisen. The delivery system is working as expected.



#### **Questar Contract Resolution**

- USBE is on track for mediation to resolve the dispute
- This could be completed within the next few months
