Enacts a sales and use tax exemption for equipment purchased by companies performing oil and gas extraction, pipeline transportation, and electrical generation.

Implement the sales and use tax exemption. Simultaneously assume no effect on state government spending.

SCENARIO 2: IMPLEMENT THE SALES AND USE TAX EXEMPTION AND ASSUME SLOWER STATIC GROWTH IN STATE/LOCAL GOVERNMENT SPENDING

Implement the sales and use tax exemption. Simultaneously assume state government spending does not grow as fast as it otherwise would.

SCENARIO 3: IMPLEMENT THE SALES AND USE TAX EXEMPTION, SLOWER STATIC GROWTH IN STATE/LOCAL GOVERNMENT SPENDING, AND STRONGER PRIVATE SECTOR RESPONSE

Implement the sales and use tax exemption. Simultaneously assume state government spending does not grow as fast as it otherwise wold. Assume the sales and use tax exemption has a stronger response due to a stronger competitive market position. This stronger response shows up as an initial assumed increase in employment of 350.
