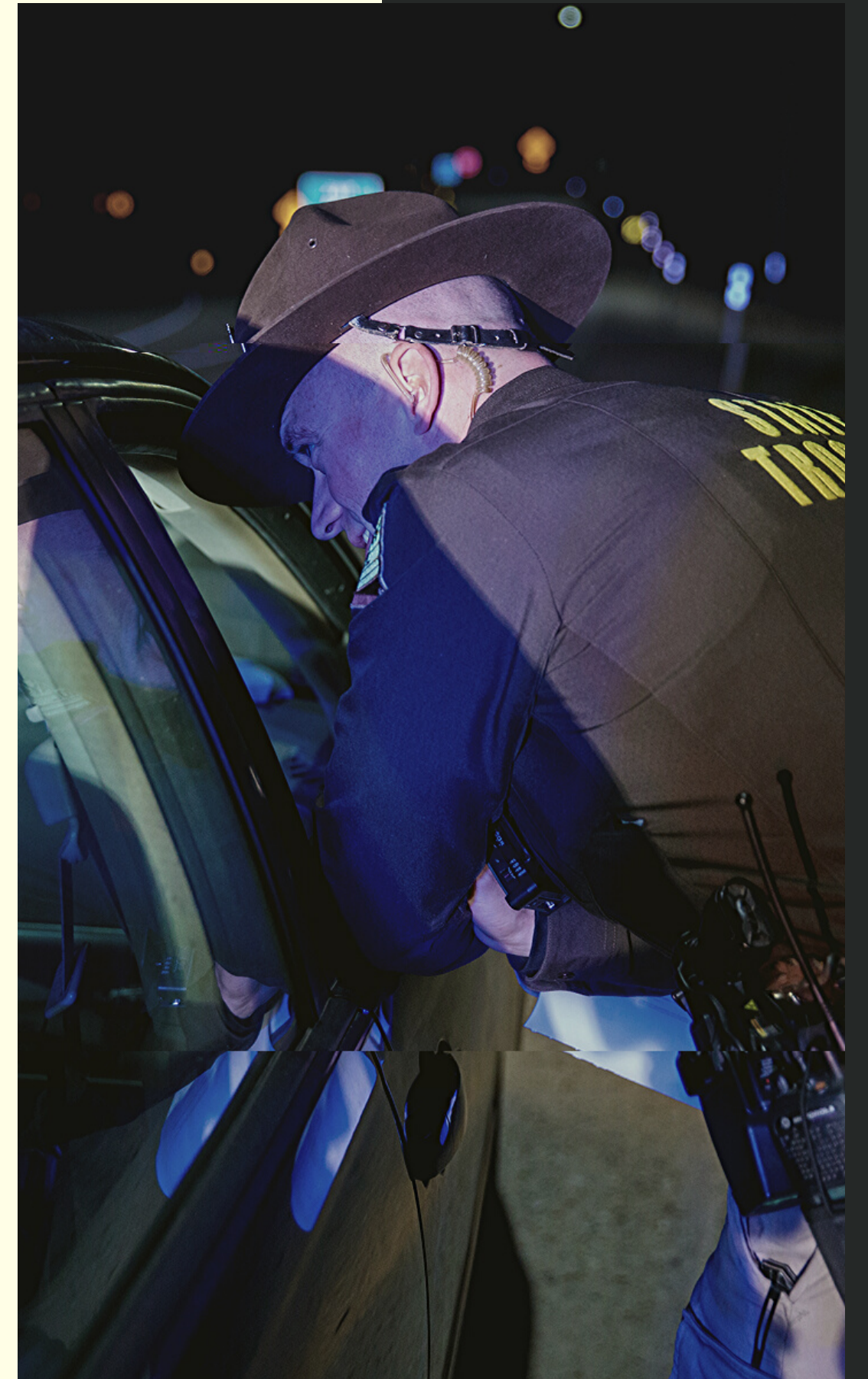

Looking to the Future

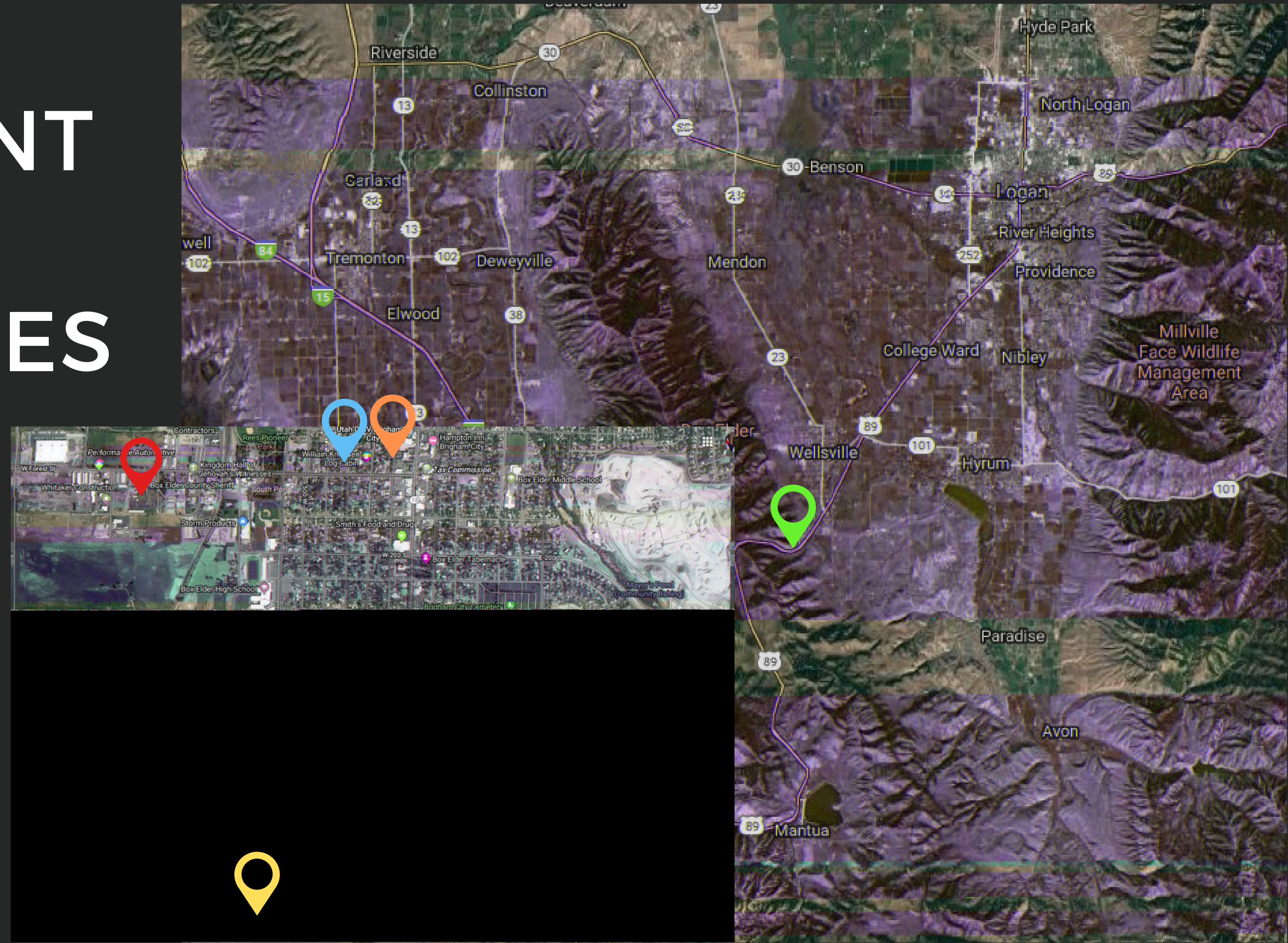
The Department of Public Safety needs a new facility to house four critical divisions serving Box Elder and Cache Counties.

Utah Highway Patrol
DPS 911 Communications
Driver License Division
State Fire Marshal

The proposed building will be located on 12 acres of property owned by DFCM, located in Brigham City.



CURRENT DPS FACILITIES



LOCATION ISSUES

CACHE COUNTY UHP "OFFICE"

UHP's Logan troopers are working from a mobile "mini" unit located behind the UDOT shed near Hyrum.

**Previous lease was not renewed in 2016.*





BRIGHAM CITY UHP OFFICE

- *Troopers are working from a converted residential space.*
- *Concerns include: Poor access to freeway, future of lease, adequate space & security.*



DISPATCH NEEDS

Professional dispatch center to meet current and future needs of the public and multiple agencies who utilize DPS 911 Communications.

OTHER PATROL NEEDS

The proposed new office would include a built-in evidence storage facility, a formal interview room, and a secured controlled entry/sally port. Ability to accommodate current and future staff.





DRIVER LICENSE NEEDS

Additional space for expansion of services and to better serve the growing needs of the public. DLD also requires an appropriate area for commercial driver license and motorcycle testing, to remain a full service facility into the future.

LONG TERM CONSIDERATIONS

POPULATION GROWTH

The new building would reduce strain on each division with the continued population growth, which is expected to grow 30% by 2030.

INCREASED NEED FOR SERVICES

10%-30% immediate and future growth to meet public safety demands. This includes law enforcement, investigation services, immediate need for six 911 communications consoles with expansion to eight consoles, and DLD testing services.

CURRENT LOCATIONS

Divisions are occupying temporary and inadequate space that will be reassigned by building owners.

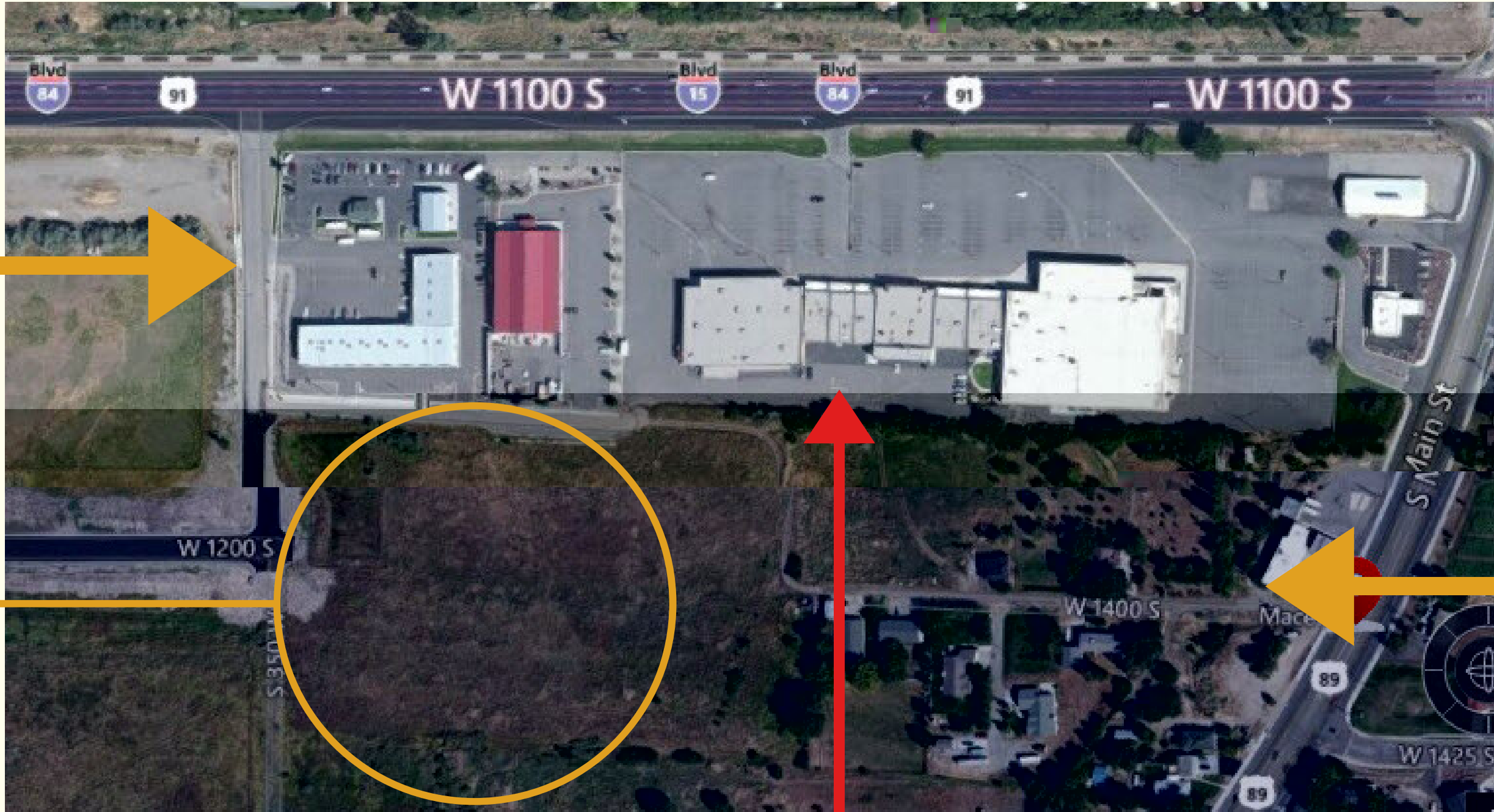
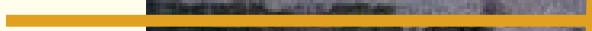


Future DPS Building

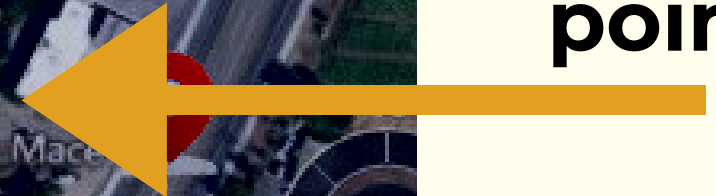
Easy access and dispatch points

Results of 2018 Feasibility Study

The study found the project is appropriate and supports efficient use of taxpayer dollars, consolidates services, and utilizes DFCM-owned property more effectively to serve the surrounding communities needs.

PROJECT BUDGET



TOTAL COST OF PROJECT: \$9,575,678
(\$551.91 COST/SQ.FT.)

\$7.5 MILLION

LEGISLATIVE REQUEST

DFCM currently has \$2,050,000 remaining appropriations for this project.

DPS is requesting \$7,525,678 in additional funding.

Annual O&M costs=\$109,634.50 (covered within DPS budget)





ONE DPS FACILITY

All DPS public services will be consolidated in one DFCM-owned building, rather than five separate facilities, maximizing efficiency in space and services provided.

This will also accommodate the need for immediate and future expansion within each division.
