H.B. 182

1. Page 4, Lines 93 through 97:

93 (5) (a) A person who violates Subsection (1) is guilty of an infraction and shall be

94 fined:

- 95 (i) not less than {~~\$400~~} \$50 for a violation; or
96 (ii) not less than {~~\$950~~} \$100 for a second or subsequent violation within three years of a
97 previous violation of this section.
