298 "contributor" means a person who has donated or in whose name at least \$35 has been donated
299 at the time of application and annually thereafter.

2. Page 12, Lines 342 through 345:

342 (4) Veterans license plates shall display one of the symbols representing the Army,
343 Navy, Air Force, Marines, Coast Guard, or American Legion.
344 Section 4. Effective date.
345 This bill takes effect on October {~~1~~ 15, 2020.
