Background

This document compiles statutory provisions that are scheduled to repeal between January 2021 and January 2022. Provisions under Title 63I, Chapter 2, Repeal Dates by Title Act, do not require a review. Without legislative action in the 2021 General Session, the provisions listed below will repeal on the date specified.
