**Funding Requests:** Legislator requests must be submitted to the Office of the Legislative Fiscal Analyst by noon on Friday, January 29th. The chairs ask that requestors of funding provide: 1) a detailed and itemized budget indicating how they would spend the money within the specified timeframe, and 2) how they would measure success. Requestors without this information will be asked to return once they provide it. All appropriations must be made to state agencies. State agencies must follow state procurement laws which require competitive bids, requests for proposal, or sole source determination.
