6. Sunset Review – Required Agency Consultation for Awarding of Mobile Crisis Outreach Teams (10 minutes)

Utah Code Subsections 62A-15-116(1) and (5) are scheduled for repeal January 1, 2023, unless reauthorized by the Legislature. The committee will conduct a sunset review of the subsections.
