

History.


The Utah Intergenerational Poverty Mitigation Act (SB37) was passed in the 2012 Legislative Session. The legislation requires DWS to:

- Establish and maintain a system to track intergenerational poverty related data, identifying trends
- Assist government officials in the study and development of plans to help individuals and families break the cycle of poverty



## Early Efforts •

DWS coordinated the defining and tracking of Utah intergenerational poverty trends and publishes those trends annually, the 10<sup>th</sup> report being released earlier this month.





## Early Efforts •

Creation of the Utah Intergenerational Welfare Reform Commission

Members include...

- The Lieutenant Governor
- Executive Director of DWS, DOH, and DHS
- State Superintendent of Public Education
- State Juvenile Court Administrator
- Director of the Division of Multicultural Affairs







With department leadership participating in the commission since 2012, movement to operationalize practices to address intergenerational poverty have been a focus.




In addition, counties were engaged in the effort through the Intergenerational Poverty Plan Implementation Pilot Program.

- · Provided one-time funds to submit a proposal that would
  - Address intergenerational poverty
  - Indicators to be used to measure progress, including baseline data
  - Propose how the county would sustain the plan moving forward




## Early Initial Results •

Sunsetting the Utah Intergenerational Welfare Reform Commission

- Data and progress available in Annual Report for ongoing monitoring
- Commission used to prioritize IGP operational strategies last 10 years
- Agencies and Counties now responsible for maintaining and improving ongoing operationalization efforts to address intergenerational poverty

Sunsetting the commission will require addressing some other impacted state code
