Administrative Rules Review Committee

October 21, 2021

Reauthorization of Administrative Rules Received a <u>presentation</u> from committee staff on the purpose of 2022 General Session draft legislation, "<u>Reauthorization of Administrative Rules</u>," which would

reauthorize all state agency administrative rules.

Regulatory Review Project

Received a <u>presentation</u> from the Department of Commerce on Utah's Innovation and Startups Regulatory Review Project.

Business and Labor

October 4, 2021

Worker COVID-19 Vaccine and Testing

Discussed President Biden's recent announcement that the Occupational Safety and Health Administration would issue an Emergency Temporary Standard to require all employers with 100 or more employees to ensure their workforce is fully vaccinated or require unvaccinated workers to be tested weekly for COVID-19. Presenters included:

- Committee staff;
- Deputy Director, Governor's Office of Economic Opportunity;
- Commissioner, Utah Labor Commission;
- Director, Division of Occupational Safety and Health;
- General Counsel, Office of the Attorney General; and
- Solicitor General, Office of the Attorney General.

October 20, 2021

Earned Wage Access Services Amendments

Discussed 2022 General Session draft legislation, "<u>Earned</u> <u>Wage Access Services Amendments</u>," which would enact provisions related to earned wage access services, including provider registration, provider operational requirements, and provider reporting. The bill would also exempt providers from the provisions of Title 7, Chapter 23, <u>Check Cashing and Deferred Deposit Lending</u> <u>Registration Act</u>.

Licensing Amendments

Discussed 2022 General Session draft legislation, "Licensing Amendments," which would modify occupational and professional licensing related provisions, including by creating the Office of Occupational and Professional Licensure Review to:

- conduct a sunrise review for each application to establish a new regulated occupation;
- review each regulated occupation at least once every 10 years; and
- review and respond to each legislator inquiry regarding an occupational licensing matter.

Heard a presentation and received a handout from the Department of Commerce and the Division of Occupational and Professional Licensing.

Occupational Licensing

Action: Voted to open a committee bill file to modify occupational and professional licensing related provisions and to serve as a cleanup bill for the Division of Occupational and Professional Licensing.

Outdated Reports

Action: Voted to open a committee bill file to remove six outdated statutorily required reports from the Utah Code. The outdated reports are:

- Community Enhancement Program (Inland Port Authority);
- Affordable Insulin Study (Insurance Department);
- Workers' Compensation Advisory Council Report Related to Hospital Costs and Workers' Compensation (Labor Commission);
- Division of Antidiscrimination and Labor Report (Labor Commission); and
- Education and Training Standards for State Plumber and Electrician Apprenticeship Programs (Division of Occupational and Professional Licensing).

Powersport Vehicle Franchise Advisory Board


Action: Approved as a committee bill 2022 General Session draft legislation, "<u>Utah Powersport Vehicle</u> <u>Franchise Advisory Board Amendments</u>," which would extend the board's sunset date by 10 years to 2032, and increase the board's total membership from six to seven by increasing the number of board members representing new powersport vehicle franchisees from three to four, one for each congressional district.

Required Reports

Received the following required reports in accordance with statutory reporting requirements:

- <u>Affordable Insulin Study</u> and <u>Cover Letter</u> (Insurance Department);
- <u>Final Report of Education and Training Standards for</u> <u>State Plumber and Electrician Apprenticeship Programs</u> (Division of Occupational and Professional Licensing);

Child Welfare Legislative Oversight

Panel

October 22, 2021

Child Fatality Review

Received a <u>report</u> from the Department of Human Services regarding the <u>deaths</u> of individuals during fiscal year 2021 who had an open case for child welfare services within the past year. Discussed individual cases in the closed portion of the meeting, and related issues and improvements since last year in the open portion of the meeting.

Guardian Ad Litem

Received a report from the Judiciary's Guardian Ad Litem Oversight Committee on how the committee fulfills its statutory duty to ensure that "the Office of Guardian Ad Litem complies with state and federal law, regulation, policy, and court rules." The Office of Guardian Ad Litem indicated that although caseloads for guardians ad litem are manageable, funding to further reduce caseloads would be helpful.

Criminal Code Evaluation Task Force

September 21, 2021

Criminal Code Recodification

Received presentations from staff on proposed changes to Title 76, Chapter 5, Part 1, Parts 2 and 4, and Part 3.

Considered the proposed revisions in each presentation and discussed the goals and scope of the recodification of the Criminal Code.

Action: Voted to open a committee bill file to renew the task force for an additional two years.

Economic Development and Workforce Services

Alignment of Economic Development Efforts

Received an <u>update</u> on the activities of the Economic Opportunity Commission from the Governor's Office of Economic Opportunity.

Child Care Affordability and Access

Received a <u>presentation</u> from the Office of Child Care on child care initiatives that could utilize COVID-19 relief funds.

Received a <u>presentation</u> from a legislator on proposed policy options to include in the committee bill file on child care.

Draft Legislation: Commission on Housing Affordability Amendments

Discussed 2022 General Session draft legislation, "Commission on Housing Affordability Amendments."

Action: Approved as a committee bill 2022 General Session draft legislation, "Commission on Housing Affordability Amendments."

Film Industry in Utah

Received a <u>presentation</u> from the Motion Picture Association of Utah on the economic impact of Utah's film incentives.

Education

Higher Education Performance Funding

Received a <u>presentation</u> from the Utah System of Higher Education updating its performance funding goals as required by 2021 General Session S.B. 193, "<u>Higher Education</u> <u>Performance Funding</u>."

Action: Voted to open a committee bill file to adopt the Utah System of Higher Education's performance funding goals.

School Curriculum Transparency

Received a <u>presentation</u> from a legislator outlining a proposal for potential legislation to increase transparency in the creation of public school curriculum.

Sunset Review: Hospitality and Tourism Management Career and Technical Education Pilot Program

Received a <u>presentation</u> outlining the following provisions and recommending a two-year extension of each:

- Utah Code Section <u>53E-3-515</u>, which creates the Hospitality and Tourism Management Career and Technical Education Pilot Program; and
- Utah Code Section <u>53F-9-501</u>, which establishes the Hospitality and Tourism Management Education Account.

Action: Voted to open a committee bill file to extend the sunset date for these provisions by two years.

Sunset Review: Juvenile Justice

Received presentations from the <u>State Board of Education</u> and the <u>Department of Human Services</u> recommending the extension of Utah Code Section <u>53G-8-211(5)</u>, which provides that a school district or school may refer a minor to a court or a law enforcement officer or agency for an alleged class C misdemeanor committed on school property, or for allegedly being a habitual truant, under certain circumstances.

Action: Voted to open a committee bill file to extend the sunset date for Utah Code Section 53G-8-211(5) by five years.



Sunset Review: State Instructional Review Commission START HERE

Utah Code Section <u>53E-4-402</u> creates the State Instructional Materials Commission. Without legislative action, this section will be repealed on July 1, 2022.

Received a <u>presentation</u> from the State Board of Education about the commission and a recommendation to extend the sunset.

Action: Voted to open a committee bill file to extend the sunset date for these provisions by five years.

Draft Legislation: Utah K-12 Reading Clinic

Reviewed 2022 General Session draft legislation, "<u>Utah K-12 Reading Clinic</u>," which would codify the name of the K-12 Reading Clinic at the University of Utah.

Action: Approved as a committee bill 2022 General Session draft legislation, "Utah K-12 Reading Clinic."

Government Operations

Department of Government Operations Merger

Received an <u>update</u> from the Department of Government Operations regarding the implementation of 2021 General Session 2nd Substitute S.B. 181, "<u>Department of</u> <u>Government Operations</u>," which resulted in the merging of the Department of Administrative Services, the Department of Technology Services, and the Department of Human Resource Management.

Division of Technology Services Update

Received a <u>presentation</u> from the Division of Technology Services regarding its organizational structure, priorities, and challenges.

Draft Legislation: Department of Government Operations

Reviewed 2022 General Session draft legislation, "<u>Department of Government Operations</u>," which would amend provisions relating to the department.

Action: Approved as a committee bill 2022 General Session draft legislation, "Department of Government Operations."

Draft Legislation: Election Modifications

Action: Approved as a committee bill 2022 General Session draft legislation, "<u>Election Modifications</u>," which would modify or repeal code provisions to reflect current practice in election administration.

Draft Legislation: Election Revisions

Action: Voted to amend and approve as a committee bill 2022 General Session draft legislation, "<u>Election</u> <u>Revisions</u>," which would:

- change the dates of a special election in an oddnumbered year to coincide with the dates of municipal elections;
- modify requirements relating to the publishing and posting of sample ballots;
- modify the crime of destroying election documents or supplies to include altering documents;
- provide for a voter's party affiliation to be changed to unaffiliated if the voter is affiliated with a party that is no longer a registered political party; and
- modify the deadline for determining whether a municipality will conduct an election by ranked choice voting to coincide with the deadline for publishing a notice of election.

Draft Legislation: Elections Schedule Amendments

Action: Approved as a committee bill draft legislation, "Elections Schedule Amendments," which would amend scheduling provisions of the election code.

Draft Legislation: Judicial Performance Evaluation Commission Act Amendments

Discussed 2022 General Session draft legislation, "Judicial Performance Evaluation Commission Amendments," which would provide that the Judicial Performance Evaluation Commission would determine whether a judge meets minimum performance standards, rather than making a recommendation regarding retaining a judge.

Draft Legislation: Legislative Process Committee Sunset Extension

Action: Approved as a committee bill 2022 General Session draft legislation "<u>Legislative Process Committee</u> <u>Sunset Extension</u>," which would extend the sunset of the committee.





Draft Legislation: Local Election Amendments

Discussed 2022 General Session draft legislation, "Local Election Amendments," which would amend provisions relating to cancelling a local election or an uncontested race in a local election.

Action: Voted to amend and approve as a committee bill 2022 General Session draft legislation, "Local Election Amendments."

Draft Legislation: Utah Protection of Public Employees Act Amendments

Received a summary from the Office of the Attorney General of 2022 General Session draft legislation, "<u>Utah</u> <u>Protection of Public Employees Act Amendments</u>," which would specify the parties' burdens of proof in a civil action where a violation of the Utah Protection of Public Employees Act is alleged.

Action: Approved as a committee bill 2022 General Session draft legislation, "Utah Protection of Public Employees Act Amendments."

Draft Legislation: "Voting History Amendments"

Discussed 2022 General Session draft legislation, "<u>Voting</u> <u>History Amendments</u>," which would require an election officer to, when reporting voting history for an election, anonymously include certain information for a voter whose voter registration is classified as private.

Action: Approved as a committee bill 2022 General Session draft legislation, "Voting History Amendments."

State Employee Amendments

Held a discussion regarding the sponsor's intent with 2022 General Session draft legislation, "State Employee Amendments," which would:

- shorten the timeline for processing and reviewing a grievance filed by a state employee;
- require that state employees be paid based on performance;
- transition, through attrition or incentives, any supervising employees who are currently careerservice to at-will; and
- require supervisors of state employees to receive annual management training.

Health and Human Services

Acupuncturist Liability

Considered 2022 General Session draft legislation, "<u>Acupuncturist Liability Amendments</u>," which would add licensed acupuncturists to those health care professionals who have limited immunity under certain circumstances for providing volunteer services, and also would add licensed acupuncturist to the definition of a health care practitioner under the Retired Volunteer Health Care Practitioner Act.

Action: Approved as a committee bill 2022 General Session draft legislation "Acupuncturist Liability Amendments."

Body Art Facilities

Considered 2022 General Session draft legislation, "<u>Sanitation Amendments</u>," which would require the Department of Health to create minimum sanitation rules for facilities where an individual practices or teaches body piercing, branding, permanent cosmetics, scarification, or tattooing.

COVID-19: Monoclonal Antibodies

Received a <u>report</u> from the Department of Health on the allocation and use of monoclonal antibody therapy to treat COVID-19. The department reported on steps being taken to address the scarcity of healthcare personnel needed to administer the therapy. The department reported that the state is not experiencing a shortage of available treatment doses.

Healthcare Worker Protections

Considered 2022 General Session draft legislation, "<u>Health</u> <u>Care Worker Protection Amendments</u>," which would expand the definitions of certain crimes against a healthcare provider or emergency medical service worker to include an employee or contractor of a healthcare facility.

Sunset Review: Anesthesia, Sedation, and Unprofessional Conduct

Discussed the sunset of statute that, among other things, defines responsibilities of the Department of Health to create and maintain a database of deaths and adverse events from the administration of sedation or anesthesia in outpatient settings and nonemergency departments.

Received recommendations from the <u>Division of Occupational</u> and <u>Professional Licensing</u> and the <u>Department of Health</u> that the sunset date be extended for an additional four years.

Action: Voted to allow the provision to sunset.

Sunset Review: Controlled Substances

Discussed the sunset of statutory restrictions related to the prescription of a Schedule II or Schedule III controlled substance that is an opiate.

Received a <u>recommendation</u> from the Division of Occupational and Professional Licensing that the statute be reauthorized until July 1, 2032.



Action: Voted to open a committee bill file to extend the sunset date for restrictions related to the prescription of a Schedule II or Schedule III controlled substance that is an opiate by 10 years.

Sunset Review: Educational Qualifications for Licensure and Reporting

Discussed the sunset of statute allowing for an alternative path to licensure for clinical mental health counselors and requiring that the Division of Occupational and Professional Licensing report how many individuals were licensed under the alternative path.

Received a <u>recommendation</u> from the Division of Occupational and Professional Licensing that the statute be reauthorized until July 1, 2032, and to make changes to the number of required hours of postgraduate supervised training.

Action: Voted to open a committee bill file to extend the sunset date by 10 years for an alternative path to licensure for clinical mental health counselors and the requirement that the Division of Occupational and Professional Licensing report how many individuals were licensed under the alternative path, and to change the number of required hours of postgraduate supervised training from 4,000 to 3,000 hours.

Sunset Review: Insurance Coverage for Opioids -Policies - Reports

Discussed the sunset of statute requiring that a health insurer submit a report to the Insurance Department indicating whether the health insurer has adopted an Opioid Prescribing Policy.

Received a <u>recommendation</u> from the Insurance Department that the requirement be allowed to sunset.

Action: Voted to allow the provision to sunset.

Sunset Review: Microenterprise Home Kitchen Permit Limitations

Discussed the sunset of statute limiting the amount of microenterprise home kitchen permits that may be issued by local health departments.

Received a <u>recommendation</u> from the Department of Health that the statute be reauthorized until July 1, 2024.

Sunset Review: Utah Substance Abuse and Mental Health Advisory Council

Discussed the sunset of statute that creates and defines responsibilities of the Utah Substance Use and Mental Health Advisory Council.

Received a <u>recommendation</u> from the Division of Substance Abuse and Mental Health and the Utah Substance Abuse and Mental Health Advisory Council that the statute be reauthorized for an additional 10 years. Action: Voted to open a committee bill file to extend the sunset date for the Utah Substance Abuse and Mental Health Advisory Council by 10 years.

<u>Judiciary</u>

Election Integrity

Heard a <u>presentation</u> from two legislators on election integrity and a presentation from the <u>Office of the Lieutenant</u> <u>Governor</u> and Weber County on how Utah elections are currently safeguarded.

Judges on Ballots

Heard a <u>presentation</u> from the Weber County Clerk and the Administrative Office of the Courts regarding justice court judges in smaller jurisdictions who cover more than one city and appear multiple times on ballots.

Action: Voted to open a committee bill file to address the issue.

Sex Offender Registry

Heard an update from the Office of the Attorney General and the Department of Corrections on practical and procedural improvements to the sex offender registry resulting from the implementation of recently passed legislation.

Law Enforcement and Criminal Justice

DUI Sentencing

Received a follow-up presentation on possible changes to DUI sentencing that were discussed at the June 16, 2021, committee meeting.

Received comments from the Salt Lake County District Attorney's Office on the need to make charges related to vehicle injuries and deaths more uniform.

Action: Approved as a committee bill 2022 General Session draft legislation, "<u>Driving Offenses</u> <u>Amendments</u>," which would adjust offenses and penalties for injuries or death caused by operating a motor vehicle while under the influence of drugs, alcohol, or any measurable amount of a controlled substance.

Intimate Image Distribution Amendments

Discussed possible changes to the offense of aggravated unlawful distribution of a counterfeit intimate image.

Received comments from the Voices for Utah Children and the Salt Lake County District Attorney's Office about limiting those eligible to be charged with the offense to those 18 years old and older.

Action: Approved as a committee bill 2022 General Session draft legislation "<u>Intimate Image Distribution</u> <u>Amendments</u>," which restricts the offense of aggravated unlawful distribution of a counterfeit intimate image to individuals 18 years old and older.

Law Enforcement and Mental Health

Received a presentation from the Previdence Corporation on law enforcement agencies in Utah and Massachusetts that have been facilitated by its mental health screening program.

Received a <u>presentation</u> from Utah State University providing an update on the implementation of the Resilient Mind for Law Enforcement Program, which provides law enforcement professionals with training intended to increase resilience during and after stressful or traumatic events.

Received comments from a legislator about the need to expand the number of mental health workers in law enforcement agencies.

Action: Voted to open a committee bill file to address first responder mental health.

Peace Officer Use of Force

Received comments from a legislator about options for improving community policing training and practices in the state, as well as the need for statutory changes to the use of force statute in code.

Sex Offender Registry

Studied the possibility of altering area restrictions for those on the Sex and Kidnap Offender Registry by allowing the registrants to enter restricted areas if accompanied by another adult.

Legislative Redistricting

Redistricting

Held public hearings around the state to receive recommendations on how the Legislature should redraw Senate, House, State School Board, and Congressional district boundaries to account for differences in population growth across the state since 2010. Held hearings in Cedar City, St. George, Richfield, Moab, Price, Vernal, Park City, Clearfield, and Salt Lake City. Using tools provided by the committee, citizens have been able to draw, submit, and comment on proposed district boundaries.

On November 1, 2021, the committee will receive and consider the recommendations of the Utah Independent Redistricting Commission.

A special session of the Legislature to enact new boundaries is expected in November 2021.

Flow Rates or Quantity for Plumbing Fixtures

Heard from a legislator regarding 2022 General Session draft legislation, "Flow Rates or Quantity for Plumbing Fixtures," which would amend the flow rates for certain plumbing fixtures.

Instream Flow of Water

Action: Approved as a commission bill 2022 General Session draft legislation, "Instream Water Flow Amendments," which would address change applications for instream water flows.

Utah Lake

Received a presentation from a legislator regarding progress on developing draft legislation that would address the management of Utah Lake.

Water Rights Proof on Small Amounts of Water

Action: Approved as a commission bill 2022 General Session draft legislation, "Water Rights Proofs on Small Amounts of Water," which would modify the requirements for a proof submitted to the State Engineer regarding a small amount of water.

Draft Legislation: Student Tribal Regalia Use Amendments

Discussed 2022 General Session draft legislation, "Student Tribal Regalia Use Amendments," which would permit qualifying students to wear tribal regalia during a high school graduation ceremony.

Action: Approved as a committee bill 2022 General Session draft legislation, "Student Tribal Regalia Use Amendments."

Native American Education Report and Issues

Received a presentation from the State Board of Education regarding Native American education in Utah.

Received reports from San Juan School District and Uintah School District on grants made under the American Indian and Alaska Native Education State Program, as required by Utah Code Section 53F-5-604.

Native American Mascots

Received a presentation from a legislator regarding the use of Native American names, imagery, symbols, and regalia as school mascots. The legislator provided the following handouts:

- Current Depictions of Utah's Native People;
- Utah Tribal Nations; and
- Indian Tribal Lands.

Department of Natural Resources and

Conservation

Heard from a legislator regarding work on draft legislation that would address the Department of Natural Resources, conservation efforts, and the coordination of conservation and outdoor recreation.

State Monuments and Parks

Discussed 2022 General Session draft legislation, "<u>State</u> <u>Monuments Act Amendments</u>," which would address the process for creating state monuments.

State Water Policy

Action: Approved as a committee bill 2022 General Session draft legislation, "<u>State Water Policy</u> <u>Amendments</u>," which would amend the state water policy to include the recharge of aquifers.

Trespassing Code Review

Income Tax Credits Review

Received a <u>presentation</u> and <u>handout</u> from the State Historic Preservation Office on the Historic Preservation tax credit.

Received a <u>presentation</u> from the Governor's Office of Economic Opportunity on the Economic Development tax credit.

Income Tax Rate

Received an <u>economic update</u> from the Office of the Legislative Fiscal Analyst and a <u>presentation</u> from the Taxpayers Association on its proposed income tax rate cut. Also received comments from Voices for Utah Children.

Sunset Review: State Transient Room Tax Act

Received an introduction from committee staff to the <u>State</u> <u>Transient Room Tax Act</u>, which imposes a 0.32% tax on certain tourist accommodations. Per Section <u>63I-1-259</u>, the Act will be repealed January 1, 2023, if the Legislature takes no action.

Autonomous Vehicles

Received a <u>presentation</u> from a legislator on the potential for unaccompanied minors to use an autonomous rideshare vehicle. Discussed activities of private driverless vehicle companies, regulatory challenges, and policy opportunities.

Public Private Partnerships

Special Group Plate

Received a <u>report</u> from the Division of Motor Vehicles that described the special group plate types, year issued, number of current registrations, cost, fees, and contribution requirements.

Discussed how the program is administered and the state license plate design.

State Airplane Fleet and Operations

Received a <u>presentation</u> from the Division of Aeronautics that detailed usage of the state's airplane fleet between 2015 and 2021, and compared the hourly costs for a new eight-passenger state plane to a private charter plane.



Towing Request for Information

Received a <u>presentation</u> from the Utah Highway Patrol (UHP) that summarized results from UHP's request for information from stakeholders. The presentation evaluated the availability of vendors, products, and technology capable of increasing efficiency, effectiveness, and transparency in the dispatching of towing providers and management of <u>towing rotations in</u> <u>Salt Lake County</u>, which experiences high demand for tow truck services.

Heard comments from representatives of the insurance and towing industries.

Action: Voted to recommend that the UHP take action to create a formal request for proposal to include a third-party towing vendor.

Transportation Mode Costs

Received a <u>presentation</u> from the Utah Transit Authority (UTA) that compared the cost per mile for bus rapid transit (BRT) projects in Utah to other transit agencies. The presentation also detailed costs for Point of the Mountain BRT and compared rates to other UTA BRTs and a hypothetical light rail.

Heard comments from Stadler Rail, a private train manufacturer.
