


DEAF AND BLIND STUDENTS SERVED STATEWIDE






USDB SERVICE ENROLLMENT BY LOCATIONS








SCHOOLS FOR THE DEAF AND THE BLIND


Historical Funding Level and Purpose of the Program:	Results/Benefits of the Program;	
 Formula in Utah Code <u>53E-8-302</u> Annual salary adjustments for USDB educators. USDB educator increases lag behind other district educators by two years. Historical Funding Levels SFY 18 = \$490,920 (2.3%) SFY 19 = \$765,750 (1.6%) SFY 20 = \$2,030,800 (10%) SFY 21 = \$2,148,300 (7.85%) SFY 22 = \$1,538,500 (6.79%) 	 This request provides funding required by <u>53E-8-302</u> and the USDB educator employment agreement. Teacher step increases are derived by calculating a weighted statewide annual salary adjustment (WASA). Request amount: \$812,600 (4.13%)

USIMAC (On-Going)

 USIMAC is the designated agency for production of materials required by blind students throughout Utah. Materials are provided at no cost to the LEAs, and all but 3 have indicated they will use USIMAC services this year. Based on actual needs, USIMAC must hire and train 6.5 additional FTEs to meet the required demand. USIMAC requires additional funding retain staff with specialized skills. USIMAC also requires additional contract labor.
