BLUEPRINT PURPOSE:

Provide Utah policymakers and stakeholders guidance on how to leverage opioid settlement funds

BLUEPRINT GOALS:

Maximize settlement spending benefits to alleviate the harms caused by opioids in Utah The Opioid Settlement Advisory Committee (OSAC) is a part of the Utah Opioid Task Force (UTOTF).

The OSAC is composed of voluntary subject matter experts from a broad range of relevant fields and has the singular task of providing guidance on utilizing opioid settlement funds expected from various opioid litigations.



BACKGROUND

- Drug poisoning deaths are a preventable public health problem
- Utah is particularly affected by prescription opioids
- There were over 100,000
 overdose deaths in the U.S. in 2021—the most ever in a 12-month period
- Utah has made progress but there is still much work to be done

Leading cause of injury death in Utah

8 out of every 10

Utah overdose deaths each week are from opioids


41% of unintentional and undetermined drug poisoning deaths in Utah are due to prescription opioids 1 overdose death every 5 minutes in the U.S.


Utah overdose deaths up nearly **20**% in 2021

Utah has gone from **4th to 38th** in U.S. overdose death rate



12-MONTH PROVISIONAL NUMBER OF DRUG OVERDOSE DEATHS CDC DATA June 2020-2021








IMMEDIATE STRATEGIC PRIORITIES FOR EARLY PHASE FUND MANAGEMENT

- 1. Establish **core principles** in legislation to provide a framework that ensures funds are spent in ways that save and improve lives.
- 2. Determine the **oversight entity** to manage funding, establish administrative cost limits.
- 3. Establish an **advisory group**.
- 4. Establish a **structured process for allocation of funds** based on the core principles.
- 5. Establish **parameters around project priorities** and selection processes based on community assessments and resources.
- 6. Establish **reporting and outcome measurements** required for transparency and compliance with settlements.



CORE PRINCIPLES

1. Spend money to save lives



3. Invest in youth prevention

4. Focus on equity geographic, socioeconomic. racial

5. Develop fair and transparent process for spending decisions



- 1. Establish a dedicated fund
- 2. Supplement existing funding
- 3. Don't spend all the money at once
- 4. Report to the public on where the money is going.

- 1. Direct funds to evidence-based programs
- 2. Remove policies creating barriers for programs that work
- 3. Build data collection capacity
- 4. Fund data-driven strategies

- 1. Youth prevention programs have a very favorable return on investment—\$18 for every \$1 spent by one estimate.
- 2. Direct funds to evidence-based interventions

- 1. Invest in communities affected by discriminatory policies
- 2. Support diversion from arrest and incarceration
- 3. Fund anti-stigma campaigns
- 4. Involve community members in solutions


- 1. Determine areas of need
- 2. Pursue wide input from groups affected by the crisis to develop plan
- 3. Ensure representation that reflects affected communities when allocating funds







RECOMMENDED STRATEGIES: SUBJECT MATTER EXPERTS (SMEs)




Evidence-based and data-driven strategies should be prioritized.




TOTAL PRIORITY INVESTMENT RECOMMENDATIONS: ALL SMEs





RECOMMENDED STRATEGIES: SMEs WITH LIVED EXPERIENCE






PRIORITIES AND IMPACTS FROM THE PUBLIC SURVEY

ADDITIONAL KEY CONSIDERATIONS/NEEDS IDENTIFIED BY SMES

- Comprehensively expand a more equitable workforce
- · Prioritize housing, legal supports, education, and job training
- Include those with lived experience, their families, and community members
- Include vital recovery supports
- Ensure overdose prevention for groups and areas that are at high risk for overdose
- Address impacts and trauma on families and children
- Fund/support costs of physical structures for service delivery
- **Vet/Monitor** funding of for-profit entities
- Measure and report results and outcomes
